1 AN ACT Relating to initiative and referendum petitions; amending
2 RCW 29.79.490; adding a new section to chapter 29.79 RCW; creating a
3 new section; and prescribing penalties.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The legislature finds that permitting
6 individuals who gather signatures on initiative or referendum petitions
7 to be paid based on the number of signatures they gather or to be paid
8 based upon the successfulness of the signature gathering campaign
9 invites the introduction of fraud into a vital aspect of the election
10 process.

11 NEW SECTION. **Sec. 2.** A new section is added to chapter 29.79 RCW
12 to read as follows:

1 It is unlawful to offer, provide, receive, or agree to receive any
2 consideration for soliciting or procuring signatures upon an initiative
3 or referendum petition if any part of the consideration:

4 (1) Is provided or is to be provided based upon the number of
5 signatures solicited or procured; or

6 (2) Is provided or is to be provided contingent upon the initiative
7 or referendum campaign's securing enough valid signatures to place the
8 initiative or referendum on the ballot.

9 A person who violates this section is guilty of a gross misdemeanor
10 which is punishable to the same extent as a gross misdemeanor that is
11 punishable under RCW 9A.20.021.

12 **Sec. 3.** RCW 29.79.490 and 1975-'76 2nd ex.s. c 112 s 2 are each
13 amended to read as follows:

14 Every person shall be guilty of a gross misdemeanor who:

15 (1) For any consideration or gratuity or promise thereof, signs or
16 declines to sign any initiative or referendum petition; or

17 ~~(2) ((Advertises in any manner that for or without consideration,~~
18 ~~he will solicit or procure signatures upon or influence or attempt to~~
19 ~~influence persons to sign or not to sign, to vote or not to vote upon~~
20 ~~an initiative or referendum petition, or to vote for or against any~~
21 ~~initiative or referendum; or~~

22 ~~(3) For any consideration or gratuity or promise thereof solicits~~
23 ~~or procures signatures upon an initiative or referendum petition; or~~

24 ~~(4)) Gives or offers any consideration or gratuity to any person~~
25 ~~to induce him to sign or not to sign((, or to solicit or procure~~
26 ~~signatures upon an initiative or referendum petition,)) or to vote for~~
27 ~~or against any initiative or referendum measure; or~~

28 ~~((+5)) (3) Interferes with or attempts to interfere with the right~~
29 ~~of any voter to sign or not to sign an initiative or referendum~~

1 petition or with the right to vote for or against an initiative or
2 referendum measure by threats, intimidation, or any other corrupt means
3 or practice((; or

4 ~~(6) Receives, handles, distributes, pays out, or gives away,~~
5 ~~directly or indirectly, money or any other thing of value contributed~~
6 ~~by or received from any person, firm, association, or corporation whose~~
7 ~~residence or principal office is, or the majority of whose members or~~
8 ~~stockholders have their residence outside, the state of Washington, for~~
9 ~~any service rendered for the purpose of aiding in procuring signatures~~
10 ~~upon any initiative or referendum petition or for the purpose of aiding~~
11 ~~in the adoption or rejection of any initiative or referendum measure:~~
12 ~~PROVIDED, That this subsection shall not apply to or prohibit any~~
13 ~~activity which is properly reported in accordance with the applicable~~
14 ~~provisions of chapter 42.17 RCW)).~~

15 Such a gross misdemeanor is punishable to the same extent as a
16 gross misdemeanor that is punishable under RCW 9A.20.021.
