5 On page 1, after line 8, insert the following:

6 "Sec. 1. RCW 46.01.230 and 1992 c 216 s 2 are each amended to read  
7 as follows:

8 (1) The department of licensing is authorized to accept checks and  
9 money orders for payment of drivers' licenses, certificates of  
10 ownership and registration, motor vehicle excise taxes, gross weight  
11 fees, and other fees and taxes collected by the department, in  
12 accordance with regulations adopted by the director. The director's  
13 regulations shall duly provide for the public's convenience consistent  
14 with sound business practice and shall encourage the annual renewal of  
15 vehicle registrations by mail to the department, authorizing checks and  
16 money orders for payment. Such regulations shall contain provisions  
17 for cancellation of any registrations, licenses, or permits paid for by  
18 checks or money orders which are not duly paid and for the necessary  
19 accounting procedures in such cases: PROVIDED, That any bona fide  
20 purchaser for value of a vehicle shall not be liable or responsible  
21 for any prior uncollected taxes and fees paid, pursuant to this  
22 section, by a check which has subsequently been dishonored: AND  
23 PROVIDED FURTHER, That no transfer of ownership of a vehicle may be  
24 denied to a bona fide purchaser for value of a vehicle if there are  
25 outstanding uncollected fees or taxes for which a predecessor paid,  
26 pursuant to this section, by check which has subsequently been  
27 dishonored nor shall the new owner be required to pay any fee for  
28 replacement vehicle license number plates that may be required pursuant  
29 to RCW 46.16.270 as now or hereafter amended.

30 (2) It is a traffic infraction to fail to surrender within ten days  
31 to the department or any authorized agent of the department any  
32 certificate, license, or permit after being notified (~~by certified~~  
33 ~~mail~~) that such certificate, license, or permit has been canceled  
34 pursuant to this section. Notice of cancellation may be accomplished  
35 by sending a notice by first class mail using the last known address in  
36 department records for the holder of the certificate, license, or

1 permit, and recording the transmittal on an affidavit of first class  
2 mail.

3 (3) Whenever registrations, licenses, or permits have been paid for  
4 by checks that have been dishonored by nonacceptance or nonpayment, a  
5 reasonable handling fee may be assessed for each such instrument.  
6 Notwithstanding provisions of any other laws, county auditors, agents,  
7 and subagents, appointed or approved by the director pursuant to RCW  
8 46.01.140, may collect restitution, and where they have collected  
9 restitution may retain the reasonable handling fee. The amount of the  
10 reasonable handling fee may be set by rule by the director.

11 (4) In those counties where the county auditor has been appointed  
12 an agent of the director under RCW 46.01.140, the auditor shall  
13 continue to process mail-in registration renewals until directed  
14 otherwise by legislative authority."

20 On page 2, after line 24, insert the following:

21 "**Sec. 4.** RCW 46.12.160 and 1975 c 25 s 12 are each amended to read  
22 as follows:

23 If the ~~((director))~~ department determines at any time that an  
24 applicant for certificate of ownership or for a certificate of license  
25 registration for a vehicle is not entitled thereto, ~~((he))~~ the  
26 department may refuse to issue such certificate or to license the  
27 vehicle and ~~((he))~~ may, for like reason, after notice, and in the  
28 exercise of discretion, cancel license registration already acquired or  
29 any outstanding certificate of ownership. ~~((The notice shall be served~~  
30 ~~personally or sent by certified mail return receipt requested.))~~ Notice  
31 of cancellation may be accomplished by sending a notice by first class  
32 mail using the last known address in department records for the  
33 registered or legal vehicle owner or owners, and recording the  
34 transmittal on an affidavit of first class mail. It shall then be  
35 unlawful for any person to remove, drive, or operate the vehicle until

1 a proper certificate of ownership or license registration has been  
2 issued, and any person removing, driving, or operating such vehicle  
3 after the refusal of the ((director)) department to issue certificates  
4 or the revocation thereof shall be guilty of a gross misdemeanor."
