5 On page 1, after line 6, insert the following:

6 "Sec. 2. RCW 46.68.090 and 1991 c 342 s 56 are each amended to
7 read as follows:

8 (1) All moneys that have accrued or may accrue to the motor vehicle
9 fund from the motor vehicle fuel tax and special fuel tax shall be
10 first expended for the following purposes:

11 (a) For payment of refunds of motor vehicle fuel tax and special
12 fuel tax that has been paid and is refundable as provided by law;

13 (b) For payment of amounts to be expended pursuant to
14 appropriations for the administrative expenses of the offices of state
15 treasurer, state auditor, and the department of licensing of the state
16 of Washington in the administration of the motor vehicle fuel tax and
17 the special fuel tax, which sums shall be distributed monthly;

18 (c) From April 1, 1992, through March 31, 1996, for distribution to
19 the transfer relief account, hereby created in the motor vehicle fund,
20 an amount not to exceed three hundred twenty-five one-thousandths of
21 one percent;

22 (d) For distribution to the rural arterial trust account in the
23 motor vehicle fund, an amount as provided in RCW 82.36.025(2) and
24 46.68.095(3);

25 (e) For distribution to the urban arterial trust account in the
26 motor vehicle fund, an amount as provided in RCW 82.36.025(3);

27 (f) For distribution to the transportation improvement account in
28 the motor vehicle fund, an amount as provided in RCW 46.68.095(1);

29 (g) For distribution to the special category C account, hereby
30 created in the motor vehicle fund, an amount as provided in RCW
31 46.68.095(2);

32 (h) For distribution to the county arterial preservation account,
33 hereby created in the motor vehicle fund, an amount as provided in RCW
34 46.68.095(4);

1 (i) For distribution to the motor vehicle fund to be allocated to
2 cities and towns as provided in RCW 46.68.110, an amount as provided in
3 RCW 46.68.095(5);

4 (j) For distribution to the motor vehicle fund to be allocated to
5 counties as provided in RCW 46.68.120, an amount as provided in RCW
6 46.68.095(6);

7 (k) For expenditure for highway purposes of the state as defined in
8 RCW 46.68.130, an amount as provided in RCW 82.36.025(4) and
9 46.68.095(7);

10 (l) From May 1, 1994, through June 30, 1995, for distribution to
11 the gasohol exemption holding account, hereby created in the motor
12 vehicle fund, an amount equal to four and sixty-five one hundredths of
13 one percent to be used only for highway construction.

14 (2) The amount accruing to the motor vehicle fund by virtue of the
15 motor vehicle fuel tax and the special fuel tax and remaining after
16 payments, distributions, and expenditures as provided in this section
17 shall, for the purposes of this chapter, be referred to as the "net tax
18 amount." "
