1 AN ACT Relating to the beef commission; and amending RCW 16.67.040
2 and 16.67.050.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 16.67.040 and 1991 c 9 s 1 are each amended to read as
5 follows:

6 There is hereby created a Washington state beef commission to be
7 thus known and designated. The commission shall be composed of three
8 beef producers, (~~two~~) three dairy (beef) producers, three feeders,
9 one livestock salesyard operator, and one meat packer. In addition
10 there will be one ex officio member without the right to vote from the
11 department of agriculture to be designated by the director thereof.

12 A majority of voting members shall constitute a quorum for the
13 transaction of any business.

14 All appointed members as stated in RCW 16.67.060 shall be citizens
15 and residents of this state, over the age of twenty-five years, each of
16 whom is and has been actually engaged in that phase of the cattle
17 industry he or she represents for a period of five years, and has
18 during that period derived a substantial portion of his or her income
19 (~~therefrom~~) from cattle, or have a substantial investment in cattle

1 as an owner, lessee, partner, or a stockholder owning at least ten
2 percent of the voting stock in a corporation engaged in the production
3 of cattle or dressed beef, or a manager or executive officer of such
4 corporation. Producer members of the commission shall not be directly
5 engaged in the business of being a meat packer, or as a feeder, feeding
6 cattle other than their own. Said qualifications must continue
7 throughout each member's term of office.

8 **Sec. 2.** RCW 16.67.050 and 1991 c 9 s 2 are each amended to read as
9 follows:

10 The appointive positions on the commission shall be designated as
11 follows: The three beef producers shall be designated positions one,
12 two and three; one dairy (beef) producer shall be designated position
13 four (~~and~~), ~~one~~ designated position ten, and one designated
14 position eleven; the three feeders shall be designated positions five,
15 six and seven; the livestock salesyard operator shall be designated
16 position eight; the meat packer shall be designated position nine.

17 The regular term of office shall be three years from the date of
18 appointment and until their successors are appointed. However, the
19 first term of office for position eleven shall terminate July 1, 1996,
20 the first term for position ten shall terminate July 1, 1994, and the
21 first terms of the members whose terms began on July 1, 1969 shall be
22 as follows: Positions one, four and seven shall terminate July 1,
23 1970; positions two, five and eight shall terminate July 1, 1971;
24 positions three, six and nine shall terminate July 1, 1972.
