
HOUSE BILL 1636

State of Washington 63rd Legislature 2013 Regular Session

1 AN ACT Relating to ensuring chapter 19.68 RCW is interpreted in a
2 manner consistent with the federal antikickback statute; adding new
3 sections to chapter 19.68 RCW; creating a new section; and declaring an
4 emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

6 NEW SECTION. **Sec. 1.** (1) The legislature recognizes the
7 complexity of the health care delivery system and the need to provide
8 a clear and consistent regulatory framework to enable health care
9 providers to manage their operations in an efficient and effective
10 manner. The legislature also recognizes that the donation of
11 electronic health records systems reduces health care costs, promotes
12 patient safety, and improves the quality of health care.

13 (2) To further the important national policy of promoting the
14 widespread adoption of electronic health records systems, the federal
15 antikickback statute and the rules adopted to implement the statute
16 contain a safe harbor that allows the donation of electronic health
17 records systems. The federal statute and rules also contain additional
18 safe harbors to preserve a variety of other activities which, in many

1 cases, improve access to health care. For health care entities other
2 than clinical laboratories, the legality of all of these arrangements
3 is currently in question.

4 (3) The legislature is adding language to chapter 19.68 RCW to
5 ensure that, except with respect to arrangements involving an entity
6 which principally operates as a clinical laboratory, it is interpreted
7 in a manner consistent with the federal antikickback statute.

8 NEW SECTION. **Sec. 2.** (1) Nothing in this chapter may be construed
9 to limit or prohibit the donation of electronic health record
10 technology or other activity by any entity, including a hospital
11 licensed under chapter 70.41 RCW that operates a clinical laboratory,
12 when the donation or other activity is allowed by or otherwise does not
13 violate, 42 U.S.C. Sec. 1320a-7b(b) or the federal rules adopted to
14 implement 42 U.S.C. Sec. 1320a-7b(b).

15 (2) This section does not apply to any entity which principally
16 operates as a clinical laboratory licensed or certified under section
17 353 of the public health service act, 42 U.S.C. Sec. 263a, or other
18 applicable Washington state law.

19 NEW SECTION. **Sec. 3.** The definitions in this section apply
20 throughout this chapter unless the context clearly requires otherwise.

21 "Electronic health record technology" means items and services, in
22 the form of software or information technology and training services,
23 necessary and used predominantly to create, maintain, transmit, or
24 receive electronic health records.

25 NEW SECTION. **Sec. 4.** Sections 2 and 3 of this act are each added
26 to chapter 19.68 RCW.

27 NEW SECTION. **Sec. 5.** This act is necessary for the immediate
28 preservation of the public peace, health, or safety, or support of the
29 state government and its existing public institutions, and takes effect
30 immediately.
