(1) A person having the right to designate the recipient of property transferable 17 18 upon the occurrence of a future event may revocably nominate a 19 custodian to receive the property for a minor beneficiary upon the occurrence of the event by naming the custodian followed in substance 20 by the words: "... as custodian for (name of minor) under 21 the Washington uniform transfers to minors act." 19	"NEW SECTION. Sec. 10. SINGLE CUSTODIANSHIP. A transfer may be
20	made only for one minor, and only one person may be the custodian. All
21	custodial property held under this chapter by the same custodian for
22	the benefit of the same minor constitutes a single custodianship."
23	"NEW SECTION. Sec. 11. VALIDITY AND EFFECT OF TRANSFER. (1) The
24	validity of a transfer made in a manner prescribed in this chapter is
25	not affected by:
26	(a) Failure of the transferor to comply with section 9(3) of this

- 1 (2) Except for one who is a transferor under section 4 of this act,
- 2 a custodian has a noncumulative election during each calendar year to
- 3 charge reasonable compensation for services performed during that year.

- 6 (4) Notwithstanding section 19 of this act, a custodian not
- 7 compensated for services is not liable for losses to the custodial

- 3 (c) A tort committed during the custodianship, may be asserted

- RENUNCIATION, RESIGNATION, DEATH, OR 4 "NEW SECTION. Sec. 18. REMOVAL OF CUSTODIAN--DESIGNATION OF SUCCESSOR CUSTODIAN. (1) A person 5 nominated under section 3 of this act or designated under section 9 of 6 this act as custodian may decline to serve. If the event giving rise 7 8 to a transfer has not occurred and no substitute custodian able, 9 willing, and eligible to serve was nominated under section 3 of this act, the person who made the nomination may nominate a substitute 10 custodian under section 3 of this act; otherwise the transferor or the 11 12 transferor's legal representative shall designate a substitute 13 custodian at the time of the transfer, in either case from among the persons eligible to serve as custodian for that kind of property under 14 section 9(1) of this act. The custodian so designated has the rights 15 16 of a successor custodian.
- 17 (2) A custodian at any time may designate a trust company or an 18 adult other than a transferor under section 4 of this act as successor 19 custodian by executing and dating an instrument of designation. If the instrument of designation does not contain or is not accompanied by the 20 resignation of the custodian, the designation of the successor does not 21 take effect until the custodian resigns, dies, becomes incapacitated, 22 23 or is removed, and custodial property is transferred to the successor custodian. 24
- (3) A custodian may resign at any time by delivering written notice to the minor, if the minor has attained the age of fourteen years, and to the successor custodian, and by delivering the custodial property to the successor custodian.

- (4) If a custodian is ineligible, dies, or becomes incapacitated 1 2 and no successor custodian has been designated as provided in this chapter, and the minor has attained the age of fourteen years, the 3 4 minor may designate as successor custodian, in the manner prescribed in subsection (2) of this section, an adult member of the minor's family, 5 6 a guardian of the minor, or a trust company. If the minor has not attained the age of fourteen years or fails to act within sixty days 7 after the ineligibility, death, or incapacity, the guardian of the 8 9 minor becomes successor custodian. If the minor has no guardian or the 10 guardian declines to act, the transferor, the legal representative of the transferor or of the custodian, an adult member of the minor's 11 12 family, or any other interested person may petition the court to 13 designate a successor custodian.
- (5) A custodian who declines to serve under subsection (1) of this section or resigns under subsection (3) of this section, or the legal representative of a deceased or incapacitated custodian, as soon as practicable, shall put the custodial property and records in the possession and control of the successor custodian. The successor custodian by action may enforce the obligation to deliver custodial property and records and becomes responsible for each item as received.
