- 7 "NEW SECTION. Sec. 1. Evaluation of programs is essential in
- 8 determining their effectiveness and cost benefit and in obtaining data
- 9 for improving services. The department of social and health services
- 10 shall conduct an evaluation of the family reconciliation services
- 11 program. The study shall include the following information:
- 12 (1) A description of services offered in phase I and phase II;
- 13 (2) The number and characteristics of youth and families served in
- 14 family reconciliation services phase I and phase II and the outcome of
- 15 services provided to youth and families;
- 16 (3) A description of outreach services including program
- 17 information provided to referring agencies and the general public;
- 18 (4) The number and type of referrals to family reconciliation
- 19 services from law enforcement, juvenile courts, schools, and community
- 20 agencies and their perception of its effectiveness;
- 21 (5) Follow-up contact with a random sample of youth and families
- 22 receiving family reconciliation services assistance and their
- 23 perception of the effectiveness of these services;
- 24 (6) The number of youth referred again after services were
- 25 terminated and outcome of services provided;
- 26 (7) The number of youth and families who requested specific
- 27 services but who did not receive services because they were not

- 1 available, including a list of the services requested but not
- 2 available; and
- 3 (8) Recommendations for improving services to at-risk youth and
- 4 families."
- 5 "NEW SECTION. Sec. 2. The demand for family reconciliation
- 6 services continues to increase. The number of families served by the
- 7 family reconciliation services program has nearly doubled in the past
- 8 ten years while the number of staff providing these services has
- 9 decreased. The department of social and health services shall expand
- 10 family reconciliation services to serve an additional one thousand
- 11 families per year."
- 12 "NEW SECTION. Sec. 3. The behavioral sciences institute
- 13 homebuilders intensive in-home counseling program has been highly
- 14 successful in serving at-risk youth and families. This program shall
- 15 expand to serve an additional one hundred twenty-six youth and families
- 16 while preserving program integrity and quality."
- 17 "NEW SECTION. Sec. 4. There is a lack of knowledge of existing
- 18 laws and services on the part of those agencies and organizations
- 19 serving at-risk youth and on the part of the general public. The
- 20 office of the administrator for the courts is requested to develop a
- 21 curriculum on at-risk youth for superior court judges and court
- 22 personnel to be presented at a regularly scheduled educational session.
- 23 The department of social and health services is directed to produce a
- 24 videotape on at-risk youth laws and services for use by law
- 25 enforcement, family reconciliation services staff, prosecuting and
- 26 defense attorneys, other agencies and organizations dealing with at-
- 27 risk youth, and the general public. The department shall consult with

- 1 other agencies and organizations providing services to at-risk youth in
- 2 the production of the videotape."
- 3 "NEW SECTION. Sec. 5. A new section is added to chapter 74.13 RCW
- 4 to read as follows:
- 5 The department of social and health services shall implement a
- 6 therapeutic family home program for up to fifteen youth in the custody
- 7 of the department under chapter 13.34 RCW. The program shall develop
- 8 and maintain a mutually reinforcing relationship between the youth and
- 9 the therapeutic staff associated with the program."
- 10 "Sec. 6. RCW 74.13.034 and 1981 c 298 s 17 are each amended to
- 11 read as follows:
- 12 (1) A child taken into custody and taken to a crisis residential
- 13 center established pursuant to RCW 74.13.032(2) may, if the center is
- 14 unable to provide appropriate treatment, supervision, and structure to
- 15 the child, be taken at department expense to another crisis residential
- 16 center or the nearest regional crisis residential center. Placement in
- 17 both centers shall not exceed seventy-two hours from the point of
- 18 intake as provided in RCW 13.32A.130.
- 19 (2) A child taken into custody and taken to a crisis residential
- 20 center established by this chapter may be placed physically by the
- 21 department or the department's designee and, at departmental expense
- 22 and approval, in a secure juvenile detention facility operated by the
- 23 county in which the center is located for a maximum of forty-eight
- 24 hours, including Saturdays, Sundays, and holidays, if ((the person in
- 25 charge of the crisis residential center finds that the child is
- 26 seriously assaultive or seriously destructive towards others and the
- 27 center is unable to provide appropriate supervision and structure. Any
- 28 child who takes unauthorized leave from the center, if)) the child has

- 1 taken unauthorized leave from the center in violation of a court order
- 2 and the person in charge of the center determines that the center
- 3 cannot provide supervision and structure adequate to ensure that the
- 4 child will not again take unauthorized leave((, may be taken to a
- 5 secure juvenile detention facility subject to the provisions of this
- 6 section: PROVIDED, That)). Juveniles placed in such a facility
- 7 pursuant to this section may not, to the extent possible, come in
- 8 contact with alleged or convicted juvenile or adult offenders.
- 9 (3) Any child placed in secure detention pursuant to this section
- 10 shall, during the period of confinement, be provided with appropriate
- 11 treatment by the department or the department's designee, which shall
- 12 include the services defined in RCW 74.13.033(2). If the child placed
- 13 in secure detention is not returned home or if an alternative living
- 14 arrangement agreeable to the parent and the child is not made within
- 15 twenty-four hours after the child's admission, the child shall be taken

- 11 (1) The department shall establish, by contracts with private
- 12 vendors, not less than eight regional crisis residential centers, which
- 13 shall be structured group care facilities licensed under rules adopted
- 14 by the department. ((Each regional center shall have an average of at
- 15 least four adult staff members and in no event less than three adult
- 16 staff members to every eight children.)) The staff shall be trained so
- 17 that they may effectively counsel juveniles admitted to the centers,
- 18 provide treatment, supervision, and structure to the juveniles, and
- 19 carry out the responsibilities outlined in RCW 13.32A.090.
- 20 (2) The department shall, in addition to the regional facilities

- 8 be transmitted to the department and which shall contain information

- 27 "NEW SECTION. Sec. 10. The legislature finds that the use of
- 28 alcohol and illicit drugs continues to be a primary crippler of our

- 1 youth. This translates into incredible costs to individuals, families,
- 2 and society in terms of traffic fatalities, suicides, criminal activity
- 3 including homicides, sexual promiscuity, familial incorrigibility, and
- 4 conduct disorders, and educational fallout. Among children of all
- 5 socioeconomic groups lower expectations for the future, low motivation
- 6 and self-esteem, alienation, and depression are associated with alcohol
- 7 and drug abuse.
- 8 Studies reveal that deaths from alcohol and other drug-related
- 9 injuries rise sharply through adolescence, peaking in the early
- 10 twenties. But second peak occurs in later life, where it accounts for
- 11 three times as many deaths from chronic diseases. A young victim's
- 12 life expectancy is likely to be reduced by an average of twenty-six
- 13 years.
- 14 Yet the cost of treating alcohol and drug addicts can be recouped
- 15 in the first three years of abstinence in health care savings alone.
- 16 Public money spent on treatment saves not only the life of the chemical
- 17 abuser, it makes us safer as individuals, and in the long-run costs
- 18 less.
- 19 The legislature further finds that many children who abuse alcohol
- 20 and other drugs may not require involuntary treatment, but still are
- 21 not adequately served. These children remain at risk for future
- 22 chemical dependency, and may become mentally ill or a juvenile offender
- 23 or need out-of-home placement. Children placed at risk because of
- 24 chemical abuse may be better served by the creation of a comprehensive
- 25 integrated system for children in crisis.
- The legislature declares that an emphasis on the treatment of youth
- 27 will pay the largest dividend in terms of preventable costs to
- 28 individuals themselves, their families, and to society. The provision
- 29 of augmented involuntary alcohol treatment services to youths, as well

- 1 as involuntary treatment for youths addicted by other drugs, is in the
- 2 interest of the public health and safety."

- 5 For the purposes of this chapter the following words and phrases

- 8 (10) "Drug addiction" means a disease characterized by a dependency
- 9 on psychoactive chemicals, loss of control over the amount and
- 10 circumstances of use, symptoms of tolerance, physiological or
- 11 psychological withdrawal, or both, if use is reduced or discontinued,
- 12 and impairment of health or disruption of social or economic
- 13 functioning.
- 14 (11) "Emergency service patrol" means a patrol established under
- 15 RCW 70.96A.170.
- 16 (12) "Gravely disabled by alcohol or other drugs" means that a
- 17 person, as a result of the use of alcohol or other drugs: (a) Is in
- 18 danger of serious physical harm resulting from a failure to provide for
- 19 his or her essential human needs of health or safety; or (b) manifests
- 20 severe deterioration in routine functioning evidenced by a repeated and
- 21 escalating loss of cognition or volitional control over his or her
- 22 actions and is not receiving care as essential for his or her health or
- 23 safety.
- 24 (13) "Incapacitated by alcohol or other psychoactive chemicals"
- 25 means that a person, as a result of the use of alcohol or other
- 26 psychoactive chemicals, has his or her judgment so impaired that he or
- 27 she is incapable of realizing and making a rational decision with
- 28 respect to his or her need for treatment and constitutes a danger to
- 29 himself or herself, to any other person, or to property.

- 1 (14) "Incompetent person" means a person who has been adjudged
- 2 incompetent by the superior court.
- 3 (15) "Intoxicated person" means a person whose mental or physical
- 4 functioning is substantially impaired as a result of the use of alcohol
- 5 or other psychoactive chemicals.
- 6 (16) "Licensed physician" means a person licensed to practice
- 7 medicine or osteopathy in the state of Washington.
- 8 (17) "Minor" means a person less than eighteen years of age.
- 9 (18) "Peace officer" means a law enforcement official of a public
- 10 agency or governmental unit, and includes persons specifically given
- 11 peace officer powers by any state law, local ordinance, or judicial

- (((18))) (19) "Person" means an individual, including a minor.
- 14 (20) "Secretary" means the secretary of the department of social

- Any person fourteen years of age or older may give consent for 1 2 himself or herself to the furnishing of counseling, care, treatment, or 3 rehabilitation by a treatment program or by any person. Consent of the 4 parent, parents, or legal guardian of a person less than eighteen years 5 of age is not necessary to authorize the care, except that the person shall not become a resident of the treatment program without such 6 permission except as provided in RCW 70.96A.120 or 70.96A.140. 7 The 8 parent, parents, or legal guardian of a person less than eighteen years 9 of age are not liable for payment of care for such persons pursuant to this chapter, unless they have joined in the consent to the counseling, 10 care, treatment, or rehabilitation." 11

- (1) When a designated chemical dependency specialist (()) receives 14 information alleging that a person is incapacitated as a result of 15 16 alcoholism, or in the case of a minor incapacitated by alcoholism and/or other drug addiction, the designated chemical dependency 17 18 specialist, after investigation and evaluation of the specific facts 19 alleged and of the reliability and credibility of the information, may file a petition for commitment of such person with the superior court 20 Ιf 21 district court. the designated chemical or dependency specialist((-)) finds that the initial needs of such person would be 22 23 better served by placement within the mental health system, the person 24 shall be referred to an evaluation and treatment facility as defined in RCW 71.05.020 or 71.34.020. If placement in an alcohol treatment 25 26 program is available and deemed appropriate, the petition shall allege 27 The person is an alcoholic who is incapacitated by alcohol, or 28 in the case of a minor incapacitated by alcoholism and/or other drug addiction, or that the person has twice before in the preceding twelve 29

months been admitted for detoxification or treatment for alcoholism 1 2 pursuant to RCW 70.96A.110, or in the case of a minor, detoxification or treatment for alcohol or drug addiction, and is in need of a more 3 4 sustained treatment program, or that the person is an alcoholic, or in the case of a minor, an alcoholic or other drug addict, who has 5 6 threatened, attempted, or inflicted physical harm on another and is likely to inflict physical harm on another unless committed. A refusal 7 to undergo treatment, by itself, does not constitute evidence of lack 8 9 of judgment as to the need for treatment. The petition shall be 10 accompanied by a certificate of a licensed physician who has examined the person within five days before submission of the petition, unless 11 12 the person whose commitment is sought has refused to submit to a medical examination, in which case the fact of refusal shall be alleged 13 14 in the petition. The certificate shall set forth the licensed physician's findings in support of the allegations of the petition. A 15 physician employed by the petitioning program or the department is 16 17 eligible to be the certifying physician.

18 (2) Upon filing the petition, the court shall fix a date for a 19 hearing no less than two and no more than seven days after the date the 20 petition was filed unless the person petitioned against is presently being detained in a program, pursuant to RCW 70.96A.120 ((or)), 21 71.05.210, or 71.34.050, as now or hereafter amended, in which case the 22 hearing shall be held within seventy-two hours of the filing of the 23 PROVIDED, HOWEVER, That the above specified seventy-two 24 petition: 25 hours shall be computed by excluding Saturdays, Sundays, and holidays: PROVIDED FURTHER, That, the court may, upon motion of the person whose 26 27 commitment is sought, or upon motion of petitioner with written 28 permission of the person whose commitment is sought, or his or her 29 counsel and, upon good cause shown, extend the date for the hearing. A copy of the petition and of the notice of the hearing, including the 30

- 1 date fixed by the court, shall be served by the designated chemical
- 2 dependency specialist on the person whose commitment is sought, his or
- 3 her next of kin, a parent or his or her legal guardian if he or she is
- 4 a minor, and any other person the court believes advisable. A copy of
- 5 the petition and certificate shall be delivered to each person
- 6 notified.
- 7 (3) At the hearing the court shall hear all relevant testimony,
- 8 including, if possible, the testimony, which may be telephonic, of at
- 9 least one licensed physician who has examined the person whose
- 10 commitment is sought. Communications otherwise deemed privileged under
- 11 the laws of this state are deemed to be waived in proceedings under
- 12 this chapter when a court of competent jurisdiction in its discretion
- 13 determines that the waiver is necessary to protect either the detained
- 14 person or the public. The waiver of a privilege under this section is
- 15 limited to records or testimony relevant to evaluation of the detained
- 16 person for purposes of a proceeding under this chapter. Upon motion by
- 17 the detained person, or on its own motion, the court shall examine a
- 18 record or testimony sought by a petitioner to determine whether it is
- 19 within the scope of the waiver.
- 20 The record maker shall not be required to testify in order to
- 21 introduce medical, nursing, or psychological records of detained
- 22 persons so long as the requirements of RCW 5.45.020 are met, except
- 23 that portions of the record that contain opinions as to whether the
- 24 detained person is an alcoholic, or in the case of a minor
- 25 <u>incapacitated by alcoholism and/or other drug addiction</u>, must be
- 26 deleted from the records unless the person offering the opinions is
- 27 available for cross-examination. The person shall be present unless
- 28 the court believes that his or her presence is likely to be injurious
- 29 to him or her; in this event the court may deem it appropriate to
- 30 appoint a guardian ad litem to represent him or her throughout the

- 1 proceeding. If deemed advisable, the court may examine the person out
- 2 of courtroom. If the person has refused to be examined by a licensed
- 3 physician, he or she shall be given an opportunity to be examined by a
- 4 court appointed licensed physician. If he or she refuses and there is
- 5 sufficient evidence to believe that the allegations of the petition are
- 6 true, or if the court believes that more medical evidence is necessary,
- 7 the court may make a temporary order committing him or her to the
- 8 department for a period of not more than five days for purposes of a
- 9 diagnostic examination.
- 10 (4) If after hearing all relevant evidence, including the results
- 11 of any diagnostic examination, the court finds that grounds for
- 12 involuntary commitment have been established by clear, cogent, and
- 13 convincing proof, it shall make an order of commitment to an approved
- 14 treatment program. It shall not order commitment of a person unless it
- 15 determines that an approved treatment program is available and able to
- 16 provide adequate and appropriate treatment for him or her.
- 17 (5) A person committed under this section shall remain in the
- 18 program for treatment for a period of sixty days unless sooner
- 19 discharged. At the end of the sixty-day period, he or she shall be
- 20 discharged automatically unless the program, before expiration of the
- 21 period, files a petition for his or her recommitment upon the grounds
- 22 set forth in subsection (1) of this section for a further period of

- 2 commitment is sought and upon good cause shown, extend the date for the
- 3 hearing. A copy of the petition and of the notice of hearing,

- 5 program on the person whose commitment is sought, his or her next of
- 6 kin, the original petitioner under subsection (1) of this section if
- 7 different from the petitioner for recommitment, one of his or her

- 17 shall be discharged at any time before the end of the period for which
- 18 he or she has been committed and he or she shall be discharged by order
- 19 of the court if either of the following conditions are met:
- 20 (a) In case of an alcoholic committed on the grounds of likelihood
- 21 of infliction of physical harm upon himself, herself, or another, or,
- 22 in the case of a minor, an alcoholic or other drug addict, the
- 23 likelihood no longer exists; or further treatment will not be likely to
- 24 bring about significant improvement in the person's condition, or
- 25 treatment is no longer adequate or appropriate.
- 26 (b) In case of an alcoholic committed on the grounds of the need of
- 27 treatment and incapacity or, in the case of a minor, incapacitated by
- 28 <u>alcoholism and/or other drug addiction</u>, that the incapacity no longer
- 29 exists.

- 1 The court shall inform the person whose commitment or 2 recommitment is sought of his or her right to contest the application, 3 be represented by counsel at every stage of any proceedings relating to 4 his or her commitment and recommitment, and have counsel appointed by the court or provided by the court, if he or she wants the assistance 5 6 of counsel and is unable to obtain counsel. If the court believes that the person needs the assistance of counsel, the court shall require, by 7 appointment if necessary, counsel for him or her regardless of his or 8 9 her wishes. The person shall, if he or she is financially able, bear 10 the costs of such legal service; otherwise such legal service shall be at public expense. The person whose commitment or recommitment is 11 sought shall be informed of his or her right to be examined by a 12 licensed physician of his or her choice. If the person is unable to 13 14 obtain a licensed physician and requests examination by a physician, the court shall employ a licensed physician. 15
- (10) A person committed under this chapter may at any time seek to be discharged from commitment by writ of habeas corpus in a court of competent jurisdiction.
- 19 (11) The venue for proceedings under this section is the county in 20 which person to be committed resides or is present.
- (12) When in the opinion of the professional person in charge of 21 the program providing involuntary treatment under this chapter, the 22 committed patient can be appropriately served by less restrictive 23 24 treatment before expiration of the period of commitment, then the less restrictive care may be required as a condition for early release for 25 a period which, when added to the initial treatment period, does not 26 27 exceed the period of commitment. If the program designated to provide 28 the less restrictive treatment is other than the program providing the 29 initial involuntary treatment, the program so designated must agree in writing to assume such responsibility. A copy of the conditions for 30

early release shall be given to the patient, the designated chemical 1 2 dependency specialist of original commitment, and the court of original The program designated to provide less restrictive care 3 4 may modify the conditions for continued release when the modifications are in the best interests of the patient. If the program providing 5 6 less restrictive care and the designated chemical dependency specialist determine that a conditionally released patient is failing to adhere to 7 the terms and conditions of his or her release, or that substantial 8 deterioration in the patient's functioning has occurred, then the 9 10 designated chemical dependency specialist shall notify the court of original commitment and request a hearing to be held no less than two 11 12 and no more than seven days after the date of the request to determine 13 whether or not the person should be returned to more restrictive care. 14 The designated chemical dependency specialist shall file a petition 15 with the court stating the facts substantiating the need for the 16 hearing along with the treatment recommendations. The patient shall 17 have the same rights with respect to notice, hearing, and counsel as 18 for the original involuntary treatment proceedings. The issues to be 19 determined at the hearing are whether the conditionally released 20 patient did or did not adhere to the terms and conditions of his or her release to less restrictive care or that substantial deterioration of 21 the patient's functioning has occurred and whether the conditions of 22 release should be modified or the person should be returned to a more 23 24 restrictive program. The hearing may be waived by the patient and his 25 or her counsel and his or her guardian or conservator, if any, but may not be waived unless all such persons agree to the waiver. 26 27 waiver, the person may be returned for involuntary treatment or 28 continued on conditional release on the same or modified conditions."

3 Each person involuntarily admitted to an evaluation and treatment 4 facility shall, within twenty-four hours of his or her admission, be 5 examined and evaluated by a licensed physician who may be assisted by 6 a physician(('s)) assistant according to chapter 18.71A RCW or a nurse practitioner according to chapter 18.88 RCW and a mental health 7 professional as defined in this chapter, and shall receive such 8 9 treatment and care as his or her condition requires including treatment 10 on an outpatient basis for the period that he or she is detained, except that, beginning twenty-four hours prior to a court proceeding, 11 the individual may refuse all but emergency life-saving treatment, and 12 13 the individual shall be informed at an appropriate time of his or her 14 right to such refusal of treatment. If, after examination and evaluation, the licensed physician and mental health professional determine that the initial needs of the person would be better served by placement in ((an alcohol)) a chemical dependency treatment facility, then the person shall be referred to an approved treatment ((facility)) program defined under RCW 70.96A.020.
