- 8 PACKAGING"
- 9 "Sec. 101. RCW 70.93.020 and 1979 c 94 s 2 are each amended to
- 10 read as follows:
- 11 The purpose of this chapter is to accomplish litter control and
- 12 stimulate private recycling programs throughout this state by
- 13 delegating to the department of ecology the authority to:
- 14 (1) Conduct a permanent and continuous program to control and
- 15 remove litter from this state to the maximum practical extent possible;
- 16 (2) Recover and recycle waste materials related to litter and
- 17 littering;
- 18 (3) Foster private recycling and markets for recyclable materials;
- 19 and
- 20 (4) Increase public awareness of the need for recycling and litter
- 21 control. It is further the intent and purpose of this chapter to
- 22 create jobs for employment of youth in litter cleanup and related
- 23 activities and to stimulate and encourage small, private recycling
- 24 centers. This program shall include the compatible goal of recovery of
- 25 recyclable materials to conserve energy and natural resources wherever
- 26 practicable. Every other department of state government and all local
- 27 governmental units and agencies of this state shall cooperate with the

- 1 department of ecology in the administration and enforcement of this
- 2 chapter. The intent of this chapter is to add to and to coordinate
- 3 existing recycling and litter control and removal efforts and not
- 4 terminate or supplant such efforts."
- 5 "Sec. 102. RCW 70.93.030 and 1979 c 94 s 3 are each amended to
- 6 read as follows:
- 7 As used in this chapter unless the context indicates otherwise:
- 8 (1) "Department" means the department of ecology;
- 9 (2) "Director" means the director of the department of ecology;
- 10 (3) "Disposable package or container" means all packages or
- 11 containers defined as such by rules and regulations adopted by the
- 12 department of ecology;
- 13 (4) "Litter" means all waste material including but not limited to
- 14 disposable packages or containers thrown or deposited as herein
- 15 prohibited but not including the wastes of the primary processes of
- 16 mining, logging, sawmilling, farming, or manufacturing;
- 17 (5) "Litter bag" means a bag, sack, or other container made of any
- 18 material which is large enough to serve as a receptacle for litter
- 19 inside the vehicle or watercraft of any person. It is not necessarily
- 20 limited to the state approved litter bag but must be similar in size
- 21 and capacity;
- 22 (6) "Litter receptacle" means those containers adopted by the
- 23 department of ecology and which may be standardized as to size, shape,
- 24 capacity, and color and which shall bear the state anti-litter symbol,
- 25 as well as any other receptacles suitable for the depositing of litter;
- 26 (7) "Person" means any political subdivision, government agency,
- 27 municipality, industry, public or private corporation, copartnership,
- 28 association, firm, individual, or other entity whatsoever;

- 1 (8) "Recycling" means ((the process of separating, cleansing,
- 2 treating, and reconstituting used or discarded litter related materials
- 3 for the purpose of recovering and reusing the resources contained
- 4 therein)) transforming or remanufacturing waste materials into a
- 5 finished product for use other than landfill disposal or incineration;
- 6 (9) "Recycling center" means a central collection point for
- 7 recyclable materials;
- 8 (10) "Vehicle" includes every device capable of being moved upon a
- 9 public highway and in, upon, or by which any persons or property is or
- 10 may be transported or drawn upon a public highway, excepting devices
- 11 moved by human or animal power or used exclusively upon stationary
- 12 rails or tracks;
- 13 (11) "Watercraft" means any boat, ship, vessel, barge, or other
- 14 floating craft;
- 15 (12) "Public place" means any area that is used or held out for use
- 16 by the public whether owned or operated by public or private
- 17 interests."
- 18 "NEW SECTION. Sec. 103. Unless the context clearly requires
- 19 otherwise, the definitions in this section apply throughout this
- 20 chapter.
- 21 (1) "Container," unless otherwise specified, refers to "rigid
- 22 plastic container" or "plastic bottle" as those terms are defined in
- 23 this section.
- 24 (2) "Distributors" means those persons engaged in the distribution
- 25 of packaged goods for sale in the state of Washington, including
- 26 manufacturers, wholesalers, and retailers.
- 27 (3) "Label" means a molded, imprinted, or raised symbol on or near
- 28 the bottom of a plastic container or bottle.

- 1 (4) "Person" means an individual, sole proprietor, partnership,
- 2 association, or other legal entity.
- 3 (5) "Plastic" means a material made of polymeric organic compounds
- 4 and additives that can be shaped by flow.
- 5 (6) "Plastic bottle" means a plastic container intended for single
- 6 use that has a neck that is smaller than the body of the container,
- 7 accepts a screw-type, snap cap, or other closure and has a capacity of
- 8 sixteen fluid ounces or more, but less than five gallons.
- 9 (7) "Rigid plastic container" means a formed or molded container,
- 10 other than a bottle, intended for single use, composed predominantly of
- 11 plastic resin, and having a relatively inflexible finite shape or form
- 12 with a capacity of eight ounces or more but less than five gallons."
- "NEW SECTION. Sec. 104. (1) The provisions of this section and
- 14 any rules adopted under this section shall be interpreted to conform
- 15 with nation-wide plastics industry standards.
- 16 (2) Except as provided in section 105(2) of this act, after January
- 17 1, 1992, no person may distribute, sell, or offer for sale in this
- 18 state a plastic bottle or rigid plastic container unless the container
- 19 is labeled with a code identifying the appropriate resin type used to
- 20 produce the structure of the container. The code shall consist of a
- 21 number placed within three triangulated arrows and letters placed below
- 22 the triangle of arrows. The triangulated arrows shall be equilateral,
- 23 formed by three arrows with the apex of each point of the triangle at
- 24 the midpoint of each arrow, rounded with a short radius. The pointer
- 25 (arrowhead) of each arrow shall be at the midpoint of each side of the
- 26 triangle with a short gap separating the pointer from the base of the
- 27 adjacent arrow. The triangle, formed by the three arrows curved at
- 28 their midpoints shall depict a clockwise path around the code number.

- 8 "NEW SECTION. Sec. 105. (1) A person who, after written notice
- 9 from the department, violates section 104 of this act is subject to a
- 10 civil penalty of fifty dollars for each violation up to a maximum of
- 11 five hundred dollars and may be enjoined from continuing violations.
- 12 Each distribution constitutes a separate offense.
- 13 (2) Retailers and distributors shall have two years from the
- 14 effective date of this section to clear current inventory, delivered or
- 15 received and held in their possession as of the effective date of this
- 16 section."
- 17 "NEW SECTION. Sec. 106. The legislature finds and declares that:
- 18 (1) The management of solid waste can pose a wide range of hazards
- 19 to public health and safety and to the environment;
- 20 (2) Packaging comprises a significant percentage of the overall
- 21 solid waste stream;
- 22 (3) The presence of heavy metals in packaging is a part of the
- 23 total concern in light of their likely presence in emissions or ash
- 24 when packaging is incinerated, or in leachate when packaging is
- 25 landfilled;
- 26 (4) Lead, mercury, cadmium, and hexavalent chromium, on the basis
- 27 of available scientific and medical evidence, are of particular
- 28 concern;

- 1 (5) The intent of this chapter is to achieve a reduction in
- 2 toxicity without impeding or discouraging the expanded use of
- 3 postconsumer materials in the production of packaging and its
- 4 components."
- 5 "NEW SECTION. Sec. 107. Unless the context clearly requires
- 6 otherwise, the definitions in this section apply throughout this
- 7 chapter.
- 8 (1) "Package" means a container providing a means of marketing,
- 9 protecting, or handling a product and shall include a unit package, an
- 10 intermediate package, and a shipping container. "Package" also means
- 11 and includes unsealed receptacles such as carrying cases, crates, cups,
- 12 pails, rigid foil and other trays, wrappers and wrapping films, bags,
- 13 and tubs.
- 14 (2) "Manufacturer" means a person, firm, or corporation that
- 15 applies a package to a product for distribution or sale.
- 16 (3) "Packaging component" means an individual assembled part of a
- 17 package such as, but not limited to, any interior or exterior blocking,
- 18 bracing, cushioning, weatherproofing, exterior strapping, coatings,
- 19 closures, inks, and labels."
- 20 "NEW SECTION. Sec. 108. The sum of the concentration levels of
- 21 lead, cadmium, mercury, and hexavalent chromium present in any product,
- 22 package, or packaging component shall not exceed the following:
- 23 (1) Six hundred parts per million by weight effective July 1, 1993;
- 24 (2) Two hundred fifty parts per million by weight effective July 1,
- 25 1994; and
- 26 (3) One hundred parts per million by weight effective July 1, 1995
- 27 after the effective date of this section.

- 1 This section shall apply only to lead, cadmium, mercury, and
- 2 hexavalent chromium that has been intentionally introduced as an
- 3 element during manufacturing or distribution."
- 4 "NEW SECTION. Sec. 109. All packages and packaging components
- 5 shall be subject to this chapter except the following:
- 6 (1) Those packages or package components with a code indicating
- 7 date of manufacture that were manufactured prior to the effective date
- 8 of this section;
- 9 (2) Those packages or packaging components that have been purchased
- 10 by, delivered to, or are possessed by a retailer on or before twenty-
- 11 four months following the effective date of this section to permit
- 12 opportunity to clear existing inventory of the proscribed packaging
- 13 material;
- 14 (3) Those packages or packaging components to which lead, cadmium,
- 15 mercury, or hexavalent chromium have been added in the manufacturing,
- 16 forming, printing, or distribution process in order to comply with
- 17 health or safety requirements of federal law or for which there is no
- 18 feasible alternative; or
- 19 (4) Those packages and packaging components that would not exceed
- 20 the maximum contaminant levels set forth in section 108(1) of this act
- 21 but for the addition of postconsumer materials; and provided that the
- 22 exemption for this subsection shall expire six years after the
- 23 effective date of this section."
- 24 "NEW SECTION. Sec. 110. By July 1, 1993, a certificate of
- 25 compliance stating that a package or packaging component is in
- 26 compliance with the requirements of this chapter shall be developed by
- 27 its manufacturer. If compliance is achieved under the exemption or
- 28 exemptions provided in section 109 (3) or (4) of this act, the

- 1 certificate shall state the specific basis upon which the exemption is
- 2 claimed. The certificate of compliance shall be signed by an
- 3 authorized official of the manufacturing company. The certificate of
- 4 compliance shall be kept on file by the manufacturer for as long as the
- 5 package or packaging component is in use, and for three years from the
- 6 date of the last sale or distribution by the manufacturer. Certificates
- 7 of compliance, or copies thereof, shall be furnished to the department
- 8 of ecology upon request within sixty days. If manufacturers are
- 9 required under any other state statute to provide a certificate of
- 10 compliance, one certificate may be developed containing all required
- 11 information.
- 12 If the manufacturer or supplier of the package or packaging
- 13 component reformulates or creates a new package or packaging component,
- 14 the manufacturer shall develop an amended or new certificate of
- 15 compliance for the reformulated or new package or packaging component."
- 16 "NEW SECTION. Sec. 111. Requests from a member of the public for
- 17 any certificate of compliance shall be:
- 18 (1) Made in writing to the department of ecology;
- 19 (2) Made specific as to package or packaging component information
- 20 requested; and
- 21 (3) Responded to by the department of ecology within ninety days."
- 22 "NEW SECTION. Sec. 112. The department of ecology may prohibit
- 23 the sale of any package for which a manufacturer has failed to respond
- 24 to a request by the department for a certificate of compliance within
- 25 the allotted period of time pursuant to section 110 of this act."
- "NEW SECTION. Sec. 113. By July 1, 1993, the solid waste advisory
- 27 committee created under chapter 70.95 RCW shall report to the

- 1 appropriate standing committees of the legislature on the need to
- 2 further reduce toxic metals from packaging. The report shall contain
- 3 recommendations to add other toxic substances contained in packaging to
- 4 the list set forth in this chapter, including but not limited to
- 5 mutagens, carcinogens, and teratogens, in order to further reduce the
- 6 toxicity of packaging waste, and shall contain a recommendation
- 7 regarding imposition of penalty for violation of section 108 of this
- 8 act."
- 9 "Sec. 114. RCW 70.95C.120 and 1989 c 431 s 54 are each amended to
- 10 read as follows:
- 11 The office of waste reduction shall develop, in consultation with the
- 12 superintendent of public instruction, an awards program to achieve
- 13 waste reduction and recycling in the public schools, grades
- 14 kindergarten through high school. The office shall develop guidelines
- 15 for program development and implementation. Each public school shall
- 16 implement a waste reduction and recycling program conforming to
- 17 guidelines developed by the office.
- 18 For the purpose of granting awards, the office may group schools
- 19 into not more than three classes, based upon student population,
- 20 distance to markets for recyclable materials, and other criteria, as
- 21 deemed appropriate by the office. Except as otherwise provided, five
- 22 or more awards shall be granted to each of the three classes. Each
- 23 award shall be a sum of not less than two thousand dollars nor more
- 24 than five thousand dollars. Awards shall be granted each year to the
- 25 schools that achieve the greatest levels of waste reduction and
- 26 recycling. ((Each)) A single award ((shall be of a sum)) of not less
- 27 than ((ten)) five thousand dollars shall be presented to the school
- 28 having the best recycling program as measured by the total amount of
- 29 <u>materials recycled</u>, <u>including materials generated outside of the</u>

- 1 school. A single award of not less than five thousand dollars shall be
- 2 presented to the school having the best waste reduction program as
- 3 <u>determined</u> by the <u>office</u>. ((The <u>office</u> shall also <u>develop</u>
- 4 recommendations for an awards program for waste reduction in the public
- 5 schools. The office shall submit these recommendations to the
- 6 appropriate standing committees in the house of representatives and
- 7 senate on or before November 30, 1989.))
- 8 The superintendent of public instruction shall distribute
- 9 guidelines and other materials developed by the office to implement
- 10 programs to reduce and recycle waste generated in administrative
- 11 offices, classrooms, laboratories, cafeterias, and maintenance
- 12 operations."
- 13 "NEW SECTION. Sec. 115. There is established the task force on recycling funding. The task force shall consist of fourteen members as 14 (1) Two members of the house committee on environmental 15 follows: 16 affairs appointed by the chair of that committee with one member from 17 each of the two caucuses; (2) two members of the senate committee on 18 environment and natural resources appointed by the chair of that committee with one member from each of the two caucuses; (3) seven 19 20 members representing manufacturers, wholesalers, retailers, cities, counties, solid waste collection companies, and an environmental 21 organization appointed jointly by the chairs of the house committee on 22 23 environmental affairs and the senate committee on environment and 24 natural resources; and (4) three members representing the departments 25 of ecology, trade and economic development, and revenue appointed by 26 their respective directors. The agency representatives shall be 27 nonvoting except for the election of the chair, which shall be made by 28 a simple majority vote of all members.

- 1 The task force shall study long-term funding mechanisms and develop
- 2 specific funding recommendations for the clean Washington center. The
- 3 task force shall report its findings and recommended legislation to
- 4 fund the clean Washington center to the appropriate standing committees
- 5 of the legislature no later than December 1, 1991. The task force
- 6 shall also study and make recommendations on long-term funding for
- 7 integrated systems to reduce, collect, recycle, and dispose of
- 8 materials.
- 9 This section shall expire January 1, 1993."
- 10 "NEW SECTION. Sec. 116. Sections 103 through 105 of this act and
- 11 sections 106 through 113 shall each constitute a new chapter in Title
- 12 70 RCW."
- 13 "PART II
- 14 CLEAN WASHINGTON CENTER"
- 15 "NEW SECTION. Sec. 201. (1) The legislature finds that:
- 16 (a) Recycling conserves energy and landfill space, provides jobs
- 17 and valuable feedstock materials to industry, and promotes health and
- 18 environmental protection;
- 19 (b) Seventy-eight percent of the citizens of the state actively
- 20 participate in recycling programs and Washington currently has the
- 21 highest recycling rate in the nation;
- (c) The current supply of many recycled commodities far exceeds the
- 23 demand for such commodities;
- 24 (d) Many local governments and private entities cumulatively
- 25 affect, and are affected by, the market for recycled commodities but
- 26 have limited jurisdiction and cannot adequately address the problems of

- 1 market development that are complex, wide-ranging, and regional in
- 2 nature; and
- 3 (e) The private sector has the greatest capacity for creating and
- 4 expanding markets for recycled commodities, and the development of
- 5 private markets for recycled commodities is in the public interest.
- 6 (2) It is therefore the policy of the state to create a single
- 7 entity to be known as the clean Washington center to develop new, and
- 8 expand existing, markets for recycled commodities."
- 9 "NEW SECTION. Sec. 202. There is created the clean Washington
- 10 center within the department of trade and economic development. As
- 11 used in this chapter, "center" means the clean Washington center."
- 12 "NEW SECTION. Sec. 203. The purpose of the center is to provide
- 13 or facilitate business assistance, basic and applied research and
- 14 development, marketing, public education, and policy analysis in
- 15 furthering the development of markets for recycled products. As used
- 16 in this chapter, market development consists of public and private
- 17 activities that are used to overcome impediments preventing full use of
- 18 secondary materials diverted from the waste stream, and that encourage
- 19 and expand use of those materials and subsequent products. In
- 20 fulfilling this mission the center shall primarily direct its services
- 21 to businesses that transform or remanufacture waste materials into
- 22 usable or marketable materials or products for use other than landfill
- 23 disposal or incineration."
- 24 "NEW SECTION. Sec. 204. (1) The center's activities shall be
- 25 conducted with the assistance of a policy board. Except as otherwise
- 26 provided, policy board members shall be appointed by the directors of

- 1 the department of trade and economic development and department of
- 2 ecology as follows:
- 3 (a) Two representatives of the legislature, one appointed by the
- 4 speaker of the house of representatives and one appointed by the
- 5 president of the senate;
- 6 (b) One member to represent cities;
- 7 (c) One member to represent counties;
- 8 (d) Five private sector members to represent the end users and
- 9 marketers of postconsumer recovered materials, including one member to
- 10 represent recycling businesses;
- 11 (e) The directors of the departments of trade and economic
- 12 development and ecology shall represent the executive branch as
- 13 nonvoting members; and
- 14 (f) Nonvoting, temporary appointments to the board can be made by
- 15 the chair where specific expertise is needed.
- 16 (2) The initial appointments of the five private sector members
- 17 will be two members with three-year terms and three members with two-
- 18 year terms. Thereafter, members shall serve two-year renewable terms.
- 19 Vacancies shall be filled by the chair with majority consent from the
- 20 members.
- 21 (3) Members of the board, exclusive of those representing the
- 22 legislative or executive branches, shall be reimbursed for travel
- 23 expenses as provided in RCW 43.03.050 and 43.03.060.
- 24 (4) The board shall meet at least quarterly.
- 25 (5) The chair shall be elected from among the members by a simple
- 26 majority vote.
- 27 (6) The board may adopt and exercise bylaws for the regulation of
- 28 its business for the purposes of this chapter."
- 29 "NEW SECTION. Sec. 205. The center shall:

- 1 (1) Provide targeted business assistance to recycling businesses,
- 2 including:
- 3 (a) Development of business plans;
- 4 (b) Market research and planning information;
- 5 (c) Access to financing programs;
- 6 (d) Referral and information on market conditions; and
- 7 (e) Information on new technology and product development;
- 8 (2) Negotiate voluntary agreements with manufacturers to increase
- 9 the use of recycled materials in product development;
- 10 (3) Support and provide research and development to stimulate and
- 11 commercialize new and existing technologies and products using recycled
- 12 materials;
- 13 (4) Undertake an integrated, comprehensive education effort
- 14 directed to recycling businesses to promote processing, manufacturing,
- 15 and purchase of recycled products, including:
- 16 (a) Provide information to recycling businesses on the availability
- 17 and benefits of using recycled materials;
- 18 (b) Provide information and referral services on recycled material
- 19 markets;
- 20 (c) Provide information on new research and technologies that may
- 21 be used by local businesses and governments; and
- 22 (d) Participate in projects to demonstrate new market uses or
- 23 applications for recycled products;
- 24 (5) Assist the departments of ecology and general administration in
- 25 the development of consistent definitions and standards on recycled
- 26 content, product performance, and availability;
- 27 (6) Undertake studies on the unmet capital needs of reprocessing
- 28 and manufacturing firms using recycled materials;

- 1 (7) Undertake and participating in marketing promotions for the
- 2 purposes of achieving expanded market penetration for recycled content
- 3 products;
- 4 (8) Coordinate with the department of ecology to ensure that the
- 5 education programs of both are mutually reinforcing, with the center
- 6 acting as the lead entity with respect to recycling businesses, and the
- 7 department as the lead entity with respect to the general public and
- 8 retailers;
- 9 (9) Develop an annual work plan. The plan shall describe actions
- 10 and recommendations for developing markets for commodities comprising
- 11 a significant percentage of the waste stream and having potential for
- 12 use as an industrial or commercial feedstock. The initial plan shall
- 13 address, but not be limited to, mixed waste paper, waste tires, yard
- 14 and food waste, and plastics; and
- 15 (10) Represent the state in regional and national market
- 16 development issues."
- 17 "NEW SECTION. Sec. 206. In order to carry out its
- 18 responsibilities under this chapter, the center may:
- 19 (1) Receive such gifts, grants, funds, fees, and endowments, in
- 20 trust or otherwise, for the use and benefit of the purposes of the
- 21 center. The center may expend the same or any income therefrom
- 22 according to the terms of the gifts, grants, or endowments;
- 23 (2) Initiate, conduct, or contract for studies and searches
- 24 relating to market development for recyclable materials, including but
- 25 not limited to applied research, technology transfer, and pilot
- 26 demonstration projects;
- 27 (3) Obtain and disseminate information relating to market
- 28 development for recyclable materials from other state and local
- 29 agencies;

- 1 (4) Enter into, amend, and terminate contracts with individuals,
- 2 corporations, trade associations, and research institutions for the
- 3 purposes of this chapter;
- 4 (5) Provide grants to local governments or other public
- 5 institutions to further the development of recycling markets;
- 6 (6) Provide business and marketing assistance to public and private
- 7 sector entities within the state; and
- 8 (7) Evaluate, analyze, and make recommendations on state policies
- 9 that may affect markets for recyclable materials."
- 10 "NEW SECTION. Sec. 207. The center shall solicit financial
- 11 contributions and support from manufacturing industries and other
- 12 private sector sources, foundations, and grants from governmental
- 13 sources to assist in conducting its activities. It may also use
- 14 separately appropriated funds of the department of trade and economic
- 15 development for the center's activities."
- 16 "NEW SECTION. Sec. 208. The center may appoint advisory
- 17 committees to assist in the development or implementation of the work
- 18 plan."
- 19 "NEW SECTION. Sec. 209. The center shall terminate on June 30,
- 20 1997."
- 21 "Sec. 210. RCW 43.31.545 and 1989 c 431 s 64 are each amended to
- 22 read as follows:
- 23 $((\frac{1}{1}))$ The department is the lead state agency to assist in
- 24 establishing and improving markets for recyclable materials generated
- 25 in the state. ((This priority on creating and expanding a recyclables
- 26 market should be fully integrated into the current targeted sector

- 1 marketing programs of the department. In carrying out these marketing
- 2 responsibilities, the department shall work closely with the office of
- 3 waste reduction in the department of ecology.
- 4 (2) The department of trade and economic development, with the
- 5 assistance of the department of ecology and the committee for recycling
- 6 markets created by RCW 43.31.552, shall develop programs to accomplish
- 7 the following:
- 8 (a) Develop new markets inside and outside this state for recycled
- 9 materials;
- 10 (b) Attract new businesses to this state whose purpose is to use
- 11 recycled materials;
- (c) Educate businesses and consumers about the high quality of
- 13 Washington recycled materials;
- 14 (d) Promote business and consumer use of products made from
- 15 recycled materials;
- 16 (e) Provide technical market assistance to businesses and local
- 17 governments;
- 18 (f) Cooperate with and secure the cooperation of any department,
- 19 agency, commission, or instrumentality in state or local government
- 20 affected by or concerned with market development; and
- 21 (g) Create and maintain a list of recyclers, collectors, and other
- 22 persons or entities interested in the development of markets for
- 23 recycling and solicit the opinions of those persons with respect to
- 24 market development.))"

- 15 USED OIL RECYCLING"
- 16 "NEW SECTION. Sec. 301. INTENT. "(1) The legislature finds that:
- 17 (a) Millions of gallons of used oil are generated each year in this
- 18 state, and used oil is a valuable petroleum resource that can be
- 19 recycled;
- 20 (b) The improper collection, transportation, recycling, use, or
- 21 disposal of used oil contributes to the pollution of air, water, and
- 22 land, and endangers public health and welfare;
- 23 (c) The private sector is a vital resource in the collection and
- 24 recycling of used oil and should be involved in its collection and
- 25 recycling whenever practicable.
- 26 (2) In light of the harmful consequences of improper disposal and
- 27 use of used oil, and its value as a resource, the legislature declares

- 1 that the collection, recycling, and reuse of used oil is in the public
- 2 interest.
- 3 (3) The department, when appropriate, should promote the rerefining

- 9 (1) "Rerefining used oil" means the reclaiming of base lube stock
- 10 from used oil for use again in the production of lube stock.
- 11 Rerefining used oil does not mean combustion or landfilling.
- 12 (2) "Used oil" means (a) lubricating fluids that have been removed
- 13 from an engine crankcase, transmission, gearbox, hydraulic device, or
- 14 differential of an automobile, bus, truck, vessel, plane, heavy
- 15 equipment, or machinery powered by an internal combustion engine; (b)
- 16 any oil that has been refined from crude oil, used, and as a result of
- 17 use, has been contaminated with physical or chemical impurities; and
- 18 (c) any oil that has been refined from crude oil and, as a consequence
- 19 of extended storage, spillage, or contamination, is no longer useful to
- 20 the original purchaser. "Used oil" does not include used oil to which
- 21 hazardous wastes have been added.
- 22 (3) "Public used oil collection site" means a site where a used oil
- 23 collection tank has been placed for the purpose of collecting household
- 24 generated used oil. "Public used oil collection site" also means a
- 25 vehicle designed or operated to collect used oil from the public.
- 26 (4) "Lubricating oil" means any oil designed for use in, or
- 27 maintenance of, a vehicle, including, but not limited to, motor oil,
- 28 gear oil, and hydraulic oil. "Lubricating oil" does not mean petroleum
- 29 hydrocarbons with a flash point below one hundred degrees Centigrade.

- 1 (5) "Vehicle" includes every device physically capable of being
- 2 moved upon a public or private highway, road, street, watercourse, or
- 3 trail, and in, upon, or by which any person or property is or may be
- 4 transported or drawn upon a public or private highway, road, street,
- 5 watercourse, or trail, except devices moved by human or animal power.
- 6 (6) "Department" means the department of ecology.
- 7 (7) "Local government" means a city or county developing a local
- 8 hazardous waste plan under RCW 70.105.220."
- 9 "NEW SECTION. Sec. 303. PUBLIC USED OIL COLLECTION. (1) Each
- 10 local government and its local hazardous waste plan under RCW
- 11 70.105.220 is required to include a used oil recycling element. This
- 12 element shall include:
- 13 (a) A plan to reach the local goals for household used oil
- 14 recycling established by the local government and the department under
- 15 section 304 of this act. The plan shall, to the maximum extent

- 9 estimated state-wide collection and rerefining rate for calendar year
- 10 1993, and shall increase each year until calendar year 1996, when the
- 11 rate shall be eighty percent.

- 19 shall adopt ordinances within its jurisdiction to enforce subsections
- 20 (1) and (4) of this section."
- 21 "NEW SECTION. Sec. 306. STATE-WIDE EDUCATION. The department
- 22 shall conduct a public education program to inform the public of the
- 23 needs for and benefits of collecting and recycling used oil in order to
- 24 conserve resources and protect the environment. As part of this
- 25 program, the department shall:
- 26 (1) Establish and maintain a state-wide list of public used oil
- 27 collection sites, and a list of all persons coordinating local
- 28 government used oil programs;

- 1 (2) Establish a state-wide media campaign describing used oil

- 4 awareness programs concerning used oil by providing technical

- 9 "NEW SECTION. Sec. 307. DISPOSAL OF USED OIL. (1) Effective
- 10 January 1, 1992, the use of used oil for dust suppression or weed
- 11 abatement is prohibited.
- 12 (2) Effective July 1, 1992, no person may sell or distribute
- 13 absorbent-based kits, intended for home use, as a means for collecting,
- 14 recycling, or disposing of used oil.
- 15 (3) Effective January 1, 1994, no person may knowingly dispose of
- 16 used oil except by delivery to a person collecting used oil for
- 17 recycling, treatment, or disposal, subject to the provisions of this
- 18 chapter and chapter 70.105 RCW.
- 19 (4) Effective January 1, 1994, no owner or operator of a solid
- 20 waste landfill may knowingly accept used oil for disposal in the
- 21 landfill.
- 22 (5) A person who violates this section is guilty of a misdemeanor."
- 23 "NEW SECTION. Sec. 308. USED OIL TRANSPORTER AND PROCESSOR
- 24 REQUIREMENTS. (1) By January 1, 1993, the department shall adopt rules
- 25 requiring any transporter of used oil to comply with minimum notifi-

- 6 (i) Flash point: 100 degrees Fahrenheit minimum.
- 7 (2) This section shall not apply to: (a) Used oil burned in space
- 8 heaters if the space heater has a maximum heat output of not greater
- 9 than 0.5 million btu's per hour or used oil burned in facilities
- 10 permitted by the department or a local air pollution control authority;
- 11 or (b) ocean-going vessels.
- 12 (3) This section shall not apply to persons in the business of
- 13 collecting used oil from residences when under authorization by a city,
- 14 county, or the utilities and transportation commission."
- 15 "NEW SECTION. Sec. 312. A new section is added to chapter 70.105
- 16 RCW to read as follows:
- 17 Local governments and combinations of local governments shall amend
- 18 their local hazardous waste plans required under RCW 70.105.220 to
- 19 comply with section 303 of this act."
- 20 "Sec. 313. RCW 70.95C.020 and 1990 c 114 s 2 are each amended to
- 21 read as follows:
- 22 As used in this chapter, the following terms have the meanings
- 23 indicated unless the context clearly requires otherwise.
- 24 (1) "Department" means the department of ecology.
- 25 (2) "Director" means the director of the department of ecology or
- 26 the director's designee.
- 27 (3) "Dangerous waste" shall have the same definition as set forth

- 14 waste or first causes a hazardous waste to become subject to
- 15 regulation.
- 16 (8) "Hazardous substance" means any hazardous substance listed as
- 17 a hazardous substance as of March 21, 1990, pursuant to section 313 of
- 18 Title III of the Superfund Amendments and Reauthorization Act, any
- 19 other substance determined by the director by rule to present a threat
- 20 to human health or the environment, and all ozone depleting compounds
- 21 as defined by the Montreal Protocol of October 1987.
- 22 (9) (a) "Hazardous substance use reduction" means the reduction,
- 23 avoidance, or elimination of the use or production of hazardous
- 24 substances without creating substantial new risks to human health or
- 25 the environment.
- 26 (b) "Hazardous substance use reduction" includes proportionate
- 27 changes in the usage of hazardous substances as the usage of a
- 28 hazardous substance or hazardous substances changes as a result of
- 29 production changes or other business changes.

- 1 (10) "Hazardous substance user" means any facility required to
- 2 report under section 313 of Title III of the Superfund Amendments and
- 3 Reauthorization Act, except for those facilities which only distribute
- 4 or use fertilizers or pesticides intended for commercial agricultural
- 5 applications.
- 6 (11) "Hazardous waste" means and includes all dangerous and
- 7 extremely hazardous wastes, but does not include radioactive wastes or
- 8 a substance composed of both radioactive and hazardous components and
- 9 does not include any hazardous waste generated as a result of a
- 10 remedial action under state or federal law.
- 11 (12) "Hazardous waste generator" means any person generating
- 12 hazardous waste regulated by the department.
- 13 (13) "Office" means the office of waste reduction.
- 14 (14) "Plan" means the plan provided for in RCW 70.95C.200.
- 15 (15) "Person" means an individual, trust, firm, joint stock
- 16 company, partnership, association, state, public or private or
- 17 municipal corporation, commission, political subdivision of a state,
- 18 interstate body, the federal government, including any agency or
- 19 officer thereof, and any Indian tribe or authorized tribal
- 20 organization.
- 21 (16) "Process" means all industrial, commercial, production, and
- 22 other processes that result in the generation of waste.
- 23 (17) "Recycled for beneficial use" means the use of hazardous
- 24 waste, either before or after reclamation, as a substitute for a
- 25 commercial product or raw material, but does not include: (a) Use
- 26 constituting disposal; (b) incineration; or (c) use as a fuel.
- 27 (18) "Recycling" means reusing waste materials and extracting
- 28 valuable materials from a waste stream. Recycling does not include
- 29 burning for energy recovery.

- 1 (19) "Treatment" means the physical, chemical, or biological
- 2 processing of waste to render it completely innocuous, produce a
- 3 recyclable by-product, reduce toxicity, or substantially reduce the
- 4 volume of material requiring disposal as described in the priorities
- 5 established in RCW 70.105.150. Treatment does not include
- 6 incineration.
- 7 (20) "Used oil" means (a) lubricating fluids that have been removed
- 8 from an engine crankcase, transmission, gearbox, hydraulic device, or
- 9 <u>differential of an automobile, bus, truck, vessel, plane, heavy</u>
- 10 equipment, or machinery powered by an internal combustion engine; (b)
- 11 any oil that has been refined from crude oil, used, and as a result of
- 12 <u>use</u>, has been contaminated with physical or chemical impurities; and
- 13 (c) any oil that has been refined from crude oil and, as a consequence
- 14 of extended storage, spillage, or contamination, is no longer useful to
- 15 the original purchaser. "Used oil" does not include used oil to which
- 16 <u>hazardous wastes have been added.</u>
- 17 (21) "Waste" means any solid waste as defined under RCW 70.95.030,
- 18 any hazardous waste, any air contaminant as defined under RCW
- 19 70.94.030, and any organic or inorganic matter that shall cause or tend
- 20 to cause water pollution as defined under RCW 90.48.020.
- 21 (((21))) (22) "Waste generator" means any individual, business,
- 22 government agency, or any other organization that generates waste.
- $((\frac{(22)}{2}))$ "Waste reduction" means all in-plant practices that
- 24 reduce, avoid, or eliminate the generation of wastes or the toxicity of
- 25 wastes, prior to generation, without creating substantial new risks to
- 26 human health or the environment. As used in RCW 70.95C.200 through
- 27 70.95C.240, "waste reduction" refers to hazardous waste only."
- 28 "Sec. 314. RCW 70.95C.200 and 1990 c 114 s 6 are each amended to
- 29 read as follows:

- 1 (1) Each hazardous waste generator who generates more than two thousand
- 2 six hundred forty pounds of hazardous waste per year and each hazardous
- 3 substance user, except for those facilities that are primarily
- 4 permitted treatment, storage, and disposal facilities or recycling
- 5 facilities, shall prepare a plan for the voluntary reduction of the use
- 6 of hazardous substances and the generation of hazardous wastes.
- 7 Hazardous waste generated and recycled for beneficial use, including

- 24 (3) The department shall adopt by April 1, 1991, rules for
- 25 preparation of plans. The rules shall require the plan to address the
- 26 following options, according to the following order of priorities:
- 27 Hazardous substance use reduction, waste reduction, recycling, and
- 28 treatment. In the planning process, first consideration shall be given
- 29 to hazardous substance use reduction and waste reduction options.
- 30 Consideration shall be given next to recycling options. Recycling

- 1 options may be considered only after hazardous substance use reduction
- 2 options and waste reduction options have been thoroughly researched and
- 3 shown to be inappropriate. Treatment options may be considered only
- 4 after hazardous substance use reduction, waste reduction, and recycling
- 5 options have been thoroughly researched and shown to be inappropriate.
- 6 Documentation of the research shall be available to the department upon
- 7 request. The rules shall also require the plans to discuss the
- 8 hazardous substance use reduction, waste reduction, and closed loop
- 9 recycling options separately from other recycling and treatment
- 10 options. All plans shall be written in conformance with the format
- 11 prescribed in the rules adopted under this section. The rules shall
- 12 require the plans to include, but not be limited to:
- 13 (a) A written policy articulating management and corporate support
- 14 for the plan and a commitment to implementing planned activities and
- 15 achieving established goals;
- 16 (b) The plan scope and objectives;
- 17 (c) Analysis of current hazardous substance use and hazardous waste
- 18 generation, and a description of current hazardous substance use
- 19 reduction, waste reduction, recycling, and treatment activities;
- 20 (d) An identification of further hazardous substance use reduction,
- 21 waste reduction, recycling, and treatment opportunities, and an
- 22 analysis of the amount of hazardous substance use reduction and waste
- 23 reduction that would be achieved, and the costs. The analysis of
- 24 options shall demonstrate that the priorities provided for in this
- 25 section have been followed;
- 26 (e) A selection of options to be implemented in accordance with the
- 27 priorities established in this section;
- 28 (f) An analysis of impediments to implementing the options.
- 29 Impediments that shall be considered acceptable include, but are not

- 1 limited to: Adverse impacts on product quality, legal or contractual
- 2 obligations, economic practicality, and technical feasibility;
- 3 (g) A written policy stating that in implementing the selected
- 4 options, whenever technically and economically practicable, risks will
- 5 not be shifted from one part of a process, environmental media, or
- 6 product to another;
- 7 (h) Specific performance goals in each of the following categories,
- 8 expressed in numeric terms:
- 9 (i) Hazardous substances to be reduced or eliminated from use;
- 10 (ii) Wastes to be reduced or eliminated through waste reduction
- 11 techniques;
- 12 (iii) Materials or wastes to be recycled; and
- 13 (iv) Wastes to be treated;
- 14 If the establishment of numeric performance goals is not
- 15 practicable, the performance goals shall include a clearly stated list
- 16 of objectives designed to lead to the establishment of numeric goals as
- 17 soon as is practicable. Goals shall be set for a five-year period from
- 18 the first reporting date;
- 19 (i) A description of how the wastes that are not recycled or
- 20 treated and the residues from recycling and treatment processes are
- 21 managed may be included in the plan;
- 22 (j) Hazardous substance use and hazardous waste accounting systems
- 23 that identify hazardous substance use and waste management costs and
- 24 factor in liability, compliance, and oversight costs;
- 25 (k) A financial description of the plan;
- 26 (1) Personnel training and employee involvement programs;
- 27 (m) A five-year plan implementation schedule;
- 28 (n) Documentation of hazardous substance use reduction and waste
- 29 reduction efforts completed before or in progress at the time of the
- 30 first reporting date; and

- 1 (o) An executive summary of the plan, which shall include, but not
- 2 be limited to:
- 3 (i) The information required by (c), (e), (h), and (n) of this
- 4 subsection; and
- 5 (ii) A summary of the information required by (d) and (f) of this
- 6 subsection.
- 7 (4) Upon completion of a plan, the owner, chief executive officer,
- 8 or other person with the authority to commit management to the plan
- 9 shall sign and submit an executive summary of the plan to the
- 10 department.
