- 3 (5) "Producer" means any person, engaged in the business of producing or causing to be produced for market in commercial 4 agricultural commodity, including commercial 5 quantities any harvesters and processors of salmon harvested in the waters of the 6 7 state of Washington or pursuant to a commercial fishing license issued by the state of Washington. For the purposes of RCW 8 15.66.060, 15.66.090, and 15.66.120, as now or hereafter amended 9 10 "producer" shall include bailees who contract to produce or grow any agricultural product on behalf of a bailor who retains title to 11 the seed and its resulting agricultural product or the agricultural 12 13 product delivered for further production or increase.
- 14 (6) "Affected producer" means any producer of an affected commodity.
 - (7) "Affected commodity" means any agricultural commodity for which the director has established a list of producers pursuant to RCW 15.66.060.
 - (8) "Commodity commission" or "commission" means a commission formed to carry out the purposes of this chapter under a particular marketing order concerning an affected commodity.
- 22 (9) "Unit" means a unit of volume, quantity or other measure 23 in which an agricultural commodity is commonly measured.
 - (10) "Unfair trade practice" means any practice which is unlawful or prohibited under the laws of the state of Washington including but not limited to Titles 15, 16 and 69 RCW and chapters
