- "Text telephone (TT)," formerly known as a telecommunications
- 25 device for the deaf (TDD)((-)) means a ((teletypewriter))
- 26 <u>telecommunications device</u> that has a typewriter <u>or computer</u> keyboard
- 27 and a readable display that couples with the telephone, allowing

- 1 messages to be typed rather than spoken. The device allows a person to
- 2 make a telephone call directly to another person possessing similar
- 3 equipment. The conversation is typed through one machine to the other
- 4 machine instead of spoken.
- 5 "((TDD)) <u>Telecommunications</u> relay ((system)) <u>service (TRS)</u>" is a
- 6 service for hearing and speech impaired people who have a ((TDD)) TT to
- 7 call someone who does not have a ((TDD)) TT or vice versa. The service
- 8 consists of several telephones being utilized by ((TDD relay service
- 9 operators)) TRS communications assistants who receive either ((TDD)) TT
- 10 or voice phone calls. If a ((TDD relay service operator)) TRS
- 11 <u>communications assistant</u> receives a phone call from a hearing or speech
- 12 impaired person wishing to call a hearing person, the operator will
- 13 call the hearing person and act as an intermediary by translating what
- 14 is displayed on the ((TDD)) TT to voice and typing what is voiced into
- 15 the ((TDD)) TT to be read by the hearing or speech impaired caller.
- 16 This process can also be reversed with a hearing person calling a deaf
- 17 person through the ((TDD)) telecommunications relay service. "TRS
- 18 program" as used in this chapter includes both the relay function and
- 19 <u>TTs.</u>
- 20 "Qualified trainer" is a person who is knowledgeable about ((TDDs))
- 21 TTs, signal devices, and amplifying accessories; familiar with the
- 22 technical aspects of equipment designed to meet hearing impaired
- 23 people's needs; and is fluent in American sign language.
- 24 "Qualified contractor" shall have ((bilingual)) staff bilingual in
- 25 American sign language and standard English available for quality
- 26 language/cultural interpretations; quality training of operators; and
- 27 policies, training, and operational procedures to be determined by the
- 28 office.
- "The department" means the department of social and health services
- 30 of the state of Washington.

- 1 "Office" means the office of deaf services within the state 2 department of social and health services."
- 3 "Sec. 3. RCW 43.20A.725 and 1990 c 89 s 3 are each amended to read 4 as follows:
- 5 (1) The department shall maintain a program whereby ((TDDs)) <u>TTs</u>,
- 6 signal devices, a ((TDD relay system)) TRS, and amplifying accessories
- 7 capable of serving the needs of the hearing and speech impaired shall
- 8 be provided at no charge additional to the basic exchange rate, to an
- 9 individual of school age or older, (a) who is certified as hearing
- 10 impaired by a licensed physician, audiologist, or a qualified state

(1) The department advisory committee on deafness shall establish a ((TDD)) TRS program advisory committee to oversee operation of the ((TDD)) TRS program. The ((TDD)) TRS program advisory committee shall consist of no more than thirteen individuals representing the hearing

impaired and speech impaired communities, the department, the utilities 1 2 and transportation commission, agencies and services serving the hearing impaired and speech impaired, and local exchange companies in 3 4 the state. The membership on the ((TDD)) TRS program advisory the maximum 5 committee shall, to extent possible, 6 representatives from (a) the major state-wide organizations the hearing impaired and speech impaired, (b) 7 representing organizations for the hearing impaired and speech impaired located in 8 9 areas of the state with high populations of such persons, and (c) 10 organizations that reflect the different geographic regions of the state.
