In January of the year following any year in which a 12 minimum of sixty days of sick leave is accrued, and each January 13 14 thereafter, any eligible employee may receive remuneration for unused 15 sick leave accumulated in the previous year at a rate equal to one day's monetary compensation of the employee for each four full days of 16 17 accrued sick leave in excess of sixty days.
