These policies may include, 17 18 but are not limited to: (1) Requiring a share of the appreciation in 19 the project in proportion to the state's contribution to the project; (2) requiring a lump-sum repayment of the loan or grant upon the sale 20 or change of use of the project; or (3) requiring a deferred payment of 21 principal or principal and interest on loans after a specified time 22 23 period."
- "NEW SECTION. Sec. 16. The director shall monitor the activities of recipients of grants and loans under this chapter to determine compliance with the terms and conditions set forth in its application or stated by the department in connection with the grant or loan."

- 2 to promulgate rules pursuant to chapter 34.05 RCW, regarding the grant
