- 25 beds are not otherwise obligated for replacement; or
- 26 (b) Expiration of a certificate of need.
- 27 (3) The department shall develop procedures for the fair and
- 28 efficient award of beds from the special pool. In making its decisions

- 1 regarding the award of beds from the pool, the department shall
- 2 consider at least the following:
- 3 (a) The relative degree to which the long-term care needs of an
- 4 ethnic minority are not otherwise being met;
- 5 (b) The percentage of low-income persons who would be served by the

- 7 (c) The financial feasibility of the proposed nursing home; and
- 8 (d) The impact of the proposal on the area's total need for nursing

- 10 (4) To be eligible to apply for or receive an award of beds from
- 11 the special pool, an application must be to build a new nursing home,
- 12 or add beds to a nursing home, that:
- 13 (a) Will be owned and operated by a nonprofit corporation, and at
- 14 least fifty percent of the board of directors of the corporation are
- 15 members of the ethnic minority the nursing home is intended to serve;
- 16 (b) Will be designed, managed, and administered to serve the
- 17 special cultural, language, dietary, and other needs of an ethnic
- 18 minority; and
- 19 (c) Will not discriminate in admissions against persons who are not
- 20 members of the ethnic minority whose special needs the nursing home is
- 21 designed to serve.
- 22 (5) If a nursing home or portion of a nursing home that is built as
- 23 a result of an award from the special pool is sold or leased within ten
- 24 years to a party not eligible under subsection (4) of this section:
- 25 (a) The purchaser or lessee may not operate those beds as nursing
- 26 home beds without first obtaining a certificate of need for new beds
- 27 under this chapter; and
- 28 (b) The beds that had been awarded from the special pool shall be
- 29 returned to the special pool.

- 2 before that number of beds are actually in the special pool, provided
- 3 that the number of beds so awarded are subtracted from the total of two
