- 1 AN ACT Relating to transportation safety; adding new sections to
- 2 chapter 46.61 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 46.61 RCW
- 5 to read as follows:
- 6 If a law enforcement officer investigating a violation of RCW
- 7 46.61.370 has reasonable cause to believe that a violation has
- 8 occurred, the officer may request the owner of the motor vehicle to
- 9 supply information identifying the driver of the vehicle at the time
- 10 the violation occurred. When requested, the owner of the motor vehicle
- 11 shall identify the driver to the best of the owner's ability. The
- 12 owner of the vehicle is not required to supply identification
- 13 information to the law enforcement officer if the owner believes the
- 14 information is self-incriminating.

- 1 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 46.61 RCW
- 2 to read as follows:
- 3 (1) The driver of a school bus who observes a violation of RCW
- 4 46.61.370 may prepare a written report on a form provided by the state
- 5 patrol or another law enforcement agency indicating that a violation
- 6 has occurred. The driver of the school bus or a school official may
- 7 deliver the report to a law enforcement officer of the state, county,
- 8 or municipality in which the violation occurred but not more than
- 9 seventy-two hours after the violation occurred. The driver shall
- 10 include in the report the time and location at which the violation
- 11 occurred, the vehicle license plate number, and a description of the
- 12 vehicle involved in the violation.
- 13 (2) The law enforcement officer shall initiate an investigation of
- 14 the reported violation within ten working days after receiving the
- 15 report described in subsection (1) of this section by contacting the
- 16 owner of the motor vehicle involved in the reported violation and
- 17 requesting the owner to supply information identifying the driver. If,
- 18 after an investigation, the law enforcement officer is able to identify
- 19 the driver and has reasonable cause to believe a violation of RCW
- 20 46.61.370 has occurred, the law enforcement officer shall prepare a
- 21 notice of traffic infraction and have it served upon the driver of the
- 22 vehicle.
- NEW SECTION. Sec. 3. By December 1, 1991, the superintendent
- 24 of public instruction shall review the current use of aides on special
- 25 education buses and provide to the education committees of the house of
- 26 representatives and the senate recommended guidelines, with associated
- 27 fiscal impacts, for increasing the use of aides on special education
- 28 buses.
