- 1 AN ACT Relating to specialized transportation for elderly and
- 2 handicapped persons; adding a new chapter to Title 47 RCW; and making
- 3 an appropriation.

State of Washington

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that many elderly
- 6 and handicapped persons are unable to take advantage of the social
- 7 service opportunities made available for them. The legislature further
- 8 finds that the lack of adequate transportation to the social service
- 9 network is a major reason for not using state and local provided
- 10 services.
- It is the intent of the legislature to provide cost-effective,
- 12 efficient transportation services that reduce fragmentation and
- 13 duplication of services in order to delay or preclude the placement of
- 14 individuals in institutional facilities, to improve the quality of life

- 1 of elderly and handicapped citizens, to provide opportunity for
- 2 schooling and employment training programs for the handicapped, and to
- 3 reinforce the coordination of transportation resources.
- 4 <u>NEW SECTION.</u> **Sec. 2.** Unless the context clearly requires
- 5 otherwise, the definitions in this section apply throughout this
- 6 chapter.
- 7 (1) "Specialized transportation services" means providing
- 8 transportation for elderly and handicapped persons to enhance the
- 9 utilization of state and local government services.
- 10 (2) "Coordinated specialized transportation grantee" means an
- 11 entity providing, or arranging for, transportation services to elderly
- 12 and handicapped persons in a manner that is cost-effective and
- 13 efficient and that reduces fragmentation and duplication of services.
- 14 (3) "Elderly" means a person sixty years of age or older.
- 15 (4) "Handicapped" means a person who, by reason of illness, injury,
- 16 age, congenital malfunction, or other permanent or temporary incapacity
- 17 or disability, or other disadvantage, is unable without special
- 18 facilities and services or special planning or design to use mass
- 19 transportation facilities as efficiently as persons who are not so
- 20 affected. Handicapped people include (a) ambulatory persons whose
- 21 capacities are hindered by sensory disabilities such as blindness or
- 22 deafness, mental disabilities such as mental retardation or emotional
- 23 illness, physical disability which still permits the person to walk
- 24 comfortably, or a combination of these disabilities; (b) semiambulatory
- 25 persons who require special aids to travel such as canes, crutches,
- 26 walkers, respirators, or human assistance; (c) nonambulatory persons
- 27 who must use wheelchairs or wheelchair-like equipment to travel; and
- 28 (d) Persons who, because of economic or language-related barriers,
- 29 require specialized services.

- 1 <u>NEW SECTION.</u> **Sec. 3.** The secretary shall adopt rules for
- 2 qualifying specialized transportation services and distributing money
- 3 from the specialized transportation services fund under section 5 of
- 4 this act to the coordinated specialized transportation grantees as
- 5 required under section 4 of this act.
- 6 <u>NEW SECTION.</u> **Sec. 4.** (1) The secretary will distribute money
- 7 to coordinated specialized transportation grantees to arrange and
- 8 coordinate specialized transportation services. The secretary will
- 9 employ a selection process that includes a detailed grant application
- 10 and a showing of actual need.
- 11 (2) The secretary will distribute money to the counties according
- 12 to the following formula:
- (a) No more than fifty percent divided equally among all counties;
- 14 (b) No more than twenty percent based upon the number of elderly
- 15 residents per county as a percentage of the state's elderly population;
- 16 (c) No more than twenty percent based upon the number of
- 17 handicapped residents per county as a percentage of the state's
- 18 handicapped population; and
- 19 (d) No more than ten percent based upon a population density factor
- 20 that recognizes the higher transportation costs in sparsely populated
- 21 counties.
- 22 (3) The secretary is authorized to adopt rules to implement this
- 23 section.
- 24 <u>NEW SECTION.</u> **Sec. 5.** The specialized transportation services
- 25 fund is created in the custody of the state treasurer to be funded by
- 26 legislative appropriation. Expenditures from the fund may be used only
- 27 for operations costs of specialized transportation services for elderly
- 28 and handicapped persons. Only the secretary of transportation or the

- 1 secretary's designee may authorize expenditures from the fund. The
- 2 fund is subject to allotment procedures under chapter 43.88 RCW, but no
- 3 appropriation is required for expenditures.
- 4 <u>NEW SECTION.</u> **Sec. 6.** Sections 1 through 5 of this act shall
- 5 constitute a new chapter in Title 47 RCW.
- 6 <u>NEW SECTION.</u> **Sec. 7.** The sum of ten million dollars, or as
- 7 much thereof as may be necessary, is appropriated for the biennium
- 8 ending June 30, 1993, from the general fund to the specialized
- 9 transportation services fund under section 5 of this act for the
- 10 purposes of this act.
