- 1 AN ACT Relating to faculty salaries in higher education; adding new
- 2 sections to chapter 28B.10 RCW; and creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** It is the intent of the legislature that
- 5 faculty who teach in the state's public colleges and universities be
- 6 paid not less than teachers with equivalent education and experience
- 7 who teach in the state's public kindergarten-through-twelfth-grade
- 8 education system.
- 9 <u>NEW SECTION.</u> **Sec. 2.** Unless the context clearly requires
- 10 otherwise, the definitions in this section apply throughout sections 3
- 11 and 4 of this act.
- 12 (1) "Fiscal period" means fiscal period as defined in RCW
- 13 43.88.020.

- 1 (2) "K-12 salary allocation schedule" means, for any fiscal period,
- 2 the salary allocation schedule, if one exists, that is set forth for
- 3 the public kindergarten-through-twelfth-grade education system in the
- 4 omnibus operating budget appropriations act for that fiscal period,
- 5 after adjusting the schedule to include the state-wide average amount
- 6 that is paid pursuant to local school district supplemental contracts
- 7 during the same fiscal period.
- 8 <u>NEW SECTION.</u> **Sec. 3.** For each fiscal period, the legislature
- 9 shall make appropriations for full-time faculty salaries to each
- 10 regional university, to The Evergreen State College, and to the
- 11 community college system in an amount at least equivalent to the amount
- 12 produced by applying to that institution or system's full-time faculty
- 13 the K-12 salary allocation schedule. The office of financial
- 14 management shall determine the minimum salary funding requirements for
- 15 each institution and system and shall report these amounts to the
- 16 fiscal committees of the house of representatives and senate by
- 17 December 1 of each year.
- 18 <u>NEW SECTION.</u> **Sec. 4.** For each fiscal period, each regional
- 19 university, The Evergreen State College, and the community college
- 20 system shall use salary funds provided by the legislature to ensure
- 21 that each full-time faculty member is paid an amount at least
- 22 equivalent to the amount that member would receive if the member's
- 23 salary were determined using the K-12 salary allocation schedule.
- 24 <u>NEW SECTION.</u> **Sec. 5.** Sections 2 through 4 of this act are
- 25 each added to chapter 28B.10 RCW.
