State of Washington 52nd Legislature 1991 Regular Session

By Representatives Miller, Fraser, Rust, Valle, Roland, Winsley and Dorn; by request of Department of Health.

Read first time February 6, 1991. Referred to Committee on Environmental Affairs.

1 AN ACT Relating to water systems operator certification and
2 registration; and amending RCW 70.119.010, 70.119.020, 70.119.030,
3 70.119.060, 70.119.090, 70.119.100, 70.119.110, and 70.119.130.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 **Sec. 1.** RCW 70.119.010 and 1983 c 292 s 1 are each amended to read
6 as follows:

7 The legislature declares that competent operation of a public water
8 ((supply)) system is necessary for the protection of the consumers'
9 health, and therefore it is of vital interest to the public. In order
10 to protect the public health and conserve and protect the water
11 resources of the state, it is necessary to provide for the classifying
12 of all public water ((supply)) systems; to require the examination and
13 certification of the persons responsible for the technical operation of
14 such systems; and to provide for the promulgation of rules and
15 regulations to carry out this chapter.

1 **Sec. 2.** RCW 70.119.020 and 1983 c 292 s 2 are each amended to read
2 as follows:

3 As used in this chapter unless context requires another meaning:

4 (1) "Board" means the board established pursuant to RCW 70.95B.070
5 which shall be known as the water and waste water operator
6 certification board of examiners.

7 (2) "Certificate" means a certificate of competency issued by the
8 secretary stating that the operator has met the requirements for the
9 specified operator classification of the certification program.

10 (3) "Certified operator" means an individual holding a valid
11 certificate and employed or appointed by any county, water district,
12 municipality, public or private corporation, company, institution,
13 person, or the state of Washington and who is designated by the
14 employing or appointing officials as the person responsible for active
15 daily technical operation.

16 (4) "Department" means the department of ~~((social and))~~ health
17 ~~((services))~~.

18 ~~((4))~~ (5) "Distribution system" means that portion of a public
19 water ~~((supply))~~ system which stores, transmits, pumps and distributes
20 water to consumers.

21 ~~((5))~~ (6) "Ground water under the direct influence of surface
22 water" means water beneath the surface of the ground that is so
23 designated by rule by the department.

24 (7) "Group A water system" means a system with fifteen or more
25 service connections, regardless of the number of people; or a system
26 serving an average of twenty-five or more people per day for sixty or
27 more days within a calendar year, regardless of the number of service
28 connections.

29 (8) "Nationally recognized association of certification
30 authorities" shall mean an organization which serves as an information

1 center for certification activities, recommends minimum standards and
2 guidelines for classification of potable water treatment plants, water
3 distribution systems and waste water facilities and certification of
4 operators, facilitates reciprocity between state programs and assists
5 authorities in establishing new certification programs and updating
6 existing ones.

7 ~~((6)) "Certified operator" means an individual employed or~~
8 ~~appointed by any county, water district, municipality, public or~~
9 ~~private corporation, company, institution, person, or the state of~~
10 ~~Washington who is designated by the employing or appointing officials~~
11 ~~as the person responsible for active daily technical operation.~~

12 ~~(7))~~ (9) "Public water ~~((supply))~~ system" means any ~~((water supply~~
13 ~~system intended or used for human consumption or other domestic uses,~~
14 ~~including source, treatment, storage, transmission and distribution~~
15 ~~facilities where water is furnished to any community or group of~~
16 ~~individuals, or is made available to the public for human consumption~~
17 ~~or domestic use, but excluding all water supply systems serving one~~
18 ~~single family residence)) system, excluding a system serving only one~~
19 ~~single-family residence, providing piped water for human consumption,~~
20 ~~including any collection, treatment, storage, or distribution~~
21 ~~facilities under control of the purveyor and used primarily in~~
22 ~~connection with the system; and collection or pretreatment storage~~
23 ~~facilities not under control of the purveyor but primarily used in~~
24 ~~connection with the system.~~

25 ~~((8))~~ (10) "Purification plant" means that portion of a public
26 water ~~((supply))~~ system which treats or improves the physical, chemical
27 or bacteriological quality of the system's water to bring the water
28 into compliance with state board of health standards.

29 ~~((9))~~ (11) "Secretary" means the secretary of the department of
30 ~~((social and))~~ health ~~((services)).~~

1 (12) "Service" means a connection to a public water system designed
2 to serve a single-family residence, dwelling unit, or equivalent use.
3 If the facility has group home or barracks-type accommodations, three
4 persons will be considered equivalent to one service.

5 (13) "Surface water" means all water open to the atmosphere and
6 subject to surface runoff.

7 **Sec. 3.** RCW 70.119.030 and 1983 c 292 s 3 are each amended to read
8 as follows:

9 ~~((All public water supply systems which serve either))~~ A public
10 water system shall have a certified operator if:

11 (a) The system serves one hundred or more services in use at any
12 one time; or

13 ~~((Twenty five or more persons which are supplied from a stream,~~
14 ~~lake or other surface water supply source and which are required by law~~
15 ~~to use a water filtration system;~~

16 ~~are required to have a certified operator))~~ It is a group A water
17 system using a surface water source or a ground water source under the
18 direct influence of surface water.

19 (2) The certified operators shall be in charge of the technical
20 direction of a water system's operation, or an operating shift of such
21 a system, or a major segment of a system necessary for monitoring or
22 improving the quality of water. The operator shall be certified as
23 provided in RCW 70.119.050.

24 ~~((+2))~~ (3) The amount of time that a certified operator shall be
25 required to be present shall be based upon the time required to
26 properly operate and maintain the public water ~~((supply))~~ system as
27 designed and constructed in accordance with RCW 43.20.050. The
28 employing or appointing officials shall designate the position or
29 positions requiring mandatory certification within their individual

1 systems and shall assure that such certified operators are responsible
2 for the system's technical operation.

3 ~~((3))~~ (4) Operators not required to be certified by this chapter
4 are encouraged to become certified on a voluntary basis.

5 **Sec. 4.** RCW 70.119.060 and 1977 ex.s. c 99 s 6 are each amended to
6 read as follows:

7 The secretary shall further categorize all public water ~~((supply))~~
8 systems with regard to the size, type, source of water, and other
9 relevant physical conditions affecting purification plants and
10 distribution systems to assist in identifying the skills, knowledge and
11 experience required for the certification of operators for each
12 category of such systems.

13 **Sec. 5.** RCW 70.119.090 and 1983 c 292 s 7 are each amended to read
14 as follows:

15 Certificates shall be issued without examination under the
16 following conditions:

17 (1) Certificates shall be issued without application fee to
18 operators who, on ~~((the effective date of this act))~~ January 1, 1978,
19 hold certificates of competency attained under the voluntary
20 certification program sponsored jointly by the state department of
21 social and health services, health services division, and the Pacific
22 Northwest section of the American water works association.

23 (2) Certification shall be issued to persons certified by a
24 governing body or owner of a public water ~~((supply))~~ system to have
25 been the operators of a purification plant or distribution system on
26 ~~((the effective date of this chapter))~~ January 1, 1978, but only to
27 those who are required to be certified under RCW 70.119.030(1). A

1 certificate so issued shall be valid for operating any plant or system
2 of the same classification and same type of water source.

3 (3) A nonrenewable certificate, temporary in nature, may be issued
4 to an operator for a period not to exceed twelve months to fill a
5 vacated position required to have a certified operator. Only one such
6 certificate may be issued subsequent to each instance of vacation of
7 any such position.

8 **Sec. 6.** RCW 70.119.100 and 1987 c 75 s 11 are each amended to read
9 as follows:

10 The issuance and renewal of a certificate shall be subject to the
11 following conditions:

12 (1) Except as provided in RCW 70.119.090, a certificate shall be
13 issued if the operator has satisfactorily passed a written examination,
14 has paid the department an application fee as established by the
15 department under RCW ~~((43.20B.110))~~ 43.70.110, and has met the
16 requirements specified in the rules and regulations as authorized by
17 this chapter.

18 ~~((The terms for all certificates shall be for one year from the
19 date of issuance.))~~ Every certificate shall be renewed annually upon
20 the payment of a fee as established by the department under RCW
21 ~~((43.20B.110))~~ 43.70.110 and satisfactory evidence is presented to the
22 secretary that the operator has fulfilled the continuing education
23 requirements as prescribed by rule of the department.

24 (3) The secretary shall notify operators who fail to renew their
25 certificates before the end of the ~~((certificate))~~ year that their
26 certificates are temporarily valid for two months following the end of
27 the certificate year. Certificates not renewed during the two month
28 period shall be invalid and the secretary shall so notify the holders
29 of such certificates.

1 (4) An operator who has failed to renew a certificate pursuant to
2 the provisions of this section, may reapply for certification and the
3 secretary may require the operator to meet the requirements established
4 for new applicants.

5 **Sec. 7.** RCW 70.119.110 and 1983 c 292 s 9 are each amended to read
6 as follows:

7 The secretary may, with the recommendation of the board and after
8 hearing before the same, revoke a certificate found to have been
9 obtained by fraud or deceit; or for gross negligence in the operation
10 of a purification plant or distribution system; or for an intentional
11 violation of the requirements of this chapter or any lawful rules,
12 order, or regulation of the department. No person whose certificate is
13 revoked under this section shall be eligible to apply for a certificate
14 for ~~((six months))~~ one year from the effective date of the final order
15 of revocation.

16 **Sec. 8.** RCW 70.119.130 and 1983 c 292 s 10 are each amended to
17 read as follows:

18 ~~((On or after one year following the effective date of this act,))~~
19 Any person, including any operator or any firm, association,
20 corporation, municipal corporation, or other governmental subdivision
21 or agency who, after thirty days' written notice, operates a public
22 water ~~((supply))~~ system which is not in compliance with RCW
23 70.119.030(1), shall be guilty of a misdemeanor. Each month of such
24 operation out of compliance with RCW 70.119.030(1) shall constitute a
25 separate offense. Upon conviction, violators shall be fined an amount
26 not exceeding one hundred dollars for each offense. It shall be the
27 duty of the prosecuting attorney or the attorney general, as
28 appropriate to secure injunctions of continuing violations of any

1 provisions of this chapter or the rules and regulations adopted
2 hereunder: PROVIDED, That, except in the case of fraud, deceit, or
3 gross negligence under RCW 70.119.110, no revocation, citation or
4 charge shall be made under RCW 70.119.110 and 70.119.130 until a proper
5 written notice of violation is received and a reasonable opportunity
6 for correction has been given.
