## HOUSE BILL 1899

State of Washington 52nd Legislature 1991 Regular Session

Read first time February 14, 1991. Referred to Committee on Judiciary.

- AN ACT Relating to grandparents' rights; amending RCW 26.09.240;
- 2 adding a new section to chapter 26.10 RCW; adding a new section to
- 3 chapter 13.34 RCW; and creating a new section.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The extended family unit is a
- 6 fundamental resource of family life which should be encouraged.
- 7 Nurturing the relationship between grandparents and children who have
- 8 developed and maintained strong relationships is in the best interests
- 9 of the children, the grandparents, and the state. Grandparents'
- 10 relationships with their grandchildren are frequently severed or
- 11 impaired when the parents of the child get divorced or their parental
- 12 rights are terminated. In furtherance of the goal of nurturing
- 13 extended family relationships, the legislature finds that grandparents'
- 14 requests for custody and visitation should be given preference over
- 15 nonparent third parties who may seek custody or visitation unless the

- 1 court finds that such preference is not in the best interests of the
- 2 child. Additionally, grandparents' desires to maintain contact with
- 3 their grandchildren after divorce should be honored.
- 4 NEW SECTION. Sec. 2. A new section is added to chapter 26.10 RCW
- 5 to read as follows:
- 6 In an action under this chapter, the court shall give custodial
- 7 preference to the natural or adoptive grandparents over other nonparent
- 8 third parties, unless the court expressly finds that giving custodial
- 9 preference to a grandparent is not in the best interests of the child.
- 10 If both the maternal and paternal grandparents seek custody, then the
- 11 court shall determine custody and visitation rights in accordance with
- 12 the best interests of the child under RCW 26.10.100.
- 13 Sec. 3. RCW 26.09.240 and 1989 c 375 s 13 are each amended to read
- 14 as follows:
- 15 The court may order visitation rights for a person other than a
- 16 parent when visitation may serve the best interest of the child whether
- 17 or not there has been any change of circumstances.
- 18 A person other than a parent may petition the court for visitation
- 19 rights at any time.
- 20 The court shall, upon petition, grant the natural or adoptive
- 21 grandparents visitation rights unless the court affirmatively finds
- 22 that grandparental visitation rights would not be in the best interests
- 23 of the child.
- 24 The court may modify an order granting or denying visitation rights
- 25 whenever modification would serve the best interests of the child.

- 1 <u>NEW SECTION.</u> **Sec. 4.** A new section is added to chapter 13.34 RCW
- 2 to read as follows:
- 3 The department of social and health services shall give preference
- 4 to a dependent child's grandparents' request for temporary custody, or
- 5 adoption, of the child over the requests of a third party, unless the
- 6 department specifically finds that honoring the grandparents' request
- 7 will not be in the best interests of the child.
