- 1 AN ACT Relating to assault of wildlife agents and other law
- 2 enforcement officers; and adding a new section to chapter 77.16 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. Sec. 1. A new section is added to chapter 77.16 RCW
- 5 to read as follows:
- 6 (1) The director shall revoke all licenses and privileges extended
- 7 under Title 77 RCW of a person convicted of assault on a state wildlife
- 8 agent or other law enforcement officer that is assisting the agent,
- 9 provided that:
- 10 (a) The wildlife agent or other law enforcement officer that was
- 11 assisting the agent was on duty at the time of the assault; and
- 12 (b) The wildlife agent or other law enforcement officer that was
- 13 assisting the agent was enforcing the provisions of Title 77 RCW.
- 14 (2) For the purposes of this section, the definition of assault
- 15 includes:

- 1 (a) RCW 9A.32.030; murder in the first degree;
- 2 (b) RCW 9A.32.050; murder in the second degree;
- 3 (c) RCW 9A.32.060; manslaughter in the first degree;
- 4 (d) RCW 9A.32.070; manslaughter in the second degree;
- 5 (e) RCW 9A.36.011; assault in the first degree;
- 6 (f) RCW 9A.36.021; assault in the second degree; and
- 7 (g) RCW 9A.36.031; assault in the third degree.
- 8 (3) For the purposes of this section, a conviction includes:
- 9 (a) A determination of guilt by the court;
- 10 (b) The entering of a guilty plea to the charge or charges by the
- 11 accused;
- 12 (c) A forfeiture of bail or a vacation of bail posted to the court;
- 13 or
- 14 (d) The imposition of a deferred or suspended sentence by the
- 15 court.
- 16 (4) No license described under Title 77 RCW shall be reissued to a
- 17 person violating this section for a minimum of ten years, at that time
- 18 a person may petition the director of wildlife for a reinstatement of
- 19 his or her license or licenses. Upon review by the director, and if
- 20 all provisions of the court that imposed sentencing have been
- 21 completed, the director may reinstate in whole or in part the licenses
- 22 and privileges under Title 77 RCW.
