HOUSE BILL 2181

State of Washington 52nd Legislature 1991 Regular Session

- 1 AN ACT Relating to a Washington timberlands foundation; adding a
- 2 new chapter to Title 43 RCW; creating a new section; and making an
- 3 appropriation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds and declares that
- 6 the social and economic implications of recent declines from expected
- 7 timber harvest schedules resulting from the preservation of northern
- 8 spotted owl habitat constitutes an immediate threat to timber
- 9 communities.
- 10 The legislature acknowledges that the logging community is
- 11 distinguished by an unusual commitment to individualism, hard work,
- 12 inventiveness, and entrepreneurial spirit.
- 13 A social contract has been broken, and with it the fabric of a
- 14 unique community. Social and cultural disruptions are caused by the
- 15 severe stress of job loss, a loss of trust in assured government timber

- 1 supplies, and a feeling of disenfranchisement while the political
- 2 conflict over fundamental social values continues.
- 3 The well-being of the citizens who lives in timber-dependent
- 4 regions is in acute peril, jeopardizing not only the quality of life
- 5 for those residing in the timberlands, but also the continued viability
- 6 of the timberlands themselves, in which human beings play an important
- 7 and integral role as managers and beneficiaries.
- 8 New ways must be found to ensure the survival of the timberlands'
- 9 way of life while, at the same time, building the foundation for a new
- 10 economy and a lifestyle that is both sustainable and personally
- 11 rewarding. The current strains on the timberlands' economies and the
- 12 harsh stresses being experienced by the timberlands' people, make it
- 13 necessary for the legislature to take immediate, comprehensive, and
- 14 long-lasting action.
- 15 <u>NEW SECTION.</u> **Sec. 2.** This chapter shall be known as the
- 16 timberlands revitalization act.
- 17 <u>NEW SECTION.</u> **Sec. 3.** Unless the context clearly requires
- 18 otherwise, the definitions in this section apply throughout this
- 19 chapter.
- 20 (1) "Timberlands" means a region of the state, as determined by
- 21 economic census data, where timber harvesting is the dominant economic
- 22 activity.
- 23 (2) "Industry council" means a local, nongovernmental, and
- 24 voluntary association of business and labor entities whose purpose is
- 25 to organize and sustain working relationships that are mutually
- 26 beneficial and beneficial to the economic health of the domestic
- 27 economy.

- 1 (3) "Community congress" means a local, nongovernmental, and
- 2 voluntary association of community interests established prior to or
- 3 pursuant to this chapter and intended to stimulate local initiative in
- 4 the attainment of local goals.
- 5 (4) "Network economy" means an economy of indigenous local
- 6 enterprises who contribute to each others' success as mutual buyers and
- 7 sellers of essential products and services.
- 8 <u>NEW SECTION.</u> **Sec. 4.** There is hereby established the
- 9 timberlands foundation. The foundation is responsible for achieving
- 10 and sustaining a high quality of life in Washington's timberlands
- 11 region. The foundation shall:
- 12 (1) Assist in transforming the local economy from one dependent on
- 13 primary wood products to a network economy based on a mix of primary
- 14 wood products, value-added wood products, and secondary manufacturing
- 15 of wood products; the design and manufacture of other products,
- 16 including so-called high technology industry; ecological husbandry;
- 17 aquaculture; crafts; local wholesale and retail activity; education and
- 18 cultural activity; tourism; trade; and other indigenous economic
- 19 activity;
- 20 (2) Encourage the substitution, wherever possible, of sustainable
- 21 agriculture and other economic activities, including silviculture, for
- 22 harvest activities that remove vital resources from the domestic
- 23 ecology and economy; and the preservation and replenishment of
- 24 ecological features essential to the character of the region and its
- 25 enjoyment by residents and visitors alike;
- 26 (3) Invest in enterprises in the region that are complementary to
- 27 the goals of the foundation, especially enterprises that have a strong
- 28 local component and which contribute to a local economy that is self-
- 29 directed and independent from influences outside the region;

- 1 (4) Stimulate a vital regional cultural life, including strong,
- 2 responsive educational institutions, that builds a strong sense of
- 3 personal identity and community among residents of the timberlands and
- 4 creates opportunities for timberlands residents to express this sense
- 5 of identity and community; and
- 6 (5) Act as an advocate for the interests of the people of the
- 7 region in councils of the state and before the federal government.
- 8 <u>NEW SECTION.</u> **Sec. 5.** The foundation shall be governed by a
- 9 board of directors.
- 10 (1) The board of directors shall be comprised of seven persons who
- 11 shall serve for four years.
- 12 (a) The initial board shall be appointed by the governor and the
- 13 legislature. Three members shall be appointed by the governor, two by
- 14 the speaker of the house of representatives, and two by the president
- 15 pro tem of the senate. Each of the persons appointed to the board
- 16 shall be a resident of the timberlands and have experience in economic,
- 17 civic, or cultural affairs relevant to the needs of the timberlands.
- 18 In making these appointments, the governor, speaker of the house of
- 19 representatives, and president pro tem of the senate shall seek to
- 20 appoint persons who represent the diverse complexion, by age, race,
- 21 sex, occupation, and interests, of the population of the timberlands;
- 22 and
- 23 (b) Subsequent boards shall be directly elected by the people of
- 24 the timberlands. The procedures for this election shall be set forth
- 25 by the legislature.
- 26 (2) The board of directors shall be compensated as directed by the
- 27 legislature.
- 28 (3) The board of directors shall appoint an executive director, who
- 29 shall serve at the pleasure of the board, to manage the activities of

- 1 the foundation. The executive director may hire additional staff to
- 2 assist in the conduct of his or her management, subject to the approval
- 3 of the board of directors.
- 4 NEW SECTION. Sec. 6. The foundation shall:
- 5 (1) Develop, in consultation with local and state agencies, crisis
- 6 relief programs, including programs for mortgage and debt assistance,
- 7 educational opportunity, and family centers, to mitigate the immediate
- 8 stresses experienced by families and individuals in the timberlands who
- 9 have been victimized by catastrophic changes in the local economy.
- 10 (a) These programs shall be coordinated with existing programs
- 11 intended to provide relief to the people of the timberlands; and
- 12 (b) To the greatest extent possible, the foundation shall transfer
- 13 responsibility for these programs to the residents of the timberlands.
- 14 (2) Investigate and promote indigenous, autonomous economic
- 15 activity based on value-added industry and local enterprises that
- 16 create diversity economic development.
- 17 (a) The foundation shall conduct studies of the timberlands local
- 18 economies to determine:
- 19 (i) Where industry is nonindigenous, nonsustainable, or
- 20 contributory to economic leakages from the region; and how this
- 21 industry might be transformed into or replaced by industry, including
- 22 silviculture, that is indigenous, sustainable, and contributory to
- 23 continuous economic development;
- 24 (ii) How a network-based economy emphasizing linkages among
- 25 indigenous enterprises can be developed and sustained; and
- 26 (iii) Those educational and other resources supplied by the state
- 27 and local agencies that are required to provide a hospitable
- 28 environment for a healthy local economy and civic life.

- 1 (b) The foundation is empowered to invest in local enterprises
- 2 whose successes will contribute to the attainment of the goals set
- 3 forth for the foundation in this chapter by making investment grants to
- 4 these enterprises. These investment grants shall be low or no-interest
- 5 loans, as determined by the legislature.
- 6 (i) These investment grants shall be labor-enhancing or shall
- 7 create new jobs. In no case shall these investment grants be used to
- 8 enable industrial processes that result in a replacement of labor
- 9 without the creation of accompanying jobs of an equal or higher quality
- 10 than those that would be replaced.
- 11 (ii) Such investments shall be targeted to produce a diverse
- 12 economy based on a mix of primary wood products, value-added wood
- 13 products, and secondary manufacturing of wood products; the design and
- 14 manufacture of other products, including so-called high technology
- 15 industry; ecological husbandry; aquaculture; crafts; local wholesale
- 16 and retail activity; education and cultural activity; tourism; trade;
- 17 and other indigenous economic activity. Whenever appropriate, the
- 18 foundation shall consult with the recipients of investment grants to
- 19 develop overseas markets for the products or services that they
- 20 produce.
- 21 (iii) These investments shall occur only in response to formal
- 22 application for funding submitted to the foundation, according to a
- 23 process established by the foundation, and subject to the scrutiny of
- 24 business, labor, and environmental representatives, and others
- 25 determined by the legislature to hold a stake in the successful outcome
- 26 of these investments.
- 27 (iv) The foundation shall establish a network of agents to assist
- 28 in identifying opportunities for, and promoting, network economies and
- 29 other economic activity that enables the foundation to achieve the
- 30 goals set forth in this chapter. These agents shall promote the

- 1 creation of local industry councils capable of coordinating local
- 2 economic activity and building favorable relationships among
- 3 enterprises.
- 4 (3) Enhance the educational, cultural, and civic life of the
- 5 region. To this end the foundation shall:
- 6 (a) Work with the University of Washington, Washington State
- 7 University, Western Washington University, The Evergreen State College,
- 8 and other educational institutions in the region to improve educational
- 9 opportunities in the timberlands;
- 10 (b) Study and work for the establishment of a four-year technical
- 11 institution of higher education in the southern timberlands, for the
- 12 purpose of training and retraining residents in the region's new
- 13 occupations. This institution and Western Washington University shall
- 14 endeavor to train local residents in professions of immediate relevance
- 15 to the timberlands, including but not limited to silviculture and
- 16 forestry, marine studies, business administration, tourism, medicine
- 17 and nursing, and teaching;
- 18 (c) Award fellowships and grants for graduate and postgraduate work
- 19 in degrees and research projects relating, but not limited, to timber
- 20 issues;
- 21 (d) Make grants for local educational, cultural, and recreational
- 22 activities, including artistic expressions, that contribute to a sense
- 23 of personal identity and community in the timberlands. Team efforts
- 24 are favored over individual efforts in the conduct of these activities;
- 25 (e) Encourage and support the creation and activation of community
- 26 congresses in communities throughout the timberlands. A community
- 27 congress shall be the nexus where local governments, school districts,
- 28 business, labor, and volunteer groups can collaborate in the solution
- 29 of local problems and the accomplishment of local goals; and

- 1 (f) Establish an extension service for promoting educational,
- 2 cultural, and civic opportunities within the structures and
- 3 institutions set forth by this chapter.
- 4 (4) Study and promote new methods of revitalizing life in the
- 5 timberlands. These methods shall include but not be limited to:
- 6 (a) Stimulating conditions favorable to the investment of capital
- 7 in the region;
- 8 (b) Determining the comparative advantages of the region vis-a-vis
- 9 other regions in the global economy and means for their exploitation;
- 10 and
- 11 (c) Examining and promoting the use of new technologies, including
- 12 but not limited to telecommunications and information technology, new
- 13 silviculture and forest management technology, value-added and
- 14 secondary manufacturing technology, transportation technology, and
- 15 aquaculture technology, that can contribute to a vibrant and
- 16 sustainable local economy.
- 17 (5) The foundation shall annually report to the legislature and the
- 18 governor on its activities and make recommendations for legislation
- 19 essential to the foundation meeting the goals set forth in this
- 20 chapter.
- 21 <u>NEW SECTION.</u> **Sec. 7.** The sum of dollars, or as
- 22 much thereof as may be necessary, is appropriated for the biennium
- 23 ending June 30, 1993, from the budget stabilization account under RCW
- 24 43.88.525 to the board of directors of the timberlands foundation, for
- 25 the purposes of this act.
- 26 <u>NEW SECTION.</u> **Sec. 8.** Sections 2 through 6 of this act shall
- 27 constitute a new chapter in Title 43 RCW.
