- 1 AN ACT Relating to education; and amending RCW 28A.505.050 and
- 2 28A.505.060.

State of Washington

- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 28A.505.050 and 1990 c 33 s 417 are each amended to
- 5 read as follows:
- 6 Upon completion of their budgets as provided in RCW 28A.505.040,
- 7 every school district shall publish a notice stating that the district
- 8 has completed the budget ((and placed the same)) which is on file in
- 9 the school district administration office, that a copy ((thereof)) will
- 10 be furnished any person who will call upon the district for it, and
- 11 that the board of directors will meet for the purpose of fixing and
- 12 adopting the budget of the district for the ensuing fiscal year.
- 13 ((Such)) The notice shall designate the date, time, and place of
- 14 ((said)) the meeting which shall occur no later than the thirty-first

- 1 day of August for first class school districts, and the first day of
- 2 August for second class school districts. The notice shall also state
- 3 that any person may appear ((thereat)) at the meeting and be heard for
- 4 or against any part of such budget. ((Said)) The notice shall be
- 5 published at least once each week for two consecutive weeks in a
- 6 newspaper of general circulation in the district, or, if ((there be))
- 7 none, in a newspaper of general circulation in the county or counties
- 8 in which ((such)) the district is a part. The last notice shall be
- 9 published no later than seven days immediately prior to the hearing.
- 10 The district shall provide a sufficient number of copies of the
- 11 budget to meet the reasonable demands of the public not later than July
- 12 20th in the first class school districts, and not later than July 15th
- 13 in second class school districts. School districts shall submit one
- 14 copy of their budget to their educational service districts for review
- 15 and comment by these dates. A copy of the notice also shall be sent to
- 16 the chairperson of all Indian education committees within the school
- 17 <u>district.</u>
- 18 **Sec. 2.** RCW 28A.505.060 and 1990 c 33 s 418 are each amended to
- 19 read as follows:
- 20 On the date given in ((said)) the notice as provided in RCW
- 21 28A.505.050 the school district board of directors shall meet at the
- 22 time and place designated. Any person may appear ((thereat and)) at
- 23 the meeting to be heard for or against any part of such budget.
- 24 ((Such)) The hearing may be continued not to exceed a total of two
- 25 days((: PROVIDED, That)). However, the budget must be adopted no
- 26 later than August 31st in first class school districts, and not later
- 27 than August 1st in second class school districts.
- 28 Upon conclusion of the hearing, the board of directors shall fix
- 29 and determine the appropriation from each fund contained in the budget

separately, and shall by resolution adopt the budget and the 1 appropriations as so finally determined, and enter the same in the 2 official minutes of the board((: PROVIDED, That)). The first class 3 4 school districts shall file copies of their adopted budget with their educational service district no later than September 3rd, and second 5 6 class school districts shall forward copies of their adopted budget to their educational service district no later than August 3rd, for 7 review, alteration and approval as provided for in RCW 28A.505.070 by 8 9 the budget review committee. <u>Indian parent education committees</u>, and 10 other individuals and groups, may notify the superintendent of public instruction of concerns regarding the school district's budget, 11 whereupon the superintendent shall work with the school district and 12 the respective individuals or groups to address the identified 13 14 concerns.
