- AN ACT Relating to higher education; and amending RCW 28B.10.710
- 2 and 28B.80.350.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 28B.10.710 and 1969 ex.s. c 223 s 28B.10.710 are each
- 5 amended to read as follows:
- 6 There shall be a one quarter or semester course in either
- 7 Washington state history and government, or Pacific Northwest history
- 8 and government in the curriculum of all teachers' colleges and
- 9 teachers' courses in all institutions of higher education. No person
- 10 shall be graduated from any of said schools without completing said
- 11 course of study, unless otherwise determined by the state board of
- 12 education. Any course in Washington state or Pacific Northwest history
- 13 and government used to fulfill this requirement shall include
- 14 information on the culture, history, and government of the American

- 1 Indian peoples who were the first human inhabitants of the state and
- 2 the region.
- 3 Sec. 2. RCW 28B.80.350 and 1988 c 172 s 4 are each amended to read
- 4 as follows:
- 5 The board shall coordinate educational activities among all
- 6 segments of higher education taking into account the educational
- 7 programs, facilities, and other resources of both public and
- 8 independent two and four-year colleges and universities. The four-year
- 9 institutions and the state board for community college education shall
- 10 coordinate information and activities with the board. The board shall
- 11 have the following additional responsibilities:
- 12 (1) Promote interinstitutional cooperation;
- 13 (2) Establish minimum admission standards for four-year
- 14 institutions, including a requirement that coursework in sign language
- 15 <u>or an American Indian language</u> shall satisfy any ((foreign language))
- 16 requirement for instruction in a language other than English that the
- 17 board or the institutions may establish as a general undergraduate
- 18 admissions requirement;
- 19 (3) Establish transfer policies;
- 20 (4) Adopt rules implementing statutory residency requirements;
- 21 (5) Develop and administer reciprocity agreements with bordering
- 22 states and the province of British Columbia;
- 23 (6) Review and recommend compensation practices and levels for
- 24 administrative employees, exempt under chapter 28B.16 RCW, and faculty
- 25 using comparative data from peer institutions;
- 26 (7) Monitor higher education activities for compliance with all
- 27 relevant state policies for higher education;
- 28 (8) Arbitrate disputes between and among four-year institutions or
- 29 between and among four-year institutions and community colleges at the

- 1 request of one or more of the institutions involved, or at the request
- 2 of the governor, or from a resolution adopted by the legislature. The
- 3 decision of the board shall be binding on the participants in the
- 4 dispute;
- 5 (9) Establish and implement a state system for collecting,
- 6 analyzing, and distributing information;
- 7 (10) Recommend to the governor and the legislature ways to remove
- 8 any economic incentives to use off-campus program funds for on-campus
- 9 activities; and
- 10 (11) Make recommendations to increase minority participation, and
- 11 monitor and report on the progress of minority participation in higher
- 12 education.
