
HOUSE BILL 2786

State of Washington 52nd Legislature 1992 Regular Session

1 AN ACT Relating to purchase of Columbia river/ Willapa Bay/ Grays
2 Harbor commercial salmon licenses; adding new sections to Title 75 RCW;
3 and providing an effective date.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

5 NEW SECTION. **Sec. 1.** The director shall develop a program for
6 the purchase and permanent retirement of Columbia river/ Willapa Bay
7 and Columbia river/ Grays Harbor commercial salmon fishing licenses.
8 The director shall administer the program in three phases. The program
9 shall be subject to funding and the program shall not begin until full
10 funding was available for all three phases.

11 The director shall solicit funding from all potential funding
12 sources for the purpose of sections 1 through 6 of this act.

1 NEW SECTION. **Sec. 2.** Phase one of the fishing license buy-out
2 plan established in section 1 of this act shall be conducted as
3 follows:

4 (1) A mandatory purchase of all licenses that have not landed
5 either:

6 (a) One thousand pounds of salmon in Washington in each of the
7 years of 1991, 1990, 1989, 1988, 1987; or

8 (b) Two thousand five hundred pounds of salmon in Washington during
9 1990 and 1991.

10 (2) Phase one license purchases shall be at five thousand dollars
11 each.

12 (3) Licensees may appeal to the director to waive the landing
13 requirement in subsection (1) of this section on the grounds of illness
14 or an unforeseen emergency. The director may review the appeals or
15 establish an advisory board to hear the appeals under RCW 75.30.050.

16 (4) Licenses purchased in phase one shall be permanently retired
17 from the fishing fleet.

18 (5) After phase one is completed, no minimum poundage requirements
19 are necessary for license renewal.

20 (6) No additional vessel operators are allowed during phase one.

21 NEW SECTION. **Sec. 3.** Phase two of the license buy-out plan
22 established in section 1 of this act shall begin after phase one is
23 completed and shall be in effect no longer than ninety days.

24 (1) All purchases of licenses in phase two shall be strictly
25 voluntary. The licensees shall be afforded the opportunity to sell
26 their licenses on a willing basis.

27 (2) The price of licenses purchased in phase two shall be fifty
28 thousand dollars for Columbia river/ Grays Harbor licenses, fifty
29 thousand dollars for Columbia river/ Willapa Bay licenses, and seventy-

1 five thousand dollars for Columbia river/ Grays Harbor/ Willapa Bay
2 licenses.

3 (3) Licenses purchased in phase two shall be permanently retired
4 from the fishing fleet.

5 (4) No minimum poundage requirements are in effect in phase two.

6 (5) No additional vessel operators are allowed in phase two.

7 NEW SECTION. **Sec. 4.** Phase three of the buy-out plan
8 established in section 1 of this act shall begin after phase two has
9 ended and shall be in effect until the entire gillnet fleet is reduced
10 to one hundred twenty-five Columbia river/ Willapa Bay licenses and
11 seventy-five Columbia River/ Grays Harbor licenses.

12 Phase three shall be conducted in the following manner:

13 (1) A voluntary purchase of licenses on the basis of ten thousand
14 dollars for a Columbia river/ Grays Harbor license, ten thousand
15 dollars for a Columbia river/ Willapa Bay license, and thirty thousand
16 dollars for a Columbia river/ Grays Harbor/ Willapa Bay license.

17 (2) The total number of Columbia river/ Grays harbor and Columbia
18 river/ Willapa Bay licenses shall not be allowed to drop below one
19 hundred fifty licenses.

20 (3) No minimum poundage requirements are in effect during and after
21 phase three.

22 (4) Licenses purchased in phase three shall be permanently retired
23 from the fishing fleet.

24 (5) When the number of licenses reaches two hundred, additional
25 vessel operators may be added.

26 NEW SECTION. **Sec. 5.** Columbia river/ Grays Harbor, Columbia
27 river/ Willapa Bay, and Columbia river/ Grays Harbor/ Willapa Bay
28 salmon gillnet licenses are freely transferable.

1 NEW SECTION. **Sec. 6.** The salmon catch division between non-
2 Indian commercial and recreational fisheries shall not change from
3 historical levels experienced in the 1980-1991 time period as a result
4 of sections 1 through 6 of this act.

5 NEW SECTION. **Sec. 7.** Sections 1 through 6 of this act are
6 each added to Title 75 RCW.

7 NEW SECTION. **Sec. 8.** If any provision of this act or its
8 application to any person or circumstance is held invalid, the
9 remainder of the act or the application of the provision to other
10 persons or circumstances is not affected.

11 NEW SECTION. **Sec. 9.** This act shall take effect January 1,
12 1993.
