- 1 AN ACT Relating to local government; amending RCW 14.08.304,
- 2 17.10.050, 17.28.140, 27.12.190, 28A.320.050, 35.17.108, 35.18.220,
- 3 35.22.200, 35.22.205, 35.23.220, 35.24.090, 35.27.130, 35.58.160,

- 13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

- 1 Sec. 1. RCW 14.08.304 and 1979 ex.s. c 126 s 3 are each amended to 2 read as follows:
- 3 The board of airport district commissioners shall consist of three members, who ((shall each be a)) are registered voters and ((actually 4 a)) residents of the district. The first commissioners shall be 5 6 appointed by the county legislative authority. At the next general district election, held as provided in RCW 29.13.020, three airport 7 district commissioners shall be elected. The term of office of airport 8 9 district commissioners shall be two years, or until their successors 10 are elected and qualified and have assumed office in accordance with RCW 29.04.170. Members of the board of airport district commissioners 11 shall be elected at each regular general election on a nonpartisan 12 13 basis. ((They shall be nominated by petition of ten registered voters 14 of the district.)) Vacancies on the board of airport district commissioners shall be filled by appointment by the remaining 15 commissioners. Members of the board of airport district commissioners 16 17 shall receive no compensation for their services, but ((shall be reimbursed for actual necessary traveling and sustenance expenses 18 19 incurred while engaged on official business)) are entitled to 20 reimbursement for reasonable expenses actually incurred in connection with official business, including subsistence and lodging while away 21 from his or her place of residence, and mileage for use of a privately 22
- NEW SECTION. Sec. 2. A new section is added to chapter 17.04 RCW to read as follows:

- The directors of a weed district shall receive no compensation for their services, except that a director who is appointed to act as

- 5 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 17.06 RCW
- 6 to read as follows:
- 7 The directors of an intercounty weed district shall receive no
- 8 compensation for their services, except that a director who is
- 9 appointed to act as secretary may be compensated in accordance with RCW
- 10 17.06.050. The directors are entitled to reimbursement for reasonable
- 11 expenses actually incurred in connection with official business,
- 12 including subsistence and lodging while away from his or her place of
- 13 residence, and mileage for use of a privately owned vehicle, in
- 14 accordance with chapter 42.24 RCW.
- 15 **Sec. 4.** RCW 17.10.050 and 1987 c 438 s 4 are each amended to read
- 16 as follows:
- 17 (1) Each activated county noxious weed control board shall consist
- 18 of five voting members ((who shall be)) appointed by the county
- 19 legislative authority. In appointing such voting members, the county
- 20 legislative authority shall divide the county into five sections, none
- 21 of which shall overlap and each of which shall be of the same
- 22 approximate area, and shall appoint a voting member from each section.
- 23 At least four of the voting members shall be engaged in the primary
- 24 production of agricultural products. There shall be one nonvoting
- 25 member on such board who shall be the chief county extension agent or
- 26 an extension agent appointed by the chief county extension agent. Each
- 27 voting member of the board shall serve a term of four years, except
- 28 that the county legislative authority shall, when a board is first

- 1 activated under this chapter, designate two voting members to serve
- 2 terms of two years. The board members shall not receive a salary but
- 3 ((shall be compensated for actual and necessary expenses incurred in
- 4 the performance of their official duties)) are entitled to
- 5 reimbursement for reasonable expenses actually incurred in connection
- 6 with official business, including subsistence and lodging while away
- 7 from his or her place of residence, and mileage for use of a privately

- Notice of expiration of a term of office shall be published at
- 16 least twice in a weekly or daily newspaper of general circulation in
- 17 ((said)) the section with last publication occurring at least ten days
- 18 prior to the nomination. All persons interested in appointment to the
- 19 board and residing in the section with a pending nomination shall make
- 20 a written application ((that includes the signatures of at least ten
- 21 registered voters residing in the section supporting the nomination))
- 22 to the county noxious weed control board. After nominations close, the
- 23 county noxious weed control board shall, after a hearing, send the
- 24 applications to the county legislative authority recommending the names
- 25 of the most qualified candidates, and shall post the names of those
- 26 nominees in the county courthouse and in three places in the section.
- 27 The county legislative authority, within ten days of receiving the list
- 28 of nominees, shall appoint one of those nominees to the county noxious
- 29 weed control board to represent that section during that term of
- 30 office.

- 1 (3) Within thirty days after all the members have been appointed,
- 2 the board shall conduct its first meeting. A majority of the voting
- 3 members of the board shall constitute a quorum for the transaction of
- 4 business and shall be necessary for any action taken by the board. The
- 5 board shall elect from its members a chairperson and such other
- 6 officers as may be necessary.
- 7 (4) In case of a vacancy occurring in any voting position on a
- 8 county noxious weed control board, the county legislative authority of
- 9 the county in which such board is located shall appoint a qualified
- 10 person to fill the vacancy for the unexpired term.
- 11 **Sec. 5.** RCW 17.28.140 and 1957 c 153 s 14 are each amended to read
- 12 as follows:
- 13 The members of the first district board shall meet on the first
- 14 Monday subsequent to thirty days after the filing with the secretary of
- 15 state of the certificate of incorporation of the district. They shall
- 16 organize by the election of one of their members as president and one
- 17 as secretary.
- 18 The members of the district board shall serve without compensation;
- 19 but the ((necessary expenses of each member for actual traveling in
- 20 connection with meetings or business of the board may be allowed and
- 21 paid)) members are entitled to reimbursement for reasonable expenses
- 22 <u>actually incurred in connection with official business, including</u>
- 23 <u>subsistence</u> and <u>lodging</u> while away from his or her place of residence,
- 24 and mileage for use of a privately owned vehicle, in accordance with
- 25 <u>chapter 42.24 RCW</u>.
- 26 The secretary shall receive such compensation as shall be fixed by
- 27 the district board.

- Sec. 6. RCW 27.12.190 and 1982 c 123 s 8 are each amended to read as follows:
- 3 The management and control of a library shall be vested in a board 4 of either five or seven trustees as hereinafter in this section 5 provided. In cities and towns five trustees shall be appointed by the 6 mayor with the consent of the legislative body. In counties, rural county library districts, and island library districts, five trustees 7 shall be appointed by the board of county commissioners. In a regional 8 9 library district a board of either five or seven trustees shall be 10 appointed by the joint action of the legislative bodies concerned. In intercounty rural library districts a board of either five or seven 11 trustees shall be appointed by the joint action of the boards of county 12 commissioners of each of the counties included in a district. 13 14 first appointments for boards comprised of but five trustees shall be for terms of one, two, three, four, and five years respectively, and 15 thereafter a trustee shall be appointed annually to serve for five 16
- 19 respectively, and thereafter a trustee shall be appointed annually to

years. The first appointments for boards comprised of seven trustees

shall be for terms of one, two, three, four, five, six, and seven years

- 20 serve for seven years. No person shall be appointed to any board of
- 21 trustees for more than two consecutive terms. Vacancies shall be
- 22 filled for unexpired terms as soon as possible in the manner in which
- 23 members of the board are regularly chosen.
- A library trustee shall not receive a salary or other compensation
- 25 for services as trustee, but ((necessary expenses actually incurred
- 26 shall be paid from the library funds)) trustees are entitled to
- 27 reimbursement for reasonable expenses actually incurred in connection
- 28 with official business, including subsistence and lodging while away
- 29 from his or her place of residence, and mileage for use of a privately
- 30 owned vehicle, in accordance with chapter 42.24 RCW.

A library trustee in the case of a city or town may be removed only 1 2 by vote of the legislative body. A trustee of a county library, a rural county library district library, or an island library district 3 4 library may be removed for just cause by the county commissioners after 5 a public hearing upon a written complaint stating the ground for 6 removal, which complaint, with a notice of the time and place of hearing, shall have been served upon the trustee at least fifteen days 7 before the hearing. A trustee of an intercounty rural library district 8 may be removed by the joint action of the board of county commissioners 9 10 of the counties involved in the same manner as provided herein for the removal of a trustee of a county library. 11

13 as follows: 14 ((The actual expenses of)) School directors ((in going to, 15 returning from and attending upon directors' meetings or other meetings 16 called or held pursuant to statute shall be paid)) are entitled to 17 reimbursement for reasonable expenses actually incurred in connection 18 with official business, including subsistence and lodging while away 19 from his or her place of residence, and mileage for use of a privately owned vehicle, in accordance with chapter 42.24 RCW. Likewise, the 20 expenses of school superintendents and other school representatives 21 22 chosen by the directors to attend any conferences or meetings or to 23 attend to any urgent business at the behest of the state superintendent 24 of public instruction or the board of directors shall be paid((. The 25 board of directors may pay the actual and necessary expenses for 26 travel, lodging and meals a superintendent candidate incurs when he or 27 she attends an employment interview in the school district. The school 28 directors, school superintendents, other school representatives or superintendent candidates may be advanced sufficient sums to cover 29

- 4 accordance with chapter 42.24 RCW.
- 5 Sec. 8. RCW 28A.400.350 and 1990 1st ex.s. c 11 s 3 and 1990 c 74
- 6 s 1 are each reenacted and amended to read as follows:
- 7 (1) The board of directors of any of the state's school districts
- 8 may make available liability, life, health, health care, accident,
- 9 disability and salary protection or insurance or any one of, or a
- 10 combination of the enumerated types of insurance, or any other type of
- 11 insurance or protection, for the members of the boards of directors,
- 12 the students, and employees of the school district, and their
- 13 dependents. Such coverage may be provided by contracts with private
- 14 carriers, with the state health care authority after July 1, 1990,
- 15 pursuant to the approval of the authority administrator, or through
- 16 self-insurance or self-funding pursuant to chapter 48.62 RCW, or in any

- 1 may contribute all or part of the costs, including the premiums, of
- 2 life, health, health care, accident or disability insurance which shall
- 3 be offered to all students participating in interschool activities on
- 4 the behalf of or as representative of their school or school district.
- 5 The school district board of directors may require any student
- 6 participating in extracurricular interschool activities to, as a
- 7 condition of participation, document evidence of insurance or purchase
- 8 insurance that will provide adequate coverage, as determined by the
- 9 school district board of directors, for medical expenses incurred as a
- 10 result of injury sustained while participating in the extracurricular
- 11 activity. In establishing such a requirement, the district shall adopt
- 12 regulations for waiving or reducing the premiums of such coverage as
- 13 may be offered through the school district to students participating in
- 14 extracurricular activities, for those students whose families, by
- 15 reason of their low income, would have difficulty paying the entire
- 16 amount of such insurance premiums. The district board shall adopt
- 17 regulations for waiving or reducing the insurance coverage requirements
- 18 for low-income students in order to assure such students are not

- 23 premiums for liability insurance. The amount and type of insurance

- 3 NEW SECTION. Sec. 9. A new section is added to chapter 35.21 RCW
- 4 to read as follows:
- 5 Until a salary ordinance can be passed and become effective as to
- 6 elective officers of a newly incorporated city or town, the first
- 7 councilmembers shall be entitled to compensation as follows:
- 8 (1) In cities with a population of twenty thousand or more
- 9 inhabitants, a councilmember shall receive a salary of four hundred
- 10 dollars per calendar month;
- 11 (2) In cities with a population of at least ten thousand but less
- 12 than twenty thousand inhabitants, a councilmember shall receive a
- 13 salary of one hundred fifty dollars per calendar month;
- 14 (3) In cities with a population of at least one thousand five
- 15 hundred but less than ten thousand inhabitants, a councilmember shall
- 16 receive a salary of seventy-five dollars per calendar month;
- 17 (4) In cities with a population of less than one thousand five
- 18 hundred inhabitants, a councilmember shall receive twenty dollars per

- 21 as a councilmember, is entitled to receive an additional amount per
- 22 calendar month equal to twenty-five percent of the councilmember's
- 23 salary.
- 24 Compensation provided under this section shall remain in effect
- 25 only until a salary ordinance is passed and becomes effective as to the
- 26 elective officers. The compensation provided in this section shall not
- 27 be construed as fixing the usual compensation of such officers.

- 2 to read as follows:
- 3 The mayor and members of the city or town council are entitled to
- 4 reimbursement for reasonable expenses actually incurred in connection
- 5 with official business, including subsistence and lodging while away
- 6 from the councilmember's place of residence, and mileage for use of a
- 7 privately owned vehicle, in accordance with chapter 42.24 RCW.
- 8 <u>NEW SECTION.</u> **Sec. 11.** A new section is added to chapter 35.21 RCW
- 9 to read as follows:
- 10 Any member of a city or town council may waive all or any portion
- 11 of his or her compensation that is payable to the councilmember as to
- 12 any month or months during his or her term of office, by filing a
- 13 written waiver with the council. The waiver, to be effective, must be
- 14 filed at any time after the member's selection and prior to the date on
- 15 which the compensation would otherwise be paid. The waiver shall
- 16 specify the month or period of months for which it is made.
- 17 <u>NEW SECTION</u>. **Sec. 12.** A new section is added to chapter 35A.21
- 18 RCW to read as follows:
- 19 Any member of a city council may waive all or any portion of his or
- 20 her compensation that is payable to the councilmember as to any month
- 21 or months during his or her term of office, by filing a written waiver
- 22 with the council. The waiver, to be effective, must be filed at any
- 23 time after the member's selection and prior to the date on which the
- 24 compensation would otherwise be paid. The waiver shall specify the
- 25 month or period of months for which it is made.
- 26 **Sec. 13.** RCW 35.17.108 and 1967 c 100 s 1 are each amended to read
- 27 as follows:

- 1 annual salaries or compensation of the mayor and the 2 commissioners of any city operating under a commission form of 3 government shall be as fixed by ((charter or)) ordinance of ((said)) 4 the city. Until a salary ordinance can be passed and become effective in a newly incorporated city, the first councilmembers shall be 5 6 compensated in accordance with section 9 of this act. Councilmembers are entitled to reimbursement for reasonable expenses actually incurred 7 in connection with official business, including subsistence and lodging 8 while away from his or her place of residence, and mileage for use of 9 10 a privately owned vehicle, in accordance with chapter 42.24 RCW. The 11 power and authority conferred by this section shall be construed as in addition and supplemental to powers or authority conferred by any other 12 13 law, and nothing contained herein shall be construed as limiting any 14 other powers or authority of any such city.

- Each member of the council shall receive such salary or 17 18 compensation as may be provided by ((law to cities of the class to 19 which it belongs)) city ordinance. Until a salary ordinance can be passed and become effective in a newly incorporated city, the first 20 councilmembers shall be compensated in accordance with section 9 of 21 22 this act. Councilmembers are entitled to reimbursement for reasonable expenses actually incurred in connection with official business, 23 24 including subsistence and lodging while away from his or her place of residence, and mileage for use of a privately owned vehicle, in 25 accordance with chapter 42.24 RCW. The city manager and other officers 26 27 or assistants shall receive such salary or compensation as the council 28 shall fix by ordinance and shall be payable at such times as the

- 3 The legislative powers of a charter city shall be vested in a mayor
- 4 and a city council, to consist of such number of members and to have
- 5 such powers as may be provided for in its charter. The charter may
- 6 provide for direct legislation by the people through the initiative and
- 7 referendum upon any matter within the scope of the powers, functions,
- 8 or duties of the city. The mayor and council and such other elective
- 9 officers as may be provided for in such charter shall be elected at
- 10 such times and in such manner as provided in Title 29 RCW, and for such
- 11 terms and shall perform such duties ((and receive such compensation))
- 12 as may be prescribed in the charter.

- 14 ordinance can be passed and become effective in a newly incorporated
- 15 city, the first councilmembers shall be compensated in accordance with
- 16 section 9 of this act.
- 17 Any city that provides a pension for any of its employees under a
- 18 plan not administered by the state must notify the state auditor of the
- 19 existence of the plan at the time of an audit of the city by the
- 20 auditor. No city may establish a pension plan for its employees that
- 21 is not administered by the state, except that any defined contribution
- 22 plan in existence as of January 1, 1990, is deemed to have been
- 23 authorized. No city that provides a defined contribution plan for its
- 24 employees as authorized by this section may make any material changes
- 25 in the terms or conditions of the plan after June 7, 1990.
- 26 Sec. 19. RCW 35.27.130 and 1990 c 212 s 2 are each amended to read
- 27 as follows:
- 28 The mayor and members of the town council may be reimbursed for
- 29 actual expenses incurred in the discharge of their official duties

- 1 ((upon presentation of a claim therefor and its allowance and approval
- 2 by resolution of the town council)), including subsistence and lodging
- 3 while away from the councilmember's place of residence, and mileage for
