HOUSE BILL 2861

- 1 AN ACT Relating to the creation of the adult family home advisory
- 2 council; and adding new sections to chapter 70.128 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** The governor shall appoint an adult
- 5 family advisory council. The council shall be comprised of:
- 6 (1) One adult family home owner from each department of social and
- 7 health services region;
- 8 (2) Three adult family home residents or a member of their
- 9 immediate family;
- 10 (3) One area agency on aging representative, to be a nonvoting
- 11 member;
- 12 (4) The director of the department of social and health services
- 13 division of developmental disabilities or his or her designee, to be a
- 14 nonvoting member;

- 1 (5) The director of the department of social and health services
- 2 mental health division or his or her designee, to be a nonvoting
- 3 member;
- 4 (6) One department of social and health services adult family home
- 5 licensor, to be a nonvoting member;
- 6 (7) The state long-term care ombudsman or his or her designee;
- 7 (8) One member representing the developmental disabilities planning
- 8 council;
- 9 (9) One member representing the state's protection and advocacy
- 10 program; and
- 11 (10) The governor may select from lists provided by interested
- 12 organizations and individuals, four members from the general public,
- 13 one each representing the traumatically brain injured, the mentally
- 14 ill, persons with alzheimer and other related dementias, and persons
- 15 with AIDS.
- 16 Each member shall hold office for a term of four years, except that
- 17 any member appointed to fill a vacancy occurring prior to the
- 18 expiration of the term for which his or her predecessor was appointed
- 19 shall be appointed for the remainder of such term and the terms of
- 20 office of the members first taking office shall expire, as designated
- 21 at the time of appointment. The terms of appointment shall be the
- 22 following: Two at the end of the first year, three at the end of the
- 23 second year, three at the end of the third year, and two at the end of
- 24 the fourth year after the date of appointment. Thereafter, all
- 25 appointments shall be for three years. The chair of the council shall
- 26 be appointed by the members of the council, however the chair shall
- 27 not be a representative of any agency within state government. It
- 28 shall be the duty of the chair to call a meeting of the council. The
- 29 council shall meet not less than quarterly each year, however may meet
- 30 more frequently as the chair deems necessary and upon the formal

- 1 written request of no less than six members. Each member of the
- 2 council shall receive travel expenses in accordance with RCW 43.03.060.
- 3 All adult family home council members shall be appointed no less than
- 4 six months after the effective date of this act.
- 5 <u>NEW SECTION.</u> **Sec. 2.** The nursing home advisory council shall:
- 6 (1) Consult with the legislature and the department of social and
- 7 health services in all matters of policy affecting administration of
- 8 adult family homes, and in development of all rules and regulations
- 9 pertaining to adult family homes;
- 10 (2) Review and make recommendations with respect to rules,
- 11 regulations, and standards pertaining to nursing homes prior to their
- 12 adoption and promulgation by the department; and
- 13 (3) Provide recommendations to the secretary of the department of
- 14 social and health services and the legislature on ways in which the
- 15 adult family home industry can increase the utilization of the program
- 16 by private and state clients, improve and maintain health and safety
- 17 standards, improve the quality of life and the quality of resident
- 18 care, establish appropriate uniform adult family home owner training,
- 19 and other issues that the council finds appropriate and beneficial for
- 20 the adult family home program.
- 21 <u>NEW SECTION.</u> **Sec. 3.** Sections 1 and 2 of this act are each
- 22 added to chapter 70.128 RCW.
