- 1 AN ACT Relating to land use patterns in transit plans; amending RCW
- 2 35.58.2795, 35.58.2796, 36.57A.070, and 36.57.070; and repealing RCW
- 3 36.57A.060.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 35.58.2795 and 1990 1st ex.s. c 17 s 60 are each
- 6 amended to read as follows:
- 7 ((By April 1st of each year,)) (1) The legislative authority of
- 8 each municipality, as defined in RCW 35.58.272, shall prepare a six-
- 9 year transit development ((and financial program for that calendar year
- 10 and the ensuing five years)) plan. The plan shall establish the
- 11 framework for the continued development of transit services in the
- 12 municipality, and shall be adopted and submitted to the state
- 13 department of transportation annually by June 1st of each year,
- 14 beginning in 1993. In addition, each municipality shall concurrently

- 1 file a copy of its transit development plan with the transportation
- 2 improvement board and cities, counties, and regional transportation
- 3 planning organizations within which the municipality is located. The
- 4 <u>municipality shall conduct one or more public hearings each year while</u>
- 5 <u>developing its plan</u>. The department of transportation shall ensure
- 6 that the plan for each municipality is current, and shall provide
- 7 technical support to such municipalities that may be lacking resources
- 8 to complete the plans.
- 9 (2) The ((program)) transit development plan shall be consistent
- 10 with the comprehensive plans adopted by counties, cities, and towns,
- 11 pursuant to chapter 35.63, 35A.63, or 36.70 RCW, the inherent authority
- 12 of a first class city or charter county derived from its charter, or
- 13 chapter 36.70A RCW. ((The program shall contain information as to how
- 14 the municipality intends to meet state and local long-range priorities
- 15 for public transportation,) The plan shall address types of land use
- 16 patterns in the service area, how those patterns affect transit
- 17 services, what coordination processes have been developed with
- 18 constituent city and county land use planning efforts, and how transit
- 19 <u>service and land use compatibility can be enhanced. The plan shall be</u>
- 20 coordinated and consistent with the regional transportation plan.
- 21 (3) The plan shall address those state-wide transit goals,
- 22 policies, and emphasis areas contained in the state transportation
- 23 policy plan approved by the transportation commission, and when
- 24 appropriate, adopted by the legislature.
- 25 (4) The department of transportation in consultation with the
- 26 affected municipalities and the legislative transportation committee,
- 27 shall determine the format for the transit development plan. Each plan
- 28 shall include an annual element that describes the proposed activities
- 29 of the municipality in the current year. At minimum the plan shall
- 30 <u>address</u> capital improvements, significant operating changes planned for

- 1 the system, and how the municipality intends to fund program needs.
- 2 ((Each municipality shall file the six-year program with the state
- 3 department of transportation, the transportation improvement board, and
- 4 cities, counties, and regional planning councils within which the
- 5 municipality is located.
- 6 In developing its program, the municipality shall consider those
- 7 policy recommendations affecting public transportation contained in the
- 8 state transportation policy plan approved by the state transportation
- 9 commission and, where appropriate, adopted by the legislature. The
- 10 municipality shall conduct one or more public hearings while developing
- 11 its program and for each annual update.))
- 12 **Sec. 2.** RCW 35.58.2796 and 1989 c 396 s 2 are each amended to read
- 13 as follows:
- 14 (1) The department of transportation shall develop an annual report
- 15 summarizing the status of ((public transportation)) transit systems in
- 16 the state. By September 1st of each year, copies of the report shall
- 17 be submitted to the legislative transportation committee and to each
- 18 municipality, as defined in RCW 35.58.272, and to individual members of
- 19 the municipality's legislative authority. ((The department shall
- 20 prepare and submit a preliminary report by December 1, 1989.
- 21 To assist the department with preparation of the report, each
- 22 municipality shall file a system report by April 1st of each year with
- 23 the state department of transportation identifying its public
- 24 transportation services for the previous calendar year and its
- 25 objectives for improving the efficiency and effectiveness of those
- 26 services. The system report shall address those items required for
- 27 each public transportation system in the department's report.)) The
- 28 report shall also address the progress made toward meeting state-wide
- 29 transit goals, policies, and emphasis areas contained in the state

- 1 transportation policy plan approved by the transportation commission,
- 2 and when appropriate, adopted by the legislature.
- 3 (2) The annual state report shall be derived by the department from
- 4 the collective transit development plans filed by each municipality as
- 5 <u>required by RCW 35.58.2795.</u> The ((department)) report shall describe
- 6 individual ((public transportation)) transit systems, including
- 7 contracted transportation services and dial-a-ride services, and
- 8 include a state-wide summary of ((public transportation)) transit
- 9 <u>accomplishments</u>, issues, and data. The ((descriptions)) <u>report</u> shall
- 10 include the following elements and such other elements as the
- 11 department deems appropriate after consultation with the municipalities
- 12 and the legislative transportation committee:
- $((\frac{1}{1}))$ (a) Equipment and facilities, including vehicle replacement
- 14 standards;
- 15 $((\frac{2}{2}))$ (b) Services and service standards;
- 16 (((3))) (c) Revenues, expenses, and ((ending balances, by fund)
- 17 source)) status of reserve accounts;
- 18 (((4))) (d) Policy issues and system improvement objectives,
- 19 including community participation in development of those objectives
- 20 and how those objectives address state-wide transportation priorities;
- 21 (((+5))) (e) Operating indicators applied to public transportation
- 22 services, revenues, and expenses. Operating indicators shall include
- 23 operating cost per passenger trip, operating cost per revenue vehicle
- 24 service hour, passenger trips per revenue service hour, passenger trips
- 25 per vehicle service mile, vehicle service hours per employee, and
- 26 farebox revenue as a percent of operating costs:
- 27 (f) Activities aimed at improving the efficiency and effectiveness
- 28 of transit services.

- 1 Sec. 3. RCW 36.57A.070 and 1985 c 6 s 5 are each amended to read
- 2 as follows:
- 3 (1) The public transportation benefit area authority shall develop
- 4 and adopt a transit development plan under RCW 35.58.2795 for the area.
- 5 The authority shall submit the initial plan to the department of
- 6 <u>transportation for approval.</u> The ((comprehensive transit plan adopted
- 7 by the authority)) initial plan shall be reviewed by the ((state
- 8 transportation commission)) department to determine:
- 9 $((\frac{1}{1}))$ (a) The <u>levels and</u> completeness of <u>transit</u> service to be
- 10 ((offered)) provided and the ((economic)) financial viability of the
- 11 ((transit system proposed in such comprehensive transit plan))
- 12 <u>authority to provide the services</u>;
- 13 $((\frac{2}{2}))$ Whether such plan integrates the proposed
- 14 ((transportation system)) transit services with existing and planned
- 15 transportation modes and systems that serve the benefit area;
- 16 (((3))) (c) Whether such plan coordinates that area's ((system)
- 17 and)) services with nearby ((public)) transportation systems and
- 18 addresses possible future expansion of the benefit area or the
- 19 consolidation of the benefit area with other systems; and
- 20 $((\frac{4}{}))$ (d) Whether such plan $(\frac{1}{2})$ eligible for matching state or
- 21 federal funds)) addresses state-wide goals, policies, and objectives
- 22 set forth in the state transit plan component of the state-wide
- 23 <u>transportation plan</u>;
- 24 (2) After reviewing the ((comprehensive transit)) initial transit
- 25 <u>development</u> plan, the ((state transportation commission shall have))
- 26 <u>department has</u> sixty days in which to approve such plan and to certify
- 27 to the state treasurer that such public transportation benefit area
- 28 shall be eligible to receive the motor vehicle excise tax proceeds
- 29 authorized pursuant to RCW 35.58.273, as now or hereafter amended in
- 30 the manner prescribed by chapter 82.44 RCW, as now or hereafter

- 1 amended. ((To be approved a plan shall provide for coordinated
- 2 transportation planning, the integration of such proposed
- 3 transportation program with other transportation systems operating in
- 4 areas adjacent to, or in the vicinity of the proposed public
- 5 transportation benefit area, and be consistent with the public
- 6 transportation coordination criteria adopted pursuant to the urban mass
- 7 transportation act of 1964 as amended as of July 1, 1975. In the event
- 8 such comprehensive)) The department shall notify the authority in
- 9 writing within thirty days as to the approval of the plan, and shall
- 10 notify the authority as to the time subsequent transit development
- 11 plans are required under RCW 35.58.2795. The time must be no longer
- 12 than eighteen months after the approval of the initial public
- 13 <u>transportation development plan.</u>
- 14 (3) If the plan is disapproved and ruled ineligible to receive
- 15 motor vehicle tax proceeds, the state transportation commission shall
- 16 provide written notice to the authority within thirty days as to the
- 17 reasons for such plan's disapproval and such ineligibility. The
- 18 authority may resubmit such plan upon reconsideration and correction of
- 19 such deficiencies in the plan cited in such notice of disapproval.
- 20 **Sec. 4.** RCW 36.57.070 and 1974 ex.s. c 167 s 7 are each amended to
- 21 read as follows:
- The authority shall ((adopt a public transportation plan)) prepare
- 23 <u>a six-year transit development plan as prescribed in RCW 36.57A.070</u>.
- 24 Such plan shall be a general comprehensive plan designed to best serve
- 25 the residents of the entire county. Prior to adoption of the plan, the
- 26 authority shall provide a minimum of sixty days during which sufficient
- 27 hearings shall be held to provide interested persons an opportunity to
- 28 participate in development of the plan.
