- 1 TO THE HONORABLE GEORGE BUSH, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, On August 2, 1990, the military forces of Iraq invaded,
- 9 and to the present have occupied, the sovereign state of Kuwait; and
- 10 WHEREAS, Iraq's unprovoked aggression has brought untold suffering,
- 11 injury, and death to the citizens of Kuwait and others caught in Iraqi
- 12 president Saddam Hussein's reign of terror; and
- 13 WHEREAS, The Iraqi leadership has ignored numerous appeals by the
- 14 United Nations, members of the Arab League, and the United States to
- 15 withdraw peacefully from Kuwait, which Saddam Hussein now regards as
- 16 his "19th state"; and

- 1 WHEREAS, Iraq now controls twenty percent of the world oil reserves
- 2 and, if allowed to corner the world energy market, could irreparably
- 3 harm or destroy the global economy; and
- 4 WHEREAS, The United States' failure to adopt a coherent energy
- 5 policy has left this nation's own economy vulnerable to such a threat;
- 6 and
- 7 WHEREAS, The Iraqi leadership has shown no proclivity to bend to
- 8 international sanctions, even at the expense of their own people; and
- 9 WHEREAS, Iraq will continue to threaten the stability of the
- 10 Mideast with its million-man army and growing arsenal of weapons until
- 11 such time as it is disarmed; and
- 12 WHEREAS, The United Nations has authorized "member states
- 13 cooperating with the government of Kuwait" to use "all necessary means"
- 14 -- including force -- to expel the Iraqi invaders from Kuwait after
- 15 January 15, 1991; and
- 16 WHEREAS, The twenty-seven-nation international alliance now has
- 17 nearly seven hundred thousand troops on alert in the Persian Gulf; and
- 18 WHEREAS, That alliance, which includes many Arab states, cannot be
- 19 expected to last indefinitely; and
- 20 WHEREAS, The United States and the international alliance are the
- 21 single strongest deterrent to Iraq's success in carrying out its policy
- 22 of aggression; and
- 23 WHEREAS, Both Houses of the United States Congress, in accordance
- 24 with the Constitution, have given President Bush the authority to use
- 25 force if necessary to expel Iraq from Kuwait; and
- 26 WHEREAS, The United States military has proven an effective
- 27 deterrent to Fascism in the 1940s and Stalinism in the years
- 28 thereafter;

- 1 NOW, THEREFORE, Your Memorialists state their support for President
- 2 Bush's current policy of pursuing peace but providing for active
- 3 opposition to the Iraqi occupation of Kuwait; and
- 4 BE IT RESOLVED, That we support the President's use of force if and
- 5 when he deems it necessary to restore the freedom of Kuwait and counter
- 6 the threat of Iraqi expansionism; and
- 7 BE IT FURTHER RESOLVED, That whatever the outcome of the current
- 8 Mideast crisis, the United States should adopt a comprehensive energy
- 9 policy that will reduce this nation's dependence on foreign oil; and
- 10 BE IT FURTHER RESOLVED, That copies of this Memorial be immediately
- 11 transmitted to the Honorable George Bush, President of the United
- 12 States, the President of the United States Senate, the Speaker of the
- 13 House of Representatives, and each member of Congress from the State of
- 14 Washington.
