- 1 TO THE HONORABLE GEORGE BUSH, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED, AND TO MANUEL LUJAN JR.,
- 5 SECRETARY OF THE UNITED STATES DEPARTMENT OF THE INTERIOR, AND TO THE
- 6 NATIONAL PARK SERVICE:
- We, your Memorialists, the Senate and House of Representatives of
- 8 the State of Washington, in legislative session assembled, respectfully
- 9 represent and petition as follows:
- 10 WHEREAS, Lake Roosevelt was created when Grand Coulee Dam was
- 11 completed in 1941. It is some one hundred fifty miles in length with
- 12 approximately six hundred miles of shoreline and is a lake of state-
- 13 wide significance; and
- 14 WHEREAS, The National Park Service manages recreation on the lake
- 15 as well as manages recreation on a narrow strip of land, owned by the
- 16 Federal Government, between the water's edge and the one thousand three
- 17 hundred ten foot elevation line; and

- 1 WHEREAS, Said body of water with the adjacent narrow strip of land
- 2 is designated as a National Recreation Area and is now managed under
- 3 the guidelines of National Park Service Special Park Use Guidelines,
- 4 NPS-53, which implements 16 U.S.C. Sec. 1(a); and
- 5 WHEREAS, Using said guidelines, the National Park Service
- 6 implemented a Special Park Use Management Plan in October of 1990 that
- 7 will phase out all permitted docks for use by local adjacent
- 8 landowners, eliminate the grazing and watering of cattle from the
- 9 freeboard lands, place unrealistic and costly conditions for the future
- 10 use of the present permitted water withdrawal systems across the
- 11 freeboard lands, which affects agricultural irrigation from the lake,
- 12 and generally place new and restrictive uses for path and trail access
- 13 to the water from the adjacent private property, and;
- 14 WHEREAS, The restrictions negatively impact what fifty years of
- 15 traditional and permitted use has established, and further, have a
- 16 negative impact on the local tax base and individual livelihoods, and
- 17 adversely affect future development growth within the area of private
- 18 land adjacent to this National Recreation Area; and
- 19 WHEREAS, The restrictions are not in the best interest of the
- 20 economic well-being of either the State of Washington or the area
- 21 within the region of Lake Roosevelt;
- 22 NOW, THEREFORE, The Washington State Legislature encourages the
- 23 United States Congress, Manuel Lujan Jr., Secretary of the United
- 24 States Department of the Interior, and the National Park Service to
- 25 work more closely with the local citizens to amend the Special Park Use
- 26 Management Plan of 1990 so as to be less restrictive in its plan
- 27 elements, thus creating less negative impacts to the economies of both
- 28 the State of Washington and the various local jurisdictions and
- 29 citizens within the area of Lake Roosevelt, and not take away what
- 30 history and traditional use have already established.

- 4 the Interior, the National Park Service, the President of the United

- 6 member of Congress from the State of Washington.
