- 1 TO THE HONORABLE GEORGE BUSH, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, Health care expenditures in the United States are
- 9 estimated to reach \$738 billion in 1991 and \$817 billion in 1992, an
- 10 increase of 11%; and
- 11 WHEREAS, The rate of health care expenditure increases will average
- 12 12% to 13% over the next five years, according to the United States
- 13 Commerce Department, and shows no likelihood of decreasing in future
- 14 years; and
- 15 WHEREAS, These health care costs have grown at a rate in excess of
- 16 the rate of growth in personal and business income and general

- 1 government revenues, threatening the ability of businesses,
- 2 individuals, and the federal and state governments to maintain their
- 3 current commitments to purchasing health services or providing health
- 4 insurance coverage; and
- 5 WHEREAS, Rapidly increasing health care expenditures severely limit
- 6 the federal and state governments' ability to adequately fund other
- 7 important areas of government spending, such as common school
- 8 education, higher education, and infrastructure; and
- 9 WHEREAS, An unacceptably high number of Americans have no health
- 10 insurance or inadequate health insurance, putting them at risk of
- 11 serious illness and financial catastrophe; and
- 12 WHEREAS, The State of Washington has reached consensus on several
- 13 significant steps to address problems in our health care system,
- 14 including development of the Washington Basic Health Plan and the First
- 15 Steps and Second Steps maternal and child health programs and
- 16 establishment of the Washington Health Care Cost Control and Access
- 17 Commission, a group representing varied health care interests, which
- 18 has developed consensus recommendations on health care reform for the
- 19 Governor and the legislature of the State of Washington;
- NOW, THEREFORE, Your Memorialists respectfully pray that the United
- 21 States Congress and the United States President reach a consensus on
- 22 the issue of health care reform that builds upon the principles of
- 23 containing health care costs and providing universal access to health
- 24 care services, without compromising the strengths of the United States
- 25 health care system related to quality of care.
- 26 BE IT RESOLVED, That copies of this Memorial be immediately
- 27 transmitted to the Honorable George Bush, President of the United
- 28 States, the President of the United States Senate, the Speaker of the
- 29 House of Representatives, and each member of Congress from the State of
- 30 Washington.
