- 1 TO THE HONORABLE GEORGE BUSH, PRESIDENT OF THE UNITED STATES, AND
- 2 TO THE PRESIDENT OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 3 REPRESENTATIVES, AND TO THE SENATE AND HOUSE OF REPRESENTATIVES OF THE
- 4 UNITED STATES, IN CONGRESS ASSEMBLED:
- 5 We, your Memorialists, the Senate and House of Representatives of
- 6 the State of Washington, in legislative session assembled, respectfully
- 7 represent and petition as follows:
- 8 WHEREAS, The Hatch Act of 1939 vastly prohibits the political
- 9 rights and activities of Federal civilian and postal employees in any
- 10 endeavor beyond voting, privately expressing opinions about candidates
- 11 and issues, or contributing money to political organizations; and
- 12 WHEREAS, Federal civilian and postal workers are, first and
- 13 foremost, citizens of the United States, with interests and experiences
- 14 as diverse as the nation and should be allowed to more fully
- 15 participate in the democratic process; and

- 1 WHEREAS, The current language of the Hatch Act is so vague and
- 2 complex as to create a chilling effect on the activities of many
- 3 federal employees who often do not participate in currently permissible
- 4 activities out of confusion and concern for their job security; and
- 5 WHEREAS, The Commission on Political Activity of Government
- 6 Personnel which was created by Congress and charged with the task of
- 7 extensively studying the question of Hatch Act reform concluded in 1968
- 8 that the Act was confusing, ambiguous, restrictive, and negative in
- 9 character; and
- 10 WHEREAS, Federal civilian and postal employees deserve to and
- 11 should be permitted to participate voluntarily, as private citizens, to
- 12 the fullest extent possible in the political processes of the nation;
- 13 and
- 14 WHEREAS, The necessity for the protection of such employees and the
- 15 general citizenry from improper political solicitations or coercion has
- 16 decreased substantially in the years since the implementation of the
- 17 Hatch Act; and
- 18 WHEREAS, The merit system for employee advancement has become so
- 19 firmly entrenched in the American Civil Service system that the
- 20 existing Hatch Act is no longer required to protect employees from
- 21 improper pressure from their superiors; and
- 22 WHEREAS, Federal civilian and postal employees possess unparalleled
- 23 knowledge and understanding of the Government and its administration
- 24 which would add immensely to public policy debate if such employees
- 25 were freed to become more politically active;
- 26 NOW, THEREFORE, Your Memorialists respectfully pray that the United
- 27 States Congress and President George Bush amend The Hatch Act, as
- 28 codified in Title 5, United States Code, to provide for Federal
- 29 civilian and postal employees to participate voluntarily as private
- 30 citizens in the political processes of the nation and to protect such

- 1 employees from improper political solicitation or coercion only to the
- 2 extent truly necessary.
- 3 BE IT RESOLVED, That copies of this Memorial be immediately
- 4 transmitted to the Honorable George Bush, President of the United
- 5 States, the President of the United States Senate, the Speaker of the
- 6 House of Representatives, and each member of Congress from the State of
- 7 Washington.
