- 1 TO THE ASSOCIATION OF WASHINGTON CITIES, THE WASHINGTON STATE
- 2 ASSOCIATION OF COUNTIES, THE WASHINGTON STATE FAMILY CHILDCARE
- 3 ASSOCIATION, AND MEMBERS OF APPROPRIATE LEGISLATIVE COMMITTEES:
- We, Your Memorialists, the Senate and House of Representatives of
- 5 the State of Washington, in legislative session assembled, respectfully
- 6 represent and petition as follows:
- WHEREAS, There exists a need for affordable, good quality, licensed
- 8 family day care in all areas of the state; and
- 9 WHEREAS, The Legislature recognizes that the provision of licensed
- 10 family day care is an issue of state-wide importance; and
- 11 WHEREAS, The Legislature recognizes that the siting of licensed
- 12 family day care facilities is currently a local land-use issue; and
- 13 WHEREAS, Local governments should be encouraged to facilitate the
- 14 siting of licensed family day care facilities to meet the demand for
- 15 child care services; and

- 1 WHEREAS, In 1989, the Legislature directed the State Department of
- 2 Community Development to conduct a study on the role that local zoning
- 3 regulations play on the need and demand for licensed family day care
- 4 facilities; and
- 5 WHEREAS, The study provided local governments with a model
- 6 ordinance for the siting of licensed day care facilities; and
- 7 WHEREAS, There exists a need to conduct a survey to assess local
- 8 government zoning regulation of licensed family day care facilities and
- 9 to determine the number of local governments that have revised their
- 10 zoning regulations, as a result of the model ordinance, to facilitate
- 11 the siting of licensed family day care facilities;
- 12 NOW, THEREFORE, The Legislature urges that the Association of
- 13 Washington Cities, the Washington State Association of Counties, and
- 14 the Washington State Family Childcare Association conduct a survey of
- 15 local government zoning regulations and the siting of licensed family
- 16 day care facilities; and
- 17 BE IT RESOLVED, That the findings and recommendations based on the
- 18 survey be submitted in a written report by December 1, 1992, to the
- 19 House of Representatives and the Senate; and
- 20 BE IT FURTHER RESOLVED, That the written report contain
- 21 recommendations on administrative changes needed to facilitate the
- 22 siting of licensed family day care facilities at the local level; and
- BE IT FURTHER RESOLVED, That copies of this memorial be immediately
- 24 transmitted to the Association of Washington Cities, the Washington
- 25 State Association of Counties, the Washington State Family Childcare
- 26 Association, and members of the appropriate legislative committees.
