- 1 AN ACT Relating to jury service; creating new sections; and making
- 2 an appropriation.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 NEW SECTION. **Sec. 1.** (1) The office of the administrator for
- 5 the courts, the Washington state superior court judges association, the
- 6 district and municipal court judges association, the Washington state
- 7 association of county clerks, the office of financial management, the
- 8 secretary of state, the Washington state association of county
- 9 auditors, the department of licensing, the Washington state bar
- 10 association, the association of Washington superior court
- 11 administrators, and the Washington state association for court
- 12 administration shall prepare a plan to implement a merging of the list
- 13 of those persons who have been issued a driver's license in the state
- 14 of Washington and whose names are in the records maintained by the

- 1 department of licensing, persons issued identicards under RCW
- 2 46.20.117, and the lists of registered voters in each county to form an
- 3 expanded jury source list. Other associations or individuals
- 4 interested in an expanded jury source list may be consulted when
- 5 developing this plan.
- 6 (2) The plan shall include: (a) A fiscal analysis of the costs;
- 7 (b) a recommendation of which costs are to be paid by the state and by
- 8 local governments; (c) a recommendation of which functions and duties
- 9 are to be performed by state agencies and local governments; (d) a
- 10 report on the potential effects of a merged source list; (e) a
- 11 recommendation of the format the lists from the department of licensing
- 12 and the lists of registered voters are to be provided for merging; and
- 13 (f) a recommendation of a methodology for merging the lists to form an
- 14 expanded jury source list.
- 15 (3) This plan along with proposed legislation shall be submitted to
- 16 the legislature by January 1, 1992.
- 17 <u>NEW SECTION.</u> **Sec. 2.** The legislature requests that the
- 18 Washington state association of county clerks conduct a study to
- 19 determine appropriate standards for excusing persons from jury service
- 20 due to financial hardship. The association is requested to report its
- 21 findings along with proposed legislation to the senate law and justice
- 22 committee and the house of representatives judiciary committee by
- 23 January 1, 1992.
- 24 <u>NEW SECTION</u>. **Sec. 3**. The sum of thirty-five thousand dollars,
- 25 or as much thereof as may be necessary, is appropriated for the
- 26 biennium ending June 30, 1993, from the general fund to the office of
- 27 the administrator for the courts to carry out the development of the
- 28 plan as set forth in section 1 of this act.
