- 1 AN ACT Relating to additional enrollments at institutions of higher
- 2 education; creating new sections; providing an effective date; and
- 3 declaring an emergency.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** This act shall be known as the higher
- 6 education opportunity act of 1991.
- 7 NEW SECTION. Sec. 2. The state of Washington has historically
- 8 given high priority to the higher education needs of its citizens. As
- 9 we move to the twenty-first century and to the more competitive world
- 10 economy that it brings, it is imperative that we provide access to all
- 11 of the types of higher education that are needed by the citizens of
- 12 Washington. Washington has developed one of the finest community
- 13 college systems in the country. The higher education coordinating
- 14 board has determined that there is a need in this state for increased

- 1 participation at the upper-division and graduate levels and that
- 2 baccalaureate and graduate degrees need to be earned at an increased
- 3 rate for our citizens to maintain competitiveness in the world economy.
- 4 There is also a need to increase the opportunity for citizens to learn
- 5 entry-level skills and trades resulting in their ability to become
- 6 productive individuals in our society and not depend on the state for
- 7 subsistence grants.
- 8 It is the intent of this act to modify the present enrollment lids
- 9 which limit the size of the student population on the public higher
- 10 education campuses in the state. This act will be the first step
- 11 toward meeting the educational needs of our citizens in the 1990's. It
- 12 is further the intent of this act to endorse the long-term enrollment
- 13 goals established by the higher education coordinating board. This act
- 14 moves toward achieving the goals of a participation rate equal to the
- 15 70th percentile of national participation rates for upper-division and
- 16 graduate students and a participation rate equal to the 90th percentile
- 17 of national participation rates for all students.
- 18 The legislature finds that the present enrollment lids at the
- 19 public institutions are artificially set and that an increase in the
- 20 number of full-time equivalent enrollments on the campuses can be
- 21 accomplished without additional capital construction. The legislature
- 22 further finds that at many of our state institutions of higher
- 23 education there is the physical capacity available to accept new
- 24 students, and there is also a desire among the institutions to accept
- 25 new enrollments in the coming biennium. It is the intent of this act
- 26 to remain sensitive to the capability and capacity of each institution
- 27 to accept additional enrollments.
- 28 It is not the intent of this act to emphasize access to the
- 29 detriment of quality in the educational programs of our institutions.
- 30 Therefore, it is the intent of this act to provide a funding level for

- 1 additional enrollments that is based on the 1990 higher education
- 2 coordinating board cost study and will include both the direct and
- 3 indirect costs associated with additional student enrollments. It is
- 4 the intent of this act to begin the process of affording a place in the
- 5 higher education system for all citizens of Washington who are
- 6 qualified for and desirous of earning a college degree, and to assure
- 7 that the quality of those degrees are not jeopardized by inadequate
- 8 funding levels.
- 9 <u>NEW SECTION.</u> **Sec. 3.** The new enrollments authorized in
- 10 sections 4 through 10 of this act are additional state-funded
- 11 enrollments at our state institutions of higher education above the
- 12 level established for each institution during the 1989-91 biennium:
- 13 PROVIDED, That should the level of funding for enrollment increases, in
- 14 the omnibus appropriations act or in Senate Bill 5814, be insufficient
- 15 to provide for the full level of enrollment increases set forth in
- 16 sections 4 through 10 of this act the enrollment increases set forth in
- 17 those sections shall be reduced proportionate to the actual level of
- 18 funding provided in either of the aforementioned acts.
- 19 <u>NEW SECTION.</u> **Sec. 4.** Subject to the provisions of section 3
- 20 of this act, the state-funded enrollment level at the University of
- 21 Washington shall be increased by two hundred forty-five full-time
- 22 equivalent students during the 1991-92 fiscal year plus an additional
- 23 three hundred ninety-eight full-time equivalent students during the
- 24 1992-93 fiscal year. The new enrollments authorized in this section
- 25 are subject to the following distribution:
- 26 (1) The enrollment level at the Tacoma branch campus shall be
- 27 increased by one hundred seventeen full-time equivalent upper-division
- 28 and graduate enrollments during the 1991-92 fiscal year plus an

- 1 additional one hundred ninety-nine full-time equivalent upper-division
- 2 and graduate enrollments during the 1992-93 fiscal year;
- 3 (2) The enrollment level at the Bothell/Woodinville branch campus
- 4 shall be increased by eighty-eight full-time equivalent upper-division
- 5 and graduate enrollments during the 1991-92 fiscal year plus an
- 6 additional one hundred sixty-four full-time equivalent upper-division
- 7 and graduate enrollments during the 1992-93 fiscal year;
- 8 (3) The enrollment level in the evening program shall be increased
- 9 by forty full-time equivalent upper-division and graduate enrollments
- 10 during the 1991-92 fiscal year plus an additional thirty-five full-time
- 11 equivalent upper-division and graduate enrollments during the 1992-93
- 12 fiscal year.
- 13 <u>NEW SECTION.</u> **Sec. 5.** Subject to the provisions of section 3
- 14 of this act, the state-funded enrollment level at Washington State
- 15 University shall be increased by four hundred seventy-four full-time
- 16 equivalent students during the 1991-92 fiscal year plus an additional
- 17 seven hundred eighty-five full-time equivalent students during the
- 18 1992-93 fiscal year. The new enrollments authorized in this section
- 19 are subject to the following distribution:
- 20 (1) The enrollment level at the Pullman campus shall be increased
- 21 by one hundred seventy-five full-time equivalent upper-division and
- 22 seventy-five full-time equivalent graduate enrollments during the 1991-
- 23 92 fiscal year plus an additional one hundred seventy-five full-time
- 24 equivalent upper-division and seventy-five full-time equivalent
- 25 graduate enrollments during the 1992-93 fiscal year;
- 26 (2) The enrollment level at the southwest Washington branch campus
- 27 shall be increased by one hundred twenty full-time equivalent upper-
- 28 division and graduate enrollments during the 1991-92 fiscal year plus

- 1 an additional two hundred eighty full-time equivalent upper-division
- 2 and graduate enrollments during the 1992-93 fiscal year;
- 3 (3) The enrollment level at the Spokane branch campus shall be
- 4 increased by thirty-nine full-time equivalent upper-division and
- 5 graduate enrollments during the 1991-92 fiscal year plus an additional
- 6 eighty full-time equivalent upper-division and graduate enrollments
- 7 during the 1992-93 fiscal year;
- 8 (4) The enrollment level at the Tri-Cities branch campus shall be
- 9 increased by sixty-five full-time equivalent upper-division and
- 10 graduate enrollments during the 1991-92 fiscal year plus an additional
- 11 one hundred seventy-five full-time equivalent upper-division and
- 12 graduate enrollments during the 1992-93 fiscal year.
- 13 <u>NEW SECTION.</u> **Sec. 6.** Subject to the provisions of section 3
- 14 of this act, the state-funded enrollment level at Central Washington
- 15 University shall be increased by two hundred fifty full-time equivalent
- 16 upper-division and fifty full-time equivalent graduate enrollments
- 17 during the 1991-92 fiscal year plus an additional two hundred full-time
- 18 equivalent upper-division and fifty full-time equivalent graduate
- 19 enrollments during the 1992-93 fiscal year.
- 20 <u>NEW SECTION.</u> **Sec. 7.** Subject to the provisions of section 3
- 21 of this act, the state-funded enrollment level at Eastern Washington
- 22 University shall be increased by one hundred fifty full-time equivalent
- 23 upper-division and fifty full-time equivalent graduate enrollments
- 24 during the 1991-92 fiscal year plus an additional one hundred fifty
- 25 full-time equivalent upper-division and fifty full-time equivalent
- 26 graduate enrollments during the 1992-93 fiscal year.

- 1 <u>NEW SECTION.</u> **Sec. 8.** Subject to the provisions of section 3
- 2 of this act, the state-funded enrollment level at The Evergreen State
- 3 College shall be increased by forty-five full-time equivalent upper-
- 4 division and five full-time equivalent graduate enrollments during the
- 5 1991-92 fiscal year plus an additional forty-five full-time equivalent
- 6 upper-division and five full-time equivalent graduate enrollments
- 7 during the 1992-93 fiscal year.
- 8 <u>NEW SECTION.</u> **Sec. 9.** Subject to the provisions of section 3
- 9 of this act, the state-funded enrollment level at Western Washington
- 10 University shall be increased by one hundred twenty full-time
- 11 equivalent upper-division and eighty full-time equivalent graduate
- 12 enrollments during the 1991-92 fiscal year plus an additional two
- 13 hundred twenty full-time equivalent upper-division and eighty full-time
- 14 equivalent graduate enrollments during the 1992-93 fiscal year.
- 15 <u>NEW SECTION.</u> **Sec. 10.** Subject to the provisions of section 3
- 16 of this act, the state-funded enrollment in the state community college
- 17 system shall be increased by three thousand five hundred full-time
- 18 equivalent enrollments during the 1991-92 fiscal year plus an
- 19 additional three thousand five hundred full-time equivalent enrollments
- 20 during the 1992-93 fiscal year. These new enrollments shall be
- 21 distributed throughout the system by the state board for community
- 22 college education consistent with legislative intent.
- NEW SECTION. Sec. 11. This act is necessary for the immediate
- 24 preservation of the public peace, health, or safety, or support of the
- 25 state government and its existing public institutions, and shall take
- 26 effect July 1, 1991.

- 1 <u>NEW SECTION.</u> **Sec. 12.** If specific funding for the purposes of
- 2 this act, referencing this act by bill number, is not provided by June
- 3 30, 1991, through the passage of Senate Bill 5814 or in the omnibus
- 4 appropriations act, this act shall be null and void.
