
REENGROSSED SENATE BILL 5226

State of Washington 52nd Legislature 1991 Regular Session

Read first time January 24, 1991. Referred to Committee or Governmental Operations.

- AN ACT Relating to terms of office; and amending RCW 43.01.010 and
- 2 44.04.021; and providing for submission of this act to a vote of the
- 3 people.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 43.01.010 and 1965 c 8 s 43.01.010 are each amended to
- 6 read as follows:
- 7 (1) The governor, lieutenant governor, secretary of state,
- 8 treasurer, auditor, attorney general, superintendent of public
- 9 instruction, commissioner of public lands, and insurance commissioner,
- 10 shall hold office for the term of four years, and until their
- 11 successors are elected and qualified; and the term shall commence on
- 12 the Wednesday after the second Monday of January following their
- 13 election.
- 14 (2) No person may hold any office listed in subsection (1) of this
- 15 section for more than twelve years, whether such office is held

- 1 consecutively or nonconsecutively. A person may not file for or be
- 2 appointed to any office listed in subsection (1) of this section if
- 3 serving the term or remainder of the term would violate the twelve-year
- 4 limitation of this subsection. Service in any of the offices listed in
- 5 <u>subsection (1) of this section before Wednesday after the second Monday</u>
- 6 in January 1993 shall not be used when applying the twelve-year
- 7 limitation of this subsection.
- 8 Sec. 2. RCW 44.04.021 and 1987 c 13 s 1 are each amended to read
- 9 as follows:
- 10 (1) The regular term of office of each senator and representative
- 11 shall commence on the second Monday in January following the date of
- 12 election.
- 13 (2) No person may hold the office of senator or representative for
- 14 more than twelve years, whether such office is held consecutively or
- 15 <u>nonconsecutively</u>. A person may not file for or be appointed to the
- 16 office of senator or representative if serving the term or remainder of
- 17 the term would violate the twelve-year limitation of this subsection.
- 18 Service in the office of senator or representative before the second
- 19 Monday in January 1993 shall not be used when applying the twelve-year
- 20 limitation of this subsection.
- 21 <u>NEW SECTION.</u> **Sec. 3.** This act shall be submitted to the
- 22 people for their adoption and ratification, or rejection, at the next
- 23 succeeding general election to be held in this state, in accordance
- 24 with Article II, section 1 of the state Constitution, as amended, and
- 25 the laws adopted to facilitate the operation thereof.
