- 1 AN ACT Relating to reducing legislative per diem and appropriations
- 2 to the governor as an incentive for concluding extraordinary sessions
- 3 of the legislature; amending RCW 44.04.120; adding a new section to
- 4 chapter 43.88 RCW; and declaring an emergency.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 6 **Sec. 1.** RCW 44.04.120 and 1985 c 3 s 1 are each amended to read as
- 7 follows:
- 8 (1) Each member of the senate or house of representatives when
- 9 serving on official legislative business shall be entitled to receive,
- 10 in lieu of per diem or any other payment, for each day or major portion
- 11 thereof in which he is actually engaged in legislative business or
- 12 business of the committee, commission, or council, notwithstanding any
- 13 laws to the contrary, an allowance in an amount fixed by the secretary
- 14 of the senate and chief clerk of the house, respectively, in accordance
- 15 with applicable rules and resolutions of each body. Such allowance

- 1 shall be reasonably calculated to reimburse expenses, exclusive of
- 2 mileage, which are ordinary and necessary in the conduct of legislative
- 3 business, recognizing cost variances which are encountered in different
- 4 locales. The allowance authorized shall not exceed the greater of
- 5 forty-four dollars per day or the maximum daily amount determined under
- 6 RCW 43.03.050, as now or hereafter amended. In addition, a mileage
- 7 allowance shall be paid at the rate per mile provided for in RCW
- 8 43.03.060, as now or hereafter amended, when authorized by the house,
- 9 committee, commission, or council of which he is a member and on the
- 10 business of which he is engaged.
- 11 (2) During any extraordinary session of the legislature pursuant to
- 12 Article II, section 12(2) of the state Constitution, the allowance
- 13 established under subsection (1) of this section shall be reduced by
- 14 ten percent during the first five days of the session, twenty percent
- 15 <u>during the next ten days</u>, and twenty-five percent during the remainder
- 16 of the extraordinary session. An amount equal to the allowances not
- 17 paid under this subsection shall be deposited by the chief clerk of the
- 18 house of representatives and the secretary of the senate in the account
- 19 <u>established under section 2(2) of this act.</u>
- 20 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 43.88 RCW
- 21 to read as follows:
- 22 (1) For each day of an extraordinary session of the legislature
- 23 pursuant to Article II, section 12(2) of the state Constitution, the
- 24 director of financial management shall remove from appropriated status
- 25 one percent of the state general funds appropriated for the operation
- 26 of the office of the governor.
- 27 (2) The funds removed from appropriated status under this section,
- 28 together with the moneys identified in RCW 44.04.120(2), shall be
- 29 deposited in the state conservancy account hereby created in the state

- 1 treasury. Moneys in the account may be appropriated by the legislature
- 2 solely for the purpose of acquiring or improving lands for wildlife
- 3 habitat, conservation, or public recreation purposes.
- 4 <u>NEW SECTION.</u> **Sec. 3.** This act is necessary for the immediate
- 5 preservation of the public peace, health, or safety, or support of the
- 6 state government and its existing public institutions, and shall take
- 7 effect immediately.
