- 1 AN ACT Relating to circumstances for removing a child from the
- 2 home; and reenacting and amending RCW 13.34.130.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 13.34.130 and 1990 c 284 s 32 and 1990 c 246 s 5 are
- 5 each reenacted and amended to read as follows:
- 6 If, after a fact-finding hearing pursuant to RCW 13.34.110, as now
- 7 or hereafter amended, it has been proven by a preponderance of the
- 8 evidence that the child is dependent within the meaning of RCW
- 9 13.34.030(2); after consideration of the predisposition report prepared
- 10 pursuant to RCW 13.34.110 and after a disposition hearing has been held
- 11 pursuant to RCW 13.34.110, the court shall enter an order of
- 12 disposition pursuant to this section.
- 13 (1) The court shall order one of the following dispositions of the
- 14 case:

- 1 (a) Order a disposition other than removal of the child from his or
- 2 her home, which shall provide a program designed to alleviate the
- 3 immediate danger to the child, to mitigate or cure any damage the child
- 4 has already suffered, and to aid the parents so that the child will not
- 5 be endangered in the future. In selecting a program, the court should
- 6 choose those services that least interfere with family autonomy,
- 7 provided that the services are adequate to protect the child.
- 8 (b) Order that the child be removed from his or her home and
- 9 ordered into the custody, control, and care of a relative or the
- 10 department of social and health services or a licensed child placing
- 11 agency for placement in a foster family home or group care facility
- 12 licensed pursuant to chapter 74.15 RCW or in a home not required to be
- 13 licensed pursuant to chapter 74.15 RCW. Unless there is reasonable
- 14 cause to believe that the safety or welfare of the child would be
- 15 jeopardized or that efforts to reunite the parent and child will be
- 16 hindered, such child shall be placed with a grandparent, brother,
- 17 sister, stepbrother, stepsister, uncle, aunt, or first cousin with whom
- 18 the child has a relationship and is comfortable, and who is willing and
- 19 available to care for the child. An order for out-of-home placement
- 20 may be made only if the court finds that reasonable efforts have been
- 21 made to prevent or eliminate the need for removal of the child from the
- 22 child's home and to make it possible for the child to return home,
- 23 specifying the services that have been provided to the child and the
- 24 child's parent, guardian, or legal custodian, and that:
- 25 (i) There is no parent or guardian available to care for such
- 26 child;
- 27 (ii) The parent, guardian, or legal custodian is not willing to
- 28 take custody of the child;
- 29 (iii) A manifest danger exists that the child will suffer serious
- 30 abuse or neglect if the child is not removed from the home and an order

- 1 under RCW 26.44.063 would not protect the child from danger. A
- 2 manifest danger includes, but is not limited to:
- 3 (A) Emotional illness, mental illness, or mental deficiency of the
- 4 parent of such nature and duration as to render the parent incapable of
- 5 providing proper care for the child;
- 6 (B) Conduct of the parent toward any child of an abusive, cruel, or
- 7 <u>sexual nature;</u>
- 8 (C) Addictive or habitual use of intoxicating liquors or controlled
- 9 substances by the parent to the extent that parental ability has been
- 10 <u>substantially impaired;</u>
- 11 (D) Physical neglect of the child by the parent; or
- 12 (iv) The extent of the child's disability is such that the parent,
- 13 guardian, or legal custodian is unable to provide the necessary care
- 14 for the child and the parent, guardian, or legal custodian has
- 15 determined that the child would benefit from placement outside of the
- 16 home.
- 17 (2) If the court has ordered a child removed from his or her home
- 18 pursuant to RCW 13.34.130(1)(b), the court may order that a petition
- 19 seeking termination of the parent and child relationship be filed if
- 20 the court finds it is recommended by the supervising agency, that it is
- 21 in the best interests of the child and that it is not reasonable to
- 22 provide further services to reunify the family because the existence of
- 23 aggravated circumstances make it unlikely that services will effectuate
- 24 the return of the child to the child's parents in the near future. In
- 25 determining whether aggravated circumstances exist, the court shall
- 26 consider one or more of the following:
- 27 (a) Conviction of the parent of rape of the child in the first,
- 28 second, or third degree as defined in RCW 9A.44.073, 9A.44.076, and
- 29 9A.44.079;

- 1 (b) Conviction of the parent of criminal mistreatment of the child
- 2 in the first or second degree as defined in RCW 9A.42.020 and
- 3 9A.42.030;
- 4 (c) Conviction of the parent of assault of the child in the first
- 5 or second degree as defined in RCW 9A.36.011 and 9A.36.021;
- 6 (d) Conviction of the parent of murder, manslaughter, or homicide
- 7 by abuse of the child's other parent, sibling, or another child;
- 8 (e) A finding by a court that a parent is a sexually violent
- 9 predator as defined in RCW ((9A.88.010)) <u>71.09.020</u>;
- 10 (f) Failure of the parent to complete available treatment ordered
- 11 under this chapter or the equivalent laws of another state, where such
- 12 failure has resulted in a prior termination of parental rights to
- 13 another child and the parent has failed to effect significant change in
- 14 the interim.
- 15 (3) Whenever a child is ordered removed from the child's home, the
- 16 agency charged with his or her care shall provide the court with:
- 17 (a) A permanent plan of care that may include one of the following:
- 18 Return of the child to the home of the child's parent, adoption,
- 19 guardianship, or long-term placement with a relative or in foster care
- 20 with a written agreement.
- 21 (b) Unless the court has ordered, pursuant to RCW 13.34.130(2),
- 22 that a termination petition be filed, a specific plan as to where the
- 23 child will be placed, what steps will be taken to return the child
- 24 home, and what actions the agency will take to maintain parent-child
- 25 ties. All aspects of the plan shall include the goal of achieving
- 26 permanence for the child.
- 27 (i) The agency plan shall specify what services the parents will be
- 28 offered in order to enable them to resume custody, what requirements
- 29 the parents must meet in order to resume custody, and a time limit for
- 30 each service plan and parental requirement.

- 1 (ii) The agency shall be required to encourage the maximum parent-
- 2 child contact possible, including regular visitation and participation
- 3 by the parents in the care of the child while the child is in
- 4 placement. Visitation may be limited or denied only if the court
- 5 determines that such limitation or denial is necessary to protect the
- 6 child's health, safety, or welfare.
- 7 (iii) A child shall be placed as close to the child's home as
- 8 possible, preferably in the child's own neighborhood, unless the court
- 9 finds that placement at a greater distance is necessary to promote the
- 10 child's or parents' well-being.
- 11 (iv) The agency charged with supervising a child in placement shall
- 12 provide all reasonable services that are available within the agency,
- 13 or within the community, or those services which the department of
- 14 social and health services has existing contracts to purchase. It
- 15 shall report to the court if it is unable to provide such services.
- 16 (c) If the court has ordered, pursuant to RCW 13.34.130(2), that a
- 17 termination petition be filed, a specific plan as to where the child
- 18 will be placed, what steps will be taken to achieve permanency for the
- 19 child, services to be offered or provided to the child, and, if
- 20 visitation would be in the best interests of the child, a
- 21 recommendation to the court regarding visitation between parent and
- 22 child pending a fact-finding hearing on the termination petition. The
- 23 agency shall not be required to develop a plan of services for the
- 24 parents or provide services to the parents.
- 25 (4) If there is insufficient information at the time of the
- 26 disposition hearing upon which to base a determination regarding the
- 27 suitability of a proposed placement with a relative, the child shall
- 28 remain in foster care and the court shall direct the supervising agency
- 29 to conduct necessary background investigations as provided in chapter
- 30 74.15 RCW and report the results of such investigation to the court

- 1 within thirty days. However, if such relative appears otherwise
- 2 suitable and competent to provide care and treatment, the criminal
- 3 history background check need not be completed before placement, but as
- 4 soon as possible after placement. Any placements with relatives,
- 5 pursuant to this section, shall be contingent upon cooperation by the
- 6 relative with the agency case plan and compliance with court orders
- 7 related to the care and supervision of the child including, but not
- 8 limited to, court orders regarding parent-child contacts and any other
- 9 conditions imposed by the court. Noncompliance with the case plan or
- 10 court order shall be grounds for removal of the child from the
- 11 relative's home, subject to review by the court.
- 12 (5) The status of all children found to be dependent shall be
- 13 reviewed by the court at least every six months from the beginning date
- 14 of the placement episode or the date dependency is established,
- 15 whichever is first, at a hearing in which it shall be determined
- 16 whether court supervision should continue. The review shall include
- 17 findings regarding the agency and parental completion of disposition
- 18 plan requirements, and if necessary, revised permanency time limits.
- 19 (a) A child shall not be returned home at the review hearing unless
- 20 the court finds that a reason for removal as set forth in this section
- 21 no longer exists. The parents, guardian, or legal custodian shall
- 22 report to the court the efforts they have made to correct the
- 23 conditions which led to removal. If a child is returned, casework
- 24 supervision shall continue for a period of six months, at which time
- 25 there shall be a hearing on the need for continued intervention.
- 26 (b) If the child is not returned home, the court shall establish in
- 27 writing:
- 28 (i) Whether reasonable services have been provided to or offered to
- 29 the parties to facilitate reunion, specifying the services provided or
- 30 offered;

- 1 (ii) Whether the child has been placed in the least-restrictive
- 2 setting appropriate to the child's needs, including whether
- 3 consideration has been given to placement with the child's relatives;
- 4 (iii) Whether there is a continuing need for placement and whether
- 5 the placement is appropriate;
- 6 (iv) Whether there has been compliance with the case plan by the
- 7 child, the child's parents, and the agency supervising the placement;
- 8 (v) Whether progress has been made toward correcting the problems
- 9 that necessitated the child's placement in out-of-home care;
- 10 (vi) Whether the parents have visited the child and any reasons why
- 11 visitation has not occurred or has been infrequent;
- 12 (vii) Whether additional services are needed to facilitate the
- 13 return of the child to the child's parents; if so, the court shall
- 14 order that reasonable services be offered specifying such services; and
- 15 (viii) The projected date by which the child will be returned home
- 16 or other permanent plan of care will be implemented.
- 17 (c) The court at the review hearing may order that a petition
- 18 seeking termination of the parent and child relationship be filed.
