SUBSTITUTE SENATE BILL 5413

State of Washington 52nd Legislature 1991 Regular Session

- 1 AN ACT Relating to the local master's degree teacher training
- 2 program; creating a new section; and making an appropriation.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** (1) The higher education coordinating
- 5 board shall establish a pilot program for the development of local
- 6 master's degree teacher training programs. The purpose of the program
- 7 is to plan for field based master's level education in local school
- 8 districts for teachers. The goals of the program are to:
- 9 (a) Test the feasibility of offering master's degrees in the local
- 10 school districts;
- 11 (b) Build a research base necessary to evaluate the effectiveness
- 12 of such programs; and
- 13 (c) Develop collaborative relationships between four-year
- 14 institutions and local school districts on innovative models for
- 15 teacher education.

- 1 (2) Field based master's degrees for teachers shall:
- 2 (a) Assure expertise in the art of teaching using the latest
- 3 research; and
- 4 (b) Include advanced study in specific subject matter areas, or
- 5 other areas of educational specialization.
- 6 (3) The pilot program shall provide for up to five grants to be
- 7 awarded by the higher education coordinating board to local school
- 8 districts or institutions of higher education. Special consideration
- 9 shall be given to proposals that involve cooperatives formed by two or
- 10 more school districts where teachers could be considered placebound.
- 11 (4) The proposals shall be developed by local advisory boards. The
- 12 local advisory boards shall include representation from higher
- 13 education institutions, local school districts, and classroom teachers.
- 14 At least fifty percent of the membership shall be teachers. Local
- 15 advisory boards and university faculty shall work with university
- 16 professional education advisory boards and local education associations
- 17 to develop proposals.
- 18 (5) Higher education participation is limited to institutions whose
- 19 main campuses are located in the state of Washington.
- 20 (6) Proposals shall be submitted to the higher education
- 21 coordinating board by August 1992, and shall document:
- 22 (a) Research on collegiality and peer coaching;
- 23 (b) Use of the latest teaching and student assessment research and
- 24 technologies;
- 25 (c) Understanding of the unique characteristics of a field based
- 26 model of graduate teacher training;
- 27 (d) Involvement of local teachers and other experts in the training
- 28 process;
- 29 (e) Commitment of the local school district to the program;

- 1 (f) Support from Washington institutions of higher education for
- 2 program development and implementation;
- 3 (g) Provision for formal evaluation of the project;
- 4 (h) Identification of an agreed upon fiscal agent; and
- 5 (i) Assurance and evidence of quality.
- 6 (7) A review committee is hereby established to make grant
- 7 recommendations to the higher education coordinating board. Review
- 8 committee composition shall be: Two participants from higher education
- 9 institutions; two representatives of the superintendent of public
- 10 instruction's office; two representatives of the state board of
- 11 education; and one representative designated by the higher education
- 12 coordinating board.
- 13 (8) The awards shall be granted by December 30, 1992.
- 14 (9) In granting the awards, the higher education coordinating board
- 15 shall ensure that the proposed degrees provide graduate level education
- 16 comparable in quality to that available at existing campus-based
- 17 graduate programs.
- 18 (10) All proposals for local master's degrees for teachers
- 19 involving public universities shall be approved by the higher education
- 20 coordinating board pursuant to procedures established by RCW
- 21 28B.80.340.
- 22 (11) The higher education coordinating board shall submit an
- 23 initial report on the program to the legislature by January 31, 1993.
- 24 <u>NEW SECTION.</u> **Sec. 2.** The sum of two hundred fifty thousand
- 25 dollars, or as much thereof as may be necessary, is appropriated for
- 26 the biennium ending June 30, 1993, from the general fund to the higher
- 27 education coordinating board for the purposes outlined in section 1 of
- 28 this act.
