Read first time February 1, 1991. Referred to Committee on Higher Education.

- AN ACT Relating to higher education; and amending RCW 28B.50.140,
- 2 28B.35.205, and 28B.40.206.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 28B.50.140 and 1990 c 135 s 1 are each amended to read
- 5 as follows:
- 6 Each community college board of trustees:
- 7 (1) Shall operate all existing community colleges and vocational-
- 8 technical institutes in its district;
- 9 (2) Shall create comprehensive programs of community college
- 10 education and training and maintain an open-door policy in accordance
- 11 with the provisions of RCW 28B.50.090(3);
- 12 (3) Shall employ for a period to be fixed by the board a college
- 13 president for each community college, a director for each vocational-
- 14 technical institute or school operated by a community college, a
- 15 district president, if deemed necessary by the board, in the event

- 1 there is more than one college and/or separated institute or school
- 2 located in the district, members of the faculty and such other
- 3 administrative officers and other employees as may be necessary or
- 4 appropriate and fix their salaries and duties. Salary increases shall
- 5 not exceed the amount or percentage established in the state
- 6 appropriations act by the legislature as allocated to the board of
- 7 trustees by the state board for community college education;
- 8 (4) May establish, under the approval and direction of the college
- 9 board, new facilities as community needs and interests demand.
- 10 However, the authority of community college boards of trustees to
- 11 purchase or lease major off-campus facilities shall be subject to the
- 12 approval of the higher education coordinating board pursuant to RCW
- 13 28B.80.340(5);
- 14 (5) May establish or lease, operate, equip and maintain
- 15 dormitories, food service facilities, bookstores and other self-
- 16 supporting facilities connected with the operation of the community
- 17 college;
- 18 (6) May, with the approval of the college board, borrow money and
- 19 issue and sell revenue bonds or other evidences of indebtedness for the
- 20 construction, reconstruction, erection, equipping with permanent
- 21 fixtures, demolition and major alteration of buildings or other capital
- 22 assets, and the acquisition of sites, rights-of-way, easements,
- 23 improvements or appurtenances, for dormitories, food service
- 24 facilities, and other self-supporting facilities connected with the
- 25 operation of the community college in accordance with the provisions of
- 26 RCW 28B.10.300 through 28B.10.330 where applicable;
- 27 (7) May establish fees and charges for the facilities authorized
- 28 hereunder, including reasonable rules and regulations for the
- 29 government thereof, not inconsistent with the rules and regulations of
- 30 the college board; each board of trustees operating a community college

- 1 may enter into agreements, subject to rules and regulations of the
- 2 college board, with owners of facilities to be used for housing
- 3 regarding the management, operation, and government of such facilities,
- 4 and any board entering into such an agreement may:
- 5 (a) Make rules and regulations for the government, management and
- 6 operation of such housing facilities deemed necessary or advisable; and
- 7 (b) Employ necessary employees to govern, manage and operate the
- 8 same;
- 9 (8) May receive such gifts, grants, conveyances, devises and
- 10 bequests of real or personal property from private sources, as may be
- 11 made from time to time, in trust or otherwise, whenever the terms and
- 12 conditions thereof will aid in carrying out the community college
- 13 programs as specified by law and the regulations of the state college
- 14 board; sell, lease or exchange, invest or expend the same or the
- 15 proceeds, rents, profits and income thereof according to the terms and
- 16 conditions thereof; and adopt regulations to govern the receipt and
- 17 expenditure of the proceeds, rents, profits and income thereof;
- 18 (9) May establish and maintain night schools whenever in the
- 19 discretion of the board of trustees it is deemed advisable, and
- 20 authorize classrooms and other facilities to be used for summer or
- 21 night schools, or for public meetings and for any other uses consistent
- 22 with the use of such classrooms or facilities for community college
- 23 purposes;
- 24 (10) May make rules and regulations for pedestrian and vehicular
- 25 traffic on property owned, operated, or maintained by the community
- 26 college district;
- 27 (11) Shall prescribe, with the assistance of the faculty, the
- 28 course of study in the various departments of the community college or
- 29 colleges under its control, and publish such catalogues and bulletins
- 30 as may become necessary;

- 1 (12) May grant to every student, upon graduation or completion of
- 2 a course of study, a suitable diploma, nonbaccalaureate degree or
- 3 certificate. The board, upon recommendation of the faculty, may also
- 4 confer honorary associate of arts degrees upon persons other than
- 5 graduates of the community college, in recognition of their learning or
- 6 devotion to education, literature, art, or science. No degree may be
- 7 conferred in consideration of the payment of money or the donation of
- 8 any kind of property;
- 9 (13) Shall enforce the rules and regulations prescribed by the
- 10 state board for community college education for the government of
- 11 community colleges, students and teachers, and promulgate such rules
- 12 and regulations and perform all other acts not inconsistent with law or
- 13 rules and regulations of the state board for community college
- 14 education as the board of trustees may in its discretion deem necessary
- 15 or appropriate to the administration of community college districts:
- 16 PROVIDED, That such rules and regulations shall include, but not be
- 17 limited to, rules and regulations relating to housing, scholarships,
- 18 conduct at the various community college facilities, and discipline:
- 19 PROVIDED, FURTHER, That the board of trustees may suspend or expel from
- 20 community colleges students who refuse to obey any of the duly
- 21 promulgated rules and regulations;
- 22 (14) May, by written order filed in its office, delegate to the
- 23 president or district president any of the powers and duties vested in
- 24 or imposed upon it by this chapter. Such delegated powers and duties
- 25 may be exercised in the name of the district board;
- 26 (15) May perform such other activities consistent with this chapter
- 27 and not in conflict with the directives of the college board;
- 28 (16) Notwithstanding any other provision of law, may offer
- 29 educational services on a contractual basis other than the tuition and
- 30 fee basis set forth in chapter 28B.15 RCW for a special fee to private

- 1 or governmental entities, consistent with rules and regulations adopted
- 2 by the state board for community college education: PROVIDED, That the
- 3 whole of such special fee shall go to the college district and be not
- 4 less than the full instructional costs of such services including any
- 5 salary increases authorized by the legislature for community college
- 6 employees during the term of the agreement: PROVIDED FURTHER, That
- 7 enrollments generated hereunder shall not be counted toward the
- 8 official enrollment level of the college district for state funding
- 9 purposes;
- 10 (17) Notwithstanding any other provision of law, may offer
- 11 educational services on a contractual basis, charging tuition and fees
- 12 as set forth in chapter 28B.15 RCW, counting such enrollments for state
- 13 funding purposes, and may additionally charge a special supplemental
- 14 fee when necessary to cover the full instructional costs of such
- 15 services: PROVIDED, That such contracts shall be subject to review by
- 16 the state board for community college education and to such rules as
- 17 the state board may adopt for that purpose in order to assure that the
- 18 sum of the supplemental fee and the normal state funding shall not
- 19 exceed the projected total cost of offering the educational service:
- 20 PROVIDED FURTHER, That enrollments generated by courses offered on the
- 21 basis of contracts requiring payment of a share of the normal costs of
- 22 the course will be discounted to the percentage provided by the
- 23 college;
- 24 (18) Shall be authorized to pay dues to any association of trustees
- 25 that may be formed by the various boards of trustees; such association
- 26 may expend any or all of such funds to submit biennially, or more often
- 27 if necessary, to the governor and to the legislature, the
- 28 recommendations of the association regarding changes which would affect
- 29 the efficiency of such association;

- 1 (19) Subject to the approval of the higher education coordinating
- 2 board pursuant to RCW 28B.80.340(4), may participate in higher
- 3 education centers and consortia that involve any four-year public or
- 4 independent college or university; and
- 5 (20) Shall perform any other duties and responsibilities imposed by
- 6 law or rule and regulation of the state board.
- 7 **Sec. 2.** RCW 28B.35.205 and 1985 c 370 s 84 are each amended to
- 8 read as follows:
- 9 In addition to all other powers and duties given to them by law,
- 10 Central Washington University, Eastern Washington University, and
- 11 Western Washington University are hereby authorized to grant any degree
- 12 through the master's degree to any student who has completed a program
- 13 of study and/or research in those areas which are determined by the
- 14 faculty and board of trustees of the college to be appropriate for the
- 15 granting of such degree: PROVIDED, That before any degree is
- 16 authorized under this section it shall be subject to the review and
- 17 approval of the higher education coordinating board.
- 18 The board of trustees, upon recommendation of the faculty, may also
- 19 confer honorary bachelor's or master's degrees upon persons other than
- 20 graduates of the institution, in recognition of their learning or
- 21 <u>devotion to education, literature, art, or science. No degree may be</u>
- 22 conferred in consideration of the payment of money or the donation of
- 23 <u>any kind of property.</u>
- 24 Sec. 3. RCW 28B.40.206 and 1985 c 370 s 85 are each amended to
- 25 read as follows:
- In addition to all other powers and duties given to them by law,
- 27 the board of trustees of The Evergreen State College is hereby
- 28 authorized to grant any degree through the master's degree to any

- 1 student who has completed a program of study and/or research in those
- 2 areas which are determined by the faculty and board of trustees of the
- 3 college to be appropriate for the granting of such degree: PROVIDED,
- 4 That any degree authorized under this section shall be subject to the
- 5 review and approval of the higher education coordinating board.
- 6 The board of trustees, upon recommendation of the faculty, may also
- 7 confer honorary bachelor's or master's degrees upon persons other than
- 8 graduates of the institution, in recognition of their learning or
- 9 <u>devotion to education, literature, art, or science. No degree may be</u>
- 10 conferred in consideration of the payment of money or the donation of
- 11 any kind of property.
