## SENATE BILL 5504

State of Washington 52nd Legislature 1991 Regular Session

- 1 AN ACT Relating to student teaching centers; adding new sections to
- 2 chapter 28A.415 RCW; repealing RCW 28A.625.420; and making an
- 3 appropriation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislature recognizes that:
- 6 (a) Strong teacher preparation programs are vital to the success of
- 7 the state's entire education system;
- 8 (b) Clinical field experiences, particularly student teaching, are
- 9 critical to the developmental preparation of teacher candidates and to
- 10 the success of teacher preparation programs;
- 11 (c) Schools, school districts, educational service districts, and
- 12 institutions of higher education benefit mutually from cooperative
- 13 relationships that provide teacher candidates with appropriate,
- 14 necessary, and successful student teaching experiences that establish
- 15 continuity between the theory and practice of teaching;

- 1 (d) Positive student teaching experiences result from the careful
- 2 match between cooperating teachers and student teachers;
- 3 (e) Teacher candidates should have student teaching opportunities
- 4 and other field experiences that are reflective of the diversity
- 5 existing among schools and school districts state-wide; and
- 6 (f) School districts state-wide should have access to student
- 7 teachers.
- 8 (2) Therefore, in support of quality, professional, research-based
- 9 training of prospective teachers, it is the intent of the legislature
- 10 to continue its support of evolving partnerships among schools, school
- 11 districts, educational service districts, community colleges, and
- 12 colleges and universities, that are:
- 13 (a) Benefiting the teaching profession;
- 14 (b) Enhancing the ability of all new teachers to assume initial
- 15 teaching responsibilities with greater confidence and a higher level of
- 16 training;
- 17 (c) Providing important and positive mentoring opportunities for
- 18 experienced teachers; and
- 19 (d) Strengthening cooperation and communication between the
- 20 precollegiate and collegiate sectors of the state education system.
- 21 <u>NEW SECTION.</u> **Sec. 2.** Unless the context clearly requires
- 22 otherwise, the definitions in this section apply throughout sections 3
- 23 through 9 of this act.
- 24 (1) "Cooperating organizations" means that at least one school
- 25 district, one college or university, and one educational service
- 26 district are involved jointly with the development of a student
- 27 teaching center.
- 28 (2) "Cooperating teacher" means a teacher who holds a continuing
- 29 certificate and supervises and coaches a student teacher.

- 1 (3) "Field experience" means opportunities for observation,
- 2 tutoring, microteaching, extended practicums, and clinical and
- 3 laboratory experiences which do not fall within the meaning of student
- 4 teaching.
- 5 (4) "School setting" means a classroom in a public, common school
- 6 in the state of Washington.
- 7 (5) "Student teacher" means a candidate for initial teacher
- 8 certification who is in a state board of education-approved, or
- 9 regionally or nationally accredited teacher preparation program in a
- 10 school setting as part of the field-based component of their
- 11 preparation program.
- 12 (6) "Student teaching" means the full quarter or semester in a
- 13 school setting during which the student teacher observes the
- 14 cooperating teacher, participates in instructional activities, and
- 15 assumes both part-time and full-time teaching responsibilities under
- 16 the supervision of the cooperating teacher.
- 17 (7) "Student teaching center" means the program established to
- 18 provide student teachers in a geographic region of the state with
- 19 special support and training as part of their teacher preparation
- 20 program.
- 21 (8) "Supervisor or university supervisor" means the regular or
- 22 adjunct faculty member, or college or university-approved designee, who
- 23 assists and supervises the work of cooperating teachers and student
- 24 teachers.
- 25 <u>NEW SECTION.</u> **Sec. 3.** (1) Cooperating teachers shall provide
- 26 a source of continuing and sustained assistance, coaching, and support
- 27 for student teachers, and may participate with supervisors in
- 28 evaluating student teachers, and shall submit recommendations to the
- 29 institutions of higher education respecting the competency of the

- 1 student teacher. Cooperating teachers shall collaborate with their
- 2 school principals respecting the support, training, and assistance they
- 3 provide to student teachers.
- 4 (2) All student teachers from an institution of higher education
- 5 whose preparation program has been approved by the state board of
- 6 education, or has been regionally or nationally accredited, shall be
- 7 provided a cooperating teacher.
- 8 (3) Cooperating teachers will be appointed by school districts in
- 9 a joint selection process with the institutions of higher education.
- 10 <u>NEW SECTION.</u> **Sec. 4.** Salary stipends for cooperating teachers
- 11 shall be paid through supplemental contracts under RCW 28A.400.200(4)
- 12 and as provided in the state operating appropriations act.
- 13 <u>NEW SECTION.</u> **Sec. 5.** The provisions of sections 3 and 4 of
- 14 this act shall apply to sections 6 through 9 of this act.
- 15 <u>NEW SECTION.</u> **Sec. 6.** The state board of education, from
- 16 appropriated funds, shall establish a network of student teaching
- 17 centers to support the continuing development of the field-based
- 18 component of teacher preparation programs. At least one center shall
- 19 be established in every educational service district region. The
- 20 purpose of the training centers is to:
- 21 (1) Expand opportunities for student teacher placements in school
- 22 districts state-wide, with an emphasis on those populations and
- 23 locations that are unserved or underserved;
- 24 (2) Provide cooperating teachers for all student teachers during
- 25 their student internship for up to two academic quarters;

- 1 (3) Enhance the student teaching component of teacher preparation
- 2 programs, including a placement of student teachers in special
- 3 education and multi-ethnic school settings; and
- 4 (4) Expand access to each other and opportunities for collaboration
- 5 in teacher education between colleges and universities and school
- 6 districts.
- 7 NEW SECTION. Sec. 7. Funds for the student teaching centers
- 8 shall be allocated by the superintendent of public instruction among
- 9 the educational service district regions on the basis of student
- 10 teaching placements. The fiscal agent for each center shall be either
- 11 an educational service district or a state institution of higher
- 12 education. Prospective fiscal agents shall document to the state board
- 13 of education the following information:
- 14 (1) The existing or proposed center was developed jointly through
- 15 a process including participation by at least one school district, one
- 16 college or university, and one educational service district;
- 17 (2) Primary administration for each center shall be the
- 18 responsibility of one or more of the cooperating organizations;
- 19 (3) Assurance that the training center program provides appropriate
- 20 and necessary training in observation, supervision, and assistance
- 21 skills and techniques for:
- 22 (a) Cooperating teachers;
- 23 (b) Other school building personnel; and
- 24 (c) School district employees.
- 25 <u>NEW SECTION.</u> **Sec. 8.** The student teaching centers shall be an
- 26 alternative means of placing teachers into school districts throughout
- 27 the state. Nothing in sections 1 through 9 of this act or RCW
- 28 28A.405.450 precludes a higher education institution that is not a

- 1 participant in a training center from placing student teachers into a
- 2 district that may be participating formally with other institutions in
- 3 a student teaching center program, or placing student teachers into
- 4 districts pursuant to an agreement between the institution and
- 5 district.
- 6 <u>NEW SECTION.</u> **Sec. 9.** Field experiences may be provided
- 7 through a student teaching center. The cost of providing such
- 8 experiences and opportunities shall be the sole responsibility of the
- 9 participants cooperating in the operation of the center.
- 10 <u>NEW SECTION.</u> **Sec. 10.** The state board of education and the
- 11 superintendent of public instruction shall adopt rules as necessary
- 12 under chapter 34.05 RCW to carry out the purposes of sections 1 through
- 13 9 of this act.
- 14 <u>NEW SECTION.</u> **Sec. 11.** RCW 28A.625.420 and 1990 1st ex.s. c 10
- 15 s 7 are each repealed.
- 16 <u>NEW SECTION.</u> **Sec. 12.** Sections 1 though 10 of this act are
- 17 each added to chapter 28A.415 RCW.
- 18 <u>NEW SECTION.</u> **Sec. 13.** The sum of two million three hundred
- 19 sixty thousand dollars, or as much thereof as may be necessary, is
- 20 appropriated for the biennium ending June 30, 1993, from the general
- 21 fund to the superintendent of public instruction for the purposes of
- 22 this act.
