State of Washington 52nd Legislature 1991 Regular Session

- 1 AN ACT Relating to increasing the use of van pools; adding a new
- 2 section to chapter 47.20 RCW; creating a new section; and making an
- 3 appropriation.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 <u>NEW SECTION.</u> **Sec. 1.** The legislature finds that traffic
- 6 congestion can be reduced efficiently by encouraging people to share
- 7 rides. The legislature further finds that passengers are attracted to
- 8 ridesharing if travel time is not adversely affected. Many potential
- 9 ridesharers are lost because the time to form car pools and van pools
- 10 by traveling to a central meeting place is perceived as a crucial
- 11 obstacle. Most car pools are formed from members of the same household
- 12 or from the same neighborhood. The legislature encourages the
- 13 exploration of means to increase the number of neighborhood-based van
- 14 pools.

- 1 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 47.20 RCW
- 2 to read as follows:
- 3 (1) The department of transportation shall contract with the
- 4 Washington state transportation center at the University of Washington
- 5 to conduct a study and make recommendations for legislation concerning
- 6 the following:
- 7 (a) How to create incentives to operate and participate in van
- 8 pools in neighborhood areas.
- 9 (b) How best to make van pool operation an attractive "cottage"
- 10 industry.
- 11 (c) Whether there exist reasonable alternatives to the traditional
- 12 meeting place approach to van pooling.
- 13 (d) Any other time savings factors that might encourage greater
- 14 participation in van pools.
- 15 (e) An assessment of costs and benefits associated with any
- 16 recommendation.
- 17 (2) The department of transportation shall report findings and
- 18 recommendations to the legislature no later than January 1, 1992.
- 19 <u>NEW SECTION.</u> **Sec. 3.** (1) The sum of forty-nine thousand
- 20 dollars, or as much thereof as may be necessary, is appropriated for
- 21 the biennium ending June 30, 1993, from the transportation fund to the
- 22 department of transportation for the purpose of implementing section 2
- 23 of this act.
- 24 (2) The contract, referred to under section 2 of this act, shall
- 25 call for the Washington state transportation center to use best efforts
- 26 to procure matching funds or other additional funds to assist in
- 27 fulfillment of the purposes set out under section 2 of this act.
