SUBSTITUTE SENATE BILL 5611

- 1 AN ACT Relating to a tax on the rental of fleet vehicles; and
- 2 creating a new section.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 <u>NEW SECTION.</u> **Sec. 1.** (1) The legislative transportation
- 5 committee, in cooperation with the state department of licensing, car
- 6 rental industry, the state department of transportation, the state
- 7 department of revenue, and other interested parties shall conduct a
- 8 study for the purpose of analyzing motor vehicle excise taxes imposed
- 9 upon car rental vehicles in the state of Washington. The study shall
- 10 include but not be limited to the following components:
- 11 (a) Whether the motor vehicle excise tax as now imposed upon the
- 12 car rental industry is fair and equitable;
- 13 (b) Whether there are alternative taxes that may be more equitably
- 14 applied to the car rental industry, and how such taxes would impact the
- 15 state, local governments including transit agencies, and the consumer;

- 1 (c) Whether alternative taxes will return to the state and local
- 2 governments including transit agencies an amount approximately equal to
- 3 that of the motor vehicle excise tax;
- 4 (d) Whether or not more rental vehicles would be purchased and
- 5 registered in-state as a result of proposed tax alternatives; and
- 6 (e) What, if any, additional costs or administrative difficulties
- 7 would result from alternative methods of taxation.
- 8 (2) The study participants shall agree upon the type and extent of
- 9 data required to analyze current and potential taxation alternatives.
- 10 At a minimum, total motor vehicle excise tax collections attributable
- 11 to rental car companies and total gross revenues as recorded on rental
- 12 car agreements shall be obtained. Other data elements that may be
- 13 considered include (a) usage of rental vehicles that have in-state
- 14 versus out-of-state plates and the associated revenue with such usage,
- 15 and (b) rental vehicles used in Washington and the associated revenue
- 16 generated from such vehicles that are registered under the
- 17 international registration plan.
- 18 (3) If the required data is not currently available, new methods
- 19 for obtaining the agreed upon data shall be developed by the
- 20 appropriate state agency or agencies to fulfill the purpose of this
- 21 study.
- 22 (4) The study shall include findings and recommendations and shall
- 23 be submitted to the legislative transportation committee no later than
- 24 January 1, 1993. An interim report shall be submitted by January 1,
- 25 1992.
