- 1 AN ACT Relating to advanced registered nurse practitioners;
- 2 amending RCW 18.88.010, 18.88.080, 18.88.160, 18.88.175, 18.88.220,
- 3 18.88.280, 18.88.285, 18.120.020, 18.130.040, 48.21.141, 48.44.290,
- 4 69.41.030, 69.45.010, 70.127.250, 71.05.210, 74.42.010, and 74.42.230;
- 5 reenacting and amending RCW 69.41.010 and 69.50.101; adding new
- 6 sections to chapter 18.88 RCW; creating a new section; and declaring an
- 7 emergency.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 9 <u>NEW SECTION.</u> **Sec. 1.** LEGISLATIVE INTENT. The legislature finds
- 10 that the prescribing of legend drugs and controlled substances by
- 11 nurses is an activity requiring specialized knowledge and training
- 12 beyond the level of a registered nurse.
- 13 The legislature further finds that appropriate protocols and
- 14 systems to monitor prescribing practices of nurses must be established
- 15 in order to assure the safe and effective prescribing of these drugs.

- 1 The legislature further finds that the development of educational
- 2 and training requirements necessary to prescribe drugs, practice
- 3 protocols to assure safe and effective prescribing practices, systems
- 4 to monitor the prescribing of drugs, and the discipline of nurses
- 5 authorized to prescribe drugs should jointly be done by the medical and
- 6 nursing professions.
- 7 The legislature declares that an advanced level of nursing should
- 8 be established whose members are authorized to prescribe drugs. The
- 9 legislature further declares that the prescribing of drugs should be
- 10 regulated by a separate board comprised of representatives of both the
- 11 medical and nursing professions.
- 12 <u>NEW SECTION.</u> **Sec. 2.** DEFINITIONS. Unless the context clearly
- 13 requires otherwise, the definitions in this section apply throughout
- 14 this chapter.
- 15 (1) "Advanced registered nurse practitioner" means an individual
- 16 licensed under this chapter.
- 17 (2) "Advanced registered nurse practitioner board" means the state
- 18 board of advanced registered nurse practitioners appointed by the
- 19 governor.
- 20 <u>NEW SECTION.</u> **Sec. 3.** SCOPE OF ADVANCED REGISTERED NURSE
- 21 PRACTITIONER PRACTICE. An advanced registered nurse practitioner is a
- 22 registered nurse prepared in a formal educational program to assume an
- 23 expanded role in providing health care services. This practice builds
- 24 on previous knowledge and skill and utilizes in-depth knowledge of
- 25 physical assessment and management of illnesses or conditions within
- 26 the advanced registered nurse practitioner's scope of practice.
- 27 Advanced registered nurse practice includes collaboration with other
- 28 licensed health professionals such as physicians, pharmacists,

- 1 podiatrists, dentists, and nurses. An advanced registered nurse
- 2 practitioner shall:
- 3 (1) Hold a current license to practice as a registered nurse in
- 4 Washington as provided in chapter 18.88 RCW; and
- 5 (2) Have completed an advanced formal education program in the area
- 6 of specialty; and
- 7 (3) Have been granted a certification credential for specialized
- 8 and advanced nursing practice granted by a national certifying body
- 9 whose certification program is approved by the board; and
- 10 (4) Have authority to prescribe legend drugs as defined in chapter
- 11 69.41 RCW and controlled substances, schedules II through V as defined
- 12 in chapter 69.50 RCW.
- 13 NEW SECTION. Sec. 4. LICENSE REQUIRED. After July 1, 1992, no
- 14 person may practice or represent oneself as an advanced registered
- 15 nurse practitioner unless licensed as both a registered nurse and as an
- 16 advanced registered nurse practitioner by the department or exempted
- 17 from licensure under this chapter.
- 18 <u>NEW SECTION.</u> **Sec. 5.** TRANSITION PERIOD. Until July 1, 1992, and
- 19 notwithstanding the provisions of sections 1 through 12 of this act,
- 20 nurses licensed under this chapter and authorized by the board to
- 21 prescribe legend drugs and schedule V controlled substances may
- 22 continue to prescribe these drugs.
- 23 <u>NEW SECTION.</u> **Sec. 6.** STATE BOARD OF ADVANCED REGISTERED NURSE
- 24 PRACTITIONERS. (1) There is created a state board of advanced
- 25 registered nurse practitioners which shall consist of eight members who
- 26 are citizens of the United States and are residents of this state and,
- 27 except for the state health officer are actively engaged in their areas

- 1 of practice. The governor shall make appointments to the board, except
- 2 that the state health officer shall be a standing member of the board.
- 3 (2) In addition to the state health officer, the advanced
- 4 registered nurse practitioner board shall be composed of:
- 5 (a) The four advanced registered nurse practitioner members of the
- 6 board shall be licensed as advanced registered nurse practitioners
- 7 under the provisions of this chapter, have had at least five years'
- 8 experience in the active practice of nursing and shall have been
- 9 engaged in practice within two years of appointment.
- 10 (b) The four physician members of the board shall be licensed as
- 11 physicians under chapter 18.71 RCW or osteopathic physicians under
- 12 chapter 18.57 RCW.
- 13 (3) Advanced registered nurse practitioner board members, except
- 14 the state health officer, shall serve for a term of five years until
- 15 their successors are appointed and qualified, except that the initial
- 16 appointments, which shall be made within ninety days after the
- 17 effective date of this act, shall be as follows:
- 18 (a) Two registered nurse practitioners and two physicians shall
- 19 serve for five years;
- 20 (b) The remaining appointed board members shall serve for three
- 21 years.
- 22 (4) Whenever a vacancy shall occur on the advanced registered nurse
- 23 practitioner board by reason other than the expiration of a term of
- 24 office, the governor shall appoint a successor of like qualifications
- 25 for the remainder of the unexpired term. No person shall serve as a
- 26 member of the board for more than two consecutive terms. No person may
- 27 concurrently serve on the advanced registered nurse practitioner board
- 28 and the boards regulating health care professions under chapters 18.57,
- 29 18.71, 18.72 RCW, or the state board of nursing as authorized by this
- 30 chapter.

- 1 (5) The governor may remove any appointed member from the advanced
- 2 registered nurse practitioner board for neglect of any duty required by
- 3 law, or for incompetency or unprofessional conduct as defined in
- 4 chapter 18.130 RCW.
- 5 (6) The advanced registered nurse practitioner board shall hold
- 6 regular annual meetings at which it shall select from its membership a
- 7 chair and vice-chair. Other meetings shall be held at such times as
- 8 the rules of the advanced registered nurse practitioner board may
- 9 provide. Special meetings may be held at such times as may be deemed
- 10 necessary or advisable by a majority of the members. Reasonable notice
- 11 of all meetings shall be given in a manner prescribed by the rules of
- 12 the advanced registered nurse practitioner board. A quorum of the
- 13 board shall consist of a majority of its members. The secretary of the
- 14 advanced registered nurse practitioner board shall be appointed by the
- 15 board and shall serve at the pleasure of the board. The secretary may
- 16 or may not be a member of the advanced registered nurse practitioner
- 17 board. The advanced registered nurse practitioner board shall work
- 18 with and through the department.
- 19 (7) Each member of the advanced registered nurse practitioner board
- 20 shall, in addition to travel expenses in accordance with RCW 43.03.050
- 21 and 43.03.060 while away from home, be compensated in accordance with
- 22 RCW 43.03.240.
- 23 <u>NEW SECTION.</u> **Sec. 7.** POWERS AND DUTIES OF THE ADVANCED REGISTERED
- 24 NURSE PRACTITIONER BOARD AND THE BOARD OF NURSING WITH RESPECT TO
- 25 ADVANCED REGISTERED NURSE PRACTITIONER PRACTICE. (1) In addition to
- 26 any other authority provided by law, the advanced registered nurse
- 27 practitioner board shall:
- 28 (a) Prescribe, publish, adopt and amend rules for the
- 29 implementation of sections 1 through 12 of this act including rules

- 1 that delineate qualifications for granting and regulating the
- 2 prescriptive authority of advanced registered nurse practitioners for
- 3 the use of legend drugs and controlled substances, schedules II through
- 4 V;
- 5 (b) Establish standards of professional conduct and to serve as the
- 6 disciplining authority for advanced registered nurse practitioners on
- 7 all disciplinary matters; and
- 8 (c) Recognize and consider the education and training of practicing
- 9 nurses who were authorized by the advanced registered nurse
- 10 practitioner board to have prescriptive authority for legend drugs and
- 11 schedule V controlled substances prior to the effective date of this
- 12 act. The advanced registered nurse practitioner board shall minimize
- 13 the additional education and training of such persons to those areas
- 14 relating to the additional prescriptive authority authorized under this
- 15 chapter;
- 16 (d) Establish the requirements for a prescriptive authority use
- 17 plan that outlines procedures and protocols for consultation and
- 18 referral with other health care professionals.
- 19 (2) Except for provisions of subsection (1) of this section, all
- 20 other matters pertaining to licensure of an advanced registered nurse
- 21 practitioner shall be determined and governed by the state board of
- 22 nursing. These matters include, but are not limited to, delineating
- 23 the qualifications for licensure of advanced registered nurse
- 24 practitioners; specifying requirements for the renewal of licensure;
- 25 approving accrediting and certification bodies for the purpose of
- 26 licensure of advanced registered nurse practitioners, approving
- 27 curricula, establishing criteria for minimum standards for schools
- 28 preparing persons for licensure under this chapter.
- 29 (3) The advanced registered nurse practitioner board and the board
- 30 shall coordinate to assure the implementation of this chapter.

- 1 NEW SECTION. Sec. 8. DUTIES OF THE DEPARTMENT. In mutual
- 2 consultation with the advanced registered nurse practitioner board, the
- 3 department shall:
- 4 (1) Establish forms and procedures necessary to administer sections
- 5 1 through 12 of this act;
- 6 (2) Hire clerical, administrative, investigative, and other staff
- 7 as needed to implement sections 1 through 12 of this act;
- 8 (3) Keep an official record of all proceedings. A part of the
- 9 record shall consist of a register of all applicants for licensure as
- 10 an advanced registered nurse practitioner under this chapter and the
- 11 results of each application; and
- 12 (4) To the extent possible the department shall minimize costs by
- 13 coordinating whenever possible clerical, investigative, and
- 14 administrative activities associated with the board and the advanced
- 15 registered nurse practitioner board operation.
- 16 <u>NEW SECTION.</u> **Sec. 9.** QUALIFICATIONS OF APPLICANTS FOR LICENSE.
- 17 An applicant for a license to practice as an advanced registered nurse
- 18 practitioner shall submit to the advanced registered nurse practitioner
- 19 board (1) an attested written application on department forms; (2)
- 20 written official evidence of diploma from an approved school of
- 21 nursing; (3) proof of licensure as a registered nurse as provided for
- 22 under this chapter; (4) a prescriptive authority use plan for
- 23 consultation and referral as defined in section 7 of this act; and (5)
- 24 any other official records specified by the advanced registered nurse
- 25 practitioner board. The applicant at the time of such submission must
- 26 not be in violation of chapter 18.130 RCW or any provision of this
- 27 chapter.

- 1 <u>NEW SECTION.</u> **Sec. 10.** EXAMINATIONS. The applicant shall be
- 2 required to pass a written examination in such subjects as the advanced
- 3 registered nurse practitioner board shall determine. Each written
- 4 examination may be supplemented by an oral and practical examination.
- 5 The advanced registered nurse practitioner board shall establish the
- 6 standards for passing.
- 7 <u>NEW SECTION.</u> **Sec. 11.** LICENSURE BY ENDORSEMENT. Upon advanced
- 8 registered nurse practitioner board approval of the application, the
- 9 department shall issue a license by endorsement to practice as an
- 10 advanced registered nurse practitioner without examination to an
- 11 applicant who is duly licensed as a registered nurse and an advanced
- 12 registered nurse practitioner, or its equivalent, by examination under
- 13 the laws of another state, territory or possession of the United States
- 14 and who meets all other qualifications for licensure.
- 15 An applicant graduated from a school of nursing outside the United
- 16 States and licensed by a country outside the United States shall meet
- 17 all qualifications required by this chapter and by the board and shall
- 18 pass examinations as determined by the board and the advanced
- 19 registered nurse practitioner board.
- 20 <u>NEW SECTION.</u> **Sec. 12.** USE OF NOMENCLATURE. Any person who holds
- 21 a license to practice as an advanced registered nurse practitioner in
- 22 this state shall have the right to use the title "advanced registered
- 23 nurse practitioner" and the abbreviations "ARNP" or "A.R.N.P.". No
- 24 other person shall assume such title or use such abbreviation or any
- 25 other words, letters, signs, or figures to indicate that the person
- 26 using them is an advanced registered nurse practitioner.

- 1 Sec. 13. RCW 18.88.010 and 1973 c 133 s 1 are each amended to read
- In order to safeguard life, health and to promote public welfare,
- 4 any person practicing or offering to practice nursing as a registered
- 5 nurse or as an advanced registered nurse practitioner in this state
- 6 shall hereafter be required to submit evidence that he or she is
- 7 qualified so to practice, and shall be licensed as hereinafter
- 8 provided. The registered nurse ((is)) and the advanced registered
- 9 <u>nurse practitioner are</u> directly accountable and responsible to the
- 10 individual consumer for the quality of nursing care rendered.
- 11 Sec. 14. RCW 18.88.080 and 1988 c 211 s 8 are each amended to read
- 12 as follows:

- The board may adopt such rules ((and regulations)) not inconsistent
- 14 with the law, as may be necessary to enable it to carry into effect the
- 15 provisions of this chapter. The board shall approve curricula and
- 16 shall establish criteria for minimum standards for schools preparing
- 17 persons for licensure under this chapter. It shall keep a record of
- 18 all its proceedings and make such reports to the governor as may be
- 19 required. The board shall define by ((regulation)) rule what
- 20 constitutes specialized and advanced levels of nursing practice as
- 21 recognized by the medical and nursing professions. The board shall not
- 22 <u>define specialized or advanced levels of practice involving the</u>
- 23 prescribing of legend drugs or controlled substances. The board may
- 24 adopt ((regulations)) rules or issue advisory opinions in response to
- 25 questions put to it by professional health associations, nursing
- 26 practitioners, and consumers in this state concerning the authority of
- 27 various categories of nursing practitioners to perform particular acts.
- 28 The board shall approve such schools of nursing as meet the

- 2 criteria as to the need for and the size of a program and the type of
- 3 program and the geographical location. The board shall establish
- 4 criteria for proof of reasonable currency of knowledge and skill as a
- 5 basis for safe practice after three years inactive or lapsed status.
- 6 The board shall establish criteria for licensure by endorsement. The
- 7 board shall examine all applications for registration under this
- 8 chapter, and shall certify to the director for licensing duly qualified
- 9 applicants.
- 10 The department shall furnish to the board such secretarial,
- 11 clerical and other assistance as may be necessary to effectively
- 12 administer the provisions of this chapter. Each member of the board
- 13 shall, in addition to travel expenses in accordance with RCW 43.03.050
- 14 and 43.03.060 while away from home, be compensated in accordance with
- 15 RCW 43.03.240.
- 16 Sec. 15. RCW 18.88.160 and 1985 c 7 s 68 are each amended to read
- 17 as follows:
- 18 Each applicant for a license to practice as a registered nurse or
- 19 a specialized or an advanced registered nurse practitioner shall pay a
- 20 fee determined by the director as provided in RCW 43.24.086 to the
- 21 state treasurer. All fees collected shall be used to support the
- 22 <u>activities of the board, the advanced registered nurse practitioner</u>
- 23 board, and the department for implementation of this chapter. The
- 24 costs of supporting the board and the advanced registered nurse
- 25 practitioner board and their activities shall be borne equally by all
- 26 registered nurses and advanced registered nurses licensed under this
- 27 <u>chapter</u>.

- the discharge of his or her official duties; (8) permitting the 1 2 measurement of the powers or range of human vision, or the determination of the accommodation and refractive state of the human 3 4 eye or the scope of its functions in general, or the fitting or adaptation of lenses or frames for the aid thereof; (9) permitting the 5 6 prescribing or directing the use of, or using, any optical device in connection with ocular exercises, visual training, vision training or 7 orthoptics; (10) permitting the prescribing of contact lenses for, or 8 9 the fitting or adaptation of contact lenses to, the human eye; (11) prohibiting the performance of routine visual screening; 10 (12)permitting the practice of dentistry or dental hygiene as defined in 11 12 chapters 18.32 and 18.29 RCW respectively; (13) permitting the practice of chiropractic as defined in chapter 18.25 RCW including the 13 14 adjustment or manipulation of the articulations of the spine; (14) permitting the practice of ((podiatry)) podiatric medicine and surgery 15 as defined in chapter 18.22 RCW; (15) permitting the performance of 16 17 major surgery, except such minor surgery as the board may have 18 specifically authorized by rule or regulation duly adopted in 19 accordance with the provisions of chapter 34.05 RCW; (16) permitting 20 the prescribing of <u>legend drugs and</u> controlled substances as defined in schedules I through  $((\exists \forall))$  V of the Uniform Controlled Substances Act, 21 chapter 69.50 RCW, except as provided for in this chapter, chapters 22 69.41, 69.45, and 69.50 RCW; (17) prohibiting the determination and 23 24 pronouncement of death.

- 1 the course thereof, she or he is authorized to do the following things

- 17 (5) To hold herself or himself out to the public or designate
- 18 herself or himself as an advanced registered nurse practitioner, a
- 19 registered nurse, or nurse.
- 20 **Sec. 20.** RCW 18.120.020 and 1989 c 300 s 14 are each amended to
- 21 read as follows:
- The definitions contained in this section shall apply throughout
- 23 this chapter unless the context clearly requires otherwise.
- 24 (1) "Applicant group" includes any health professional group or
- 25 organization, any individual, or any other interested party which
- 26 proposes that any health professional group not presently regulated be
- 27 regulated or which proposes to substantially increase the scope of
- 28 practice of the profession.

- 1 (2) "Certificate" and "certification" mean a voluntary process by
  2 which a statutory regulatory entity grants recognition to an individual
  3 who (a) has met certain prerequisite qualifications specified by that
  4 regulatory entity, and (b) may assume or use "certified" in the title
  5 or designation to perform prescribed health professional tasks.
- 6 (3) "Grandfather clause" means a provision in a regulatory statute
  7 applicable to practitioners actively engaged in the regulated health
  8 profession prior to the effective date of the regulatory statute which
  9 exempts the practitioners from meeting the prerequisite qualifications
  10 set forth in the regulatory statute to perform prescribed occupational
  11 tasks.
