## SENATE BILL 5669

State of Washington 52nd Legislature 1991 Regular Session

By Senators Niemi and West.

Read first time February 14, 1991. Referred to Committee on Health & Long-Term Care.

- 1 AN ACT Relating to housing trust fund priorities for projects
- 2 submitted by regional support networks; and amending RCW 43.185.010,
- 3 43.185.060, 43.185.070, 43.185.080, 43.185.110, and 71.24.300.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 5 **Sec. 1.** RCW 43.185.010 and 1986 c 298 s 1 are each amended to read
- 6 as follows:
- 7 The legislature finds that current economic conditions, federal
- 8 housing policies and declining resources at the federal, state, and
- 9 local level adversely affect the ability of low and very low-income
- 10 persons to obtain safe, decent, and affordable housing.
- 11 The legislature further finds that members of over one hundred
- 12 twenty thousand households live in housing units which are overcrowded,
- 13 lack plumbing, are otherwise threatening to health and safety, and have
- 14 rents and utility payments which exceed thirty percent of their income.

- 1 The legislature further finds that minorities, rural households,
- 2 and migrant farm workers require housing assistance at a rate which
- 3 significantly exceeds their proportion of the general population.
- 4 The legislature further finds that one of the most dramatic housing
- 5 needs is that of persons needing special housing-related services, such
- 6 as the mentally ill, recovering alcoholics, frail elderly persons, and
- 7 single parents. These services include medical assistance, counseling,
- 8 chore services, and child care.
- 9 The legislature further finds that a major duty of regional support
- 10 networks authorized under chapter 71.24 RCW is to plan and develop for
- 11 mentally ill persons systems of community support which have housing
- 12 and housing support at their center.
- 13 The legislature further finds that housing assistance programs in
- 14 the past have often failed to help those in greatest need.
- 15 The legislature declares that it is in the public interest to
- 16 establish a continuously renewable resource known as a housing trust
- 17 fund to assist low and very low-income citizens in meeting their basic
- 18 housing needs, and that the needs of very low-income citizens should be
- 19 given priority.
- 20 **Sec. 2.** RCW 43.185.060 and 1986 c 298 s 7 are each amended to read
- 21 as follows:
- Organizations that may receive assistance from the department under
- 23 this chapter are local governments, local housing authorities, regional
- 24 support networks established under chapter 71.24 RCW, nonprofit
- 25 community or neighborhood-based organizations, and regional or state-
- 26 wide nonprofit housing assistance organizations.
- 27 **Sec. 3.** RCW 43.185.070 and 1988 c 286 s 1 are each amended to read
- 28 as follows:

- (1) During each calendar year in which funds are available for use 1 2 by the department from the housing trust fund, as prescribed in RCW 43.185.030, the department shall announce to all known interested 3 4 parties, and through major media throughout the state, a grant and loan application period of at least ninety days' duration. 5 6 announcement shall be made as often as the director deems appropriate for proper utilization of resources, but at least twice annually. 7 department shall then promptly grant as many applications as will 8 9 utilize available funds less appropriate administrative costs of the 10 department, not to exceed thirty-seven thousand five hundred dollars in the fiscal year ending June 30, 1988, and seventy-five thousand dollars 11 12 in the fiscal year ending June 30, 1989, and not to exceed five percent of annual revenues to the fund thereafter. 13
- 14 (2) The department shall give first priority to applications: (a) 15 Submitted before July 1, 1995, for projects and activities, including projects authorized under RCW 43.185.050(2)(b) through (d), that are 16 17 identified by regional support networks as supporting the housing needs 18 of mentally ill persons according to the priorities established in 19 <u>chapter 71.24 RCW, and (b)</u> for projects and activities <u>for other</u> 20 populations which utilize existing privately owned housing stock including privately owned housing stock purchased by nonprofit public 21 Such projects and activities shall be 22 development authorities. evaluated under subsection (3) of this section. Second priority shall 23 24 be given to activities and projects which utilize existing publicly 25 owned housing stock. Such projects and activities shall be evaluated
- 27 (3) The department shall give preference for applications based on 28 the following criteria:

under subsection (3) of this section.

- 1 (a) The degree of leveraging of other funds that will occur,
- 2 <u>especially the leveraging of available resources as defined in chapter</u>
- 3 <u>71.24 RCW</u>;
- 4 (b) Recipient contributions to total project costs, including
- 5 allied contributions from other sources such as professional, craft and
- 6 trade services, and lender interest rate subsidies;
- 7 (c) Local government project contributions in the form of
- 8 infrastructure improvements, and others, except for projects identified
- 9 or submitted by regional support networks;
- 10 (d) Projects that encourage ownership, management, and other
- 11 project-related responsibility opportunities, except for projects
- 12 <u>identified or submitted by regional support networks</u>;
- 13 (e) Projects that demonstrate a strong probability of serving the
- 14 original target group or income level for a period of at least fifteen
- 15 years, except for projects identified or submitted by regional support
- 16 <u>networks</u>;
- 17 (f) The applicant has the demonstrated ability, stability and
- 18 resources to implement the project;
- 19 (q) Projects which demonstrate serving the greatest need; and
- 20 (h) Projects that provide housing for persons and families with the
- 21 lowest incomes, except for projects identified or submitted by regional
- 22 <u>support networks</u>.
- 23 **Sec. 4.** RCW 43.185.080 and 1986 c 298 s 9 are each amended to read
- 24 as follows:
- 25 (1) The department may use moneys from the housing trust fund to
- 26 provide preconstruction technical assistance to eligible recipients
- 27 seeking to construct, rehabilitate, or finance housing-related services
- 28 for very low and low-income persons or mentally ill persons as defined
- 29 <u>in chapter 71.24 RCW</u>. The department shall emphasize providing

- 1 planning or preconstruction technical assistance services to regional
- 2 support networks as defined in chapter 71.24 RCW, rural areas, and
- 3 small cities and towns. The department may contract with nonprofit
- 4 organizations to provide this technical assistance. The department may
- 5 contract for any of the following services:
- 6 (a) Financial planning and packaging for housing projects,
- 7 including alternative ownership programs, such as limited equity
- 8 partnerships and syndications;
- 9 (b) Project design, architectural planning, and siting;
- 10 (c) Compliance with planning requirements;
- 11 (d) Securing matching resources for project development;
- 12 (e) Maximizing local government contributions to project
- 13 development in the form of land donations, infrastructure improvements,
- 14 waivers of development fees, locally and state-managed funds, zoning
- 15 variances, or creative local planning;
- 16 (f) Coordination with local planning, economic development, and
- 17 environmental, social service, and recreational activities, including
- 18 integrating housing support project requests with regional support
- 19 <u>network plans developed under chapter 71.24 RCW;</u>
- 20 (g) Construction and materials management; and
- 21 (h) Project maintenance and management.
- 22 (2) The department shall publish requests for proposals which
- 23 specify contract performance standards, award criteria, and contractor
- 24 requirements. In evaluating proposals, the department shall consider
- 25 the ability of the contractor to provide technical assistance to low
- 26 and very low-income persons and to persons with special housing needs.
- 27 **Sec. 5.** RCW 43.185.110 and 1987 c 513 s 3 are each amended to read
- 28 as follows:

1 The director shall prepare an annual report that includes housing 2 support projects funded for the mentally ill and shall send copies to the chairs of the house of representatives committees on housing and 3 4 health care, the chairs of the senate committees on commerce and labor and health and long-term care, and one copy to the staff of each 5 6 committee that summarizes the housing trust fund's income, grants and operating expenses, implementation of its program, and any problems 7 arising in the administration thereof. The director shall promptly 8 9 appoint a low-income housing assistance advisory committee composed of 10 a representative from each of the following groups: Apartment owners, 11 realtors, mortgage lending or servicing institutions, private nonprofit housing assistance programs, tenant associations, and public housing 12 assistance programs. The advisory group shall advise the director on 13 14 housing needs in this state, operational aspects of the grant and loan program or revenue collection programs established by this chapter, and 15 16 implementation of the policy and goals of this chapter.

17 **Sec. 6.** RCW 71.24.300 and 1989 c 205 s 5 are each amended to read 18 as follows:

19 A county authority or a group of county authorities whose combined population is no less than forty thousand may enter into a joint 20 operating agreement to form a regional support network. The roles and 21 responsibilities of county authorities shall be determined by the terms 22 of that agreement and the provisions of law. The state mental health 23 24 authority may not determine the roles and responsibilities of county authorities as to each other under regional support networks by rule, 25 except to assure that all duties required of regional support networks 26 27 are assigned and that a single authority has final responsibility for 28 all available resources and performance under the regional support network's contract with the secretary. 29

- 1 (1) Regional support networks shall within three months of
- 2 recognition submit an overall six-year operating and capital plan,
- 3 timeline, and budget and submit progress reports and an updated two-
- 4 year plan biennially thereafter, to assume within available resources
- 5 all of the following duties by July 1, 1995, instead of those presently
- 6 assigned to counties under RCW 71.24.045(1):
- 7 (a) Administer and provide for the availability of all resource
- 8 management services, residential services, and community support
- 9 services.
- 10 (b) Administer and provide for the availability of all
- 11 investigation, transportation, court-related, and other services
- 12 provided by the state or counties pursuant to chapter 71.05 RCW.
- 13 (c) By July 1, 1993, provide within the boundaries of each regional
- 14 support network evaluation and treatment services for at least eighty-
- 15 five percent of persons detained or committed for periods up to
- 16 seventeen days according to chapter 71.05 RCW. Regional support
- 17 networks with populations of less than one hundred fifty thousand may
- 18 contract to purchase evaluation and treatment services from other
- 19 networks. For regional support networks that are created after June
- 20 30, 1991, the requirements of (c) of this subsection must be met by
- 21 July 1, 1995.
- 22 (d) By July 1, 1993, administer a portion of funds appropriated by
- 23 the legislature to house mentally ill persons in state institutions
- 24 from counties within the boundaries of any regional support network,
- 25 with the exception of mentally ill offenders, and provide for the care
- 26 of all persons needing evaluation and treatment services for periods up
- 27 to seventeen days according to chapter 71.05 RCW in appropriate
- 28 residential services, which may include state institutions. The
- 29 regional support networks shall reimburse the state for use of state
- 30 institutions at a rate equal to that assumed by the legislature when

- 1 appropriating funds for such care at state institutions during the
- 2 biennium when reimbursement occurs. The duty of a state hospital to
- 3 accept persons for evaluation and treatment under chapter 71.05 RCW is
- 4 limited by the responsibilities assigned to regional support networks
- 5 under this section. For regional support networks that are created
- 6 after June 30, 1991, the requirements of (d) of this subsection must be
- 7 met by July 1, 1995.
- 8 (e) Administer and provide for the availability of all other mental
- 9 health services, which shall include patient counseling, day treatment,
- 10 consultation, education services, and mental health services to
- 11 children as provided in this chapter.
- 12 (f) Establish standards and procedures for reviewing individual
- 13 service plans and determining when that person may be discharged from
- 14 resource management services.
- 15 (2) Regional support networks shall assume all duties assigned to
- 16 county authorities by this chapter and chapter 71.05 RCW.
- 17 (3) A regional support network may request that any state-owned
- 18 land, building, facility, or other capital asset which was ever
- 19 purchased, deeded, given, or placed in trust for the care of the
- 20 mentally ill and which is within the boundaries of a regional support
- 21 network be made available to support the operations of the regional
- 22 support network. State agencies managing such capital assets shall
- 23 give first priority to requests for their use pursuant to this chapter.
- 24 (4) Each regional support network shall appoint a mental health
- 25 advisory board which shall review and provide comments on plans and
- 26 policies developed under this chapter. The composition of the board
- 27 shall be broadly representative of the demographic character of the
- 28 region and the mentally ill persons served therein. Length of terms of
- 29 board members shall be determined by the regional support network.

- 1 (5) Regional support networks shall assume all duties specified in 2 their plans and joint operating agreements through biennial contractual
- 3 agreements with the secretary.
- 4 (6) Counties or groups of counties participating in a regional
- 5 support network are not subject to RCW 71.24.045(7). The office of
- 6 financial management shall consider information gathered in studies
- 7 required in this chapter and information about the experience of other
- 8 states to propose a mental health services administrative cost lid to
- 9 the 1991 legislature which shall include administrative costs of
- 10 licensed service providers, the state psychiatric hospitals and the
- 11 department.
- 12 (7) The first regional support network contract may include a pilot
- 13 project to: Establish standards and procedures for (a) making
- 14 referrals for comprehensive medical examinations and treatment programs
- 15 for those whose mental illness is caused or exacerbated by organic
- 16 disease, and (b) training staff in recognizing the relationship between
- 17 mental illness and organic disease.
- 18 (8) Regional support networks may receive technical assistance from
- 19 the housing trust fund and may identify and submit projects for housing
- 20 and housing support services to the housing trust fund established
- 21 under chapter 43.185 RCW. Projects identified or submitted under this
- 22 section must be fully integrated with the regional support network six-
- 23 year operating and capital plan, timeline, and budget required by
- 24 <u>subsection (1) of this section.</u>
