- 1 AN ACT Relating to the department of wildlife; amending RCW
- 2 75.25.005, 75.25.080, 75.25.095, 75.25.170, and 75.25.180; adding new
- 3 sections to chapter 77.12 RCW; adding a new chapter to Title 77 RCW;
- 4 creating a new section; recodifying RCW 75.25.005, 75.25.015,
- 5 75.25.040, 75.25.080, 75.25.090, 75.25.095, 75.25.100, 75.25.110,
- 6 75.25.120, 75.25.126, 75.25.130, 75.25.140, 75.25.150, 75.25.160,
- 7 75.25.170, 75.25.180, 75.25.190, 75.25.200, 75.25.901, and 75.25.902;
- 8 and providing an effective date.
- 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 10 <u>NEW SECTION.</u> **Sec. 1.** A new section is added to chapter 77.12 RCW
- 11 to read as follows:
- 12 The director of wildlife shall administer all licenses, tags, and
- 13 permits currently authorized under the statutes governing the
- 14 department of wildlife. Additionally, the director shall also

- 1 administer all recreational licenses currently authorized under the
- 2 statutes that govern the department of fisheries.
- 3 The director shall establish rules for the administration of a
- 4 combined recreational license format. The combined license format
- 5 shall be similar to the format prescribed by the Washington state
- 6 commission for efficiency and accountability in government's January
- 7 1991 report entitled combined sport hunting and fishing license study.
- 8 The combined license format shall seek to minimize costs of
- 9 administration, reduce paperwork for recreational fishers, and provide
- 10 for easier issuance by license dealers.
- 11 <u>NEW SECTION.</u> **Sec. 2.** A new section is added to chapter 77.12 RCW
- 12 to read as follows:
- 13 All revenue that results from the sale of recreational food fish
- 14 licenses shall be placed in the wildlife fund, under RCW 77.12.170.
- 15 **Sec. 3.** RCW 75.25.005 and 1989 c 305 s 1 are each amended to read
- 16 as follows:
- 17 The following recreational fishing licenses are administered and
- 18 issued by the department of ((fisheries)) wildlife under authority of
- 19 the director ((of fisheries)):
- 20 (1) Hood Canal shrimp license;
- 21 (2) Razor clam license;
- 22 (3) Personal use fishing license;
- 23 (4) Salmon license; and
- 24 (5) Sturgeon license.
- 25 **Sec. 4.** RCW 75.25.080 and 1989 c 305 s 4 are each amended to read
- 26 as follows:

- 1 (1) It is lawful to dig the personal-use daily bag limit of razor
- 2 clams for another person if that person has in possession a physical
- 3 disability permit issued by the director.
- 4 (2) An application for a physical disability permit must be
- 5 submitted on a department of ((fisheries)) wildlife official form and
- 6 must be accompanied by a licensed medical doctor's certification of
- 7 disability.
- 8 Sec. 5. RCW 75.25.095 and 1990 c 34 s 2 are each amended to read
- 9 as follows:
- 10 Notwithstanding RCW 75.25.090 (as recodified by this act), the
- 11 director may adopt rules designating times and places for the purposes
- 12 of family fishing days when a recreational fishing license is not
- 13 required to fish for food fish or shellfish. All other applicable laws
- 14 and rules shall remain in effect.
- 15 **Sec. 6.** RCW 75.25.170 and 1989 c 305 s 16 are each amended to read
- 16 as follows:
- 17 Fees received for recreational licenses required under this chapter
- 18 shall be deposited in the ((general)) wildlife fund and shall be
- 19 appropriated for management, enhancement, research, and enforcement
- 20 purposes of the shellfish, salmon, and marine fish programs of the
- 21 department of ((fisheries)) wildlife.
- 22 **Sec. 7.** RCW 75.25.180 and 1989 c 305 s 14 are each amended to read
- 23 as follows:
- 24 Recreational licenses issued by the department of ((fisheries))
- 25 <u>wildlife</u> under this chapter are valid for the following periods:
- 26 (1) Recreational licenses issued without charge to persons
- 27 designated by this chapter are valid:

- 1 (a) For life for blind persons;
- 2 (b) For the period of continued state residency for qualified
- 3 disabled veterans;
- 4 (c) For the period of continued state residency for persons sixty-
- 5 five years of age or more;
- 6 (d) For the period of the disability for persons with a
- 7 developmental disability;
- 8 (e) For life for handicapped persons confined to a wheelchair who
- 9 have been issued a permanent disability card; and
- 10 (f) Until a child reaches fifteen years of age.
- 11 (2) Two-consecutive-day personal use licenses expire at midnight on
- 12 the day following the validation date written on the license by the
- 13 license dealer, except two-consecutive-day personal use licenses
- 14 validated for December 31 expire at midnight on that date.
- 15 (3) An annual salmon license is valid for a maximum catch of
- 16 fifteen salmon, after which another salmon license may be purchased.
- 17 A salmon license is valid only for the calendar year for which it is
- 18 issued.
- 19 (4) An annual sturgeon license is valid for a maximum catch of
- 20 fifteen sturgeon. A sturgeon license is valid only for the calendar
- 21 year for which it is issued.
- 22 (5) All other recreational licenses are valid for the calendar year
- 23 for which they are issued.
- 24 NEW SECTION. Sec. 8. RCW 75.25.005, 75.25.015, 75.25.040,
- 25 75.25.080, 75.25.090, 75.25.095, 75.25.100, 75.25.110, 75.25.120,
- 26 75.25.126, 75.25.130, 75.25.140, 75.25.150, 75.25.160, 75.25.170,
- 27 75.25.180, 75.25.190, 75.25.200, 75.25.901, and 75.25.902 are each
- 28 recodified as a new chapter in Title 77 RCW.

- 1 <u>NEW SECTION.</u> **Sec. 9.** The code reviser shall correct all
- 2 statutory references to code sections recodified by section 8 of this
- 3 act.
- 4 NEW SECTION. Sec. 10. This act shall take effect January 1,
- 5 1992.
