- 1 AN ACT Relating to the department of information services; amending
- 2 RCW 43.105.032; and adding new sections to chapter 43.105 RCW.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 43.105.032 and 1987 c 504 s 4 are each amended to read
- 5 as follows:
- 6 (1) There is hereby created the Washington state information
- 7 services board. The board shall be ((composed)) comprised of ((nine))
- 8 the members ((. Seven members shall be appointed by the governor, and
- 9 serving at the governor's pleasure as follows: Three representatives
- 10 from cabinet agencies, one representative from higher education, one
- 11 representative from a noncabinet executive agency, and two
- 12 representatives from the private sector. One member shall represent
- 13 the judicial branch and be appointed by the chief justice of the
- 14 supreme court. One member shall represent the legislative branch and

- 1 shall be selected by the president of the senate and the speaker of the
- 2 house of representatives)) identified under section 2 of this act.
- 3 ((These)) (2) The members under section 2 of this act shall
- 4 constitute the membership of the board with full voting rights. ((The
- 5 director shall be an ex officio, nonvoting member of the board.)) The
- 6 board shall select a chairperson from among its members. A majority of
- 7 the members of the board shall constitute a quorum for the transaction
- 8 of business.
- 9 (3) Vacancies shall be filled in the same manner ((that the
- 10 original appointments were made)) as appointments are made under
- 11 <u>section 2 of this act</u>.
- 12 ((A majority of the members of the board shall constitute a quorum
- 13 for the transaction of business.))
- 14 (4) Members of the board shall be compensated for service on the
- 15 board in accordance with RCW 43.03.240 and shall be reimbursed for
- 16 travel expenses as provided in RCW 43.03.050 and 43.03.060.
- 17 NEW SECTION. Sec. 2. A new section is added to chapter 43.105 RCW
- 18 to read as follows:
- The members of the information services board established under RCW
- 20 43.105.032 shall include:
- 21 (1) The chief executive officer from four cabinet agencies,
- 22 appointed by the governor, one of whom shall be the director of the
- 23 department of information services;
- 24 (2) The superintendent of public instruction;
- 25 (3) The executive director of the higher education coordinating
- 26 board;
- 27 (4) The executive director of the state board for community college
- 28 education;

- 1 (5) Two members appointed by the governor to represent the private
- 2 sector;
- 3 (6) One member appointed by the chief justice of the state supreme
- 4 court to represent the judicial branch; and
- 5 (7) Two members representing the legislative branch. One
- 6 legislator shall be appointed by the president of the senate. One
- 7 legislator shall be appointed by the speaker of the house of
- 8 representatives.
- 9 <u>NEW SECTION.</u> **Sec. 3.** A new section is added to chapter 43.105 RCW
- 10 to read as follows:
- 11 (1) A video telecommunications advisory committee is created to
- 12 advise the board on video telecommunications issues. The committee
- 13 shall:
- 14 (a) Develop recommendations for the creation and utilization of
- 15 state-wide video telecommunications resources;
- 16 (b) Assist the board in its development of a strategic direction
- 17 for future state use of video telecommunications and a coordinated
- 18 program for the state-wide use of video telecommunications;
- 19 (c) Develop a plan to encourage collaborative efforts among state
- 20 agencies, institutions, and schools to make the most cost-effective use
- 21 of video telecommunications equipment and resources;
- 22 (d) Develop recommendations for the board regarding the use of
- 23 video telecommunications to conduct state business and expand
- 24 educational opportunities in ways that are consistent with the overall
- 25 strategic direction for the state-wide use of video telecommunications
- 26 resources;
- 27 (e) In the event funds are made available, develop criteria for
- 28 selection of pilot projects using video telecommunications in
- 29 education, training, and the conduct of state business.

- 1 (2) The advisory committee shall be composed of fifteen members, to
- 2 be appointed as follows:
- 3 (a) The director of the higher education coordinating board shall
- 4 appoint:
- 5 (i) A representative from the staff of the higher education
- 6 coordinating board; and
- 7 (ii) A representative from an institution of higher education with
- 8 experience in use of video telecommunications as an instructional
- 9 medium;
- 10 (b) The director of the state board for community college education
- 11 shall appoint:
- 12 (i) A representative from the staff of the state board for
- 13 community college education; and
- 14 (ii) A representative from a community college with experience in
- 15 use of video telecommunications as an instructional medium;
- 16 (c) The superintendent of public instruction shall appoint:
- 17 (i) A representative from the office of the superintendent of
- 18 public instruction;
- 19 (ii) A representative from a school district with experience in
- 20 use of video telecommunications as an instructional medium;
- 21 (iii) A representative from an educational service district with
- 22 experience in coordination of video telecommunications services; and
- 23 (iv) A representative from a public vocational-technical institute
- 24 with experience in use of video telecommunications as an instructional
- 25 medium;
- 26 (d) The director of the office of financial management shall
- 27 appoint a representative from the office of financial management;
- 28 (e) The director of the department of information services shall
- 29 appoint:

- 1 (i) Two representatives of state agencies with experience or
- 2 interest in the use of video telecommunications to facilitate state
- 3 business; and
- 4 (ii) Two private sector representatives with expertise in video
- 5 communications technology and the use of that technology to facilitate
- 6 business and expand educational opportunities;
- 7 (f) The speaker of the house of representatives and the president
- 8 of the senate shall each appoint a member of the legislature with
- 9 interest in the coordinated and collaborative development of state-wide
- 10 video telecommunications resources; and
- 11 (g) The director of the department of information services, or his
- 12 or her designee.
- 13 (3) The committee shall select a chairperson from among its
- 14 members.
