- 1 AN ACT Relating to transportation of horses by farmers; and
- 2 amending RCW 81.80.040.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 81.80.040 and 1984 c 171 s 1 are each amended to read
- 5 as follows:
- 6 The provisions of this chapter, except where specifically otherwise
- 7 provided, and except the provisions providing for licenses, shall not
- 8 apply to:
- 9 (1) Motor vehicles when operated in transportation exclusively
- 10 within the corporate limits of any city or town of less than ten
- 11 thousand population unless contiguous to a city or town of ten thousand
- 12 population or over, nor between contiguous cities or towns both or all
- 13 of which are less than ten thousand population;
- 14 (2) Motor vehicles when operated in transportation wholly within
- 15 the corporate limits of cities or towns of ten thousand or more but

- 1 less than thirty thousand population, or between such cities or towns
- 2 when contiguous, as to which the commission, after investigation and
- 3 the issuance of an order thereon, has determined that no substantial
- 4 public interest exists which requires that such transportation be
- 5 subject to regulation under this chapter;
- 6 (3) Motor vehicles when transporting exclusively the United States
- 7 mail or in the transportation of newspapers or periodicals;
- 8 (4) Motor vehicles owned and operated by the United States, the
- 9 state of Washington, or any county, city, town, or municipality
- 10 therein, or by any department of them, or either of them;
- 11 (5) Motor vehicles specially constructed for towing disabled
- 12 vehicles or wrecking and not otherwise used in transporting goods for
- 13 compensation;
- 14 (6) Motor vehicles normally owned and operated by farmers in the
- 15 transportation of their own farm, orchard, or dairy products, including
- 16 livestock and plant or animal wastes, from point of production to
- 17 market, or in the infrequent or seasonal transportation by one farmer
- 18 for another farmer, if their farms are located within twenty miles of
- 19 each other, of products of the farm, orchard, or dairy, including
- 20 livestock and plant or animal wastes, or of supplies or commodities to
- 21 be used on the farm, orchard, or dairy;
- 22 (7) Motor vehicles when transporting exclusively water in
- 23 connection with construction projects only;
- 24 (8) Motor vehicles of less than 8,000 pounds gross vehicle weight
- 25 when transporting exclusively legal documents, pleadings, process,
- 26 correspondence, depositions, briefs, medical records, photographs,
- 27 books or papers, cash or checks, when moving shipments of the documents
- 28 described at the direction of an attorney as part of providing legal
- 29 services<u>;</u>

- 1 (9) Motor vehicles used by a farmer to transport ill or injured
- 2 horses to or from the farmer's own property for rehabilitation by the
- 3 farmer when the transportation is incidental to the rehabilitation of
- 4 the horses.
