- 9 The commissioner, in consultation with the administrator of the
- 10 health care authority, shall develop a uniform health care insurance
- 11 claim form system in both paper and electronic formats to be used by
- 12 all carriers licensed under chapters 48.20, 48.44, 48.46, and 48.84
- 13 RCW. The commissioner may establish an advisory committee to assist in
- 14 implementing the uniform claim form system, which shall be in place by

- 1 January 1, 1993. The commissioner shall make the system available to
- 2 carriers after January 1, 1993, for optional use until January 1, 1994,
- 3 when the system shall be made mandatory for all carriers.

- 9 <u>NEW SECTION.</u> **Sec. 7.** After January 1, 1994, the uniform
- 10 health care insurance claim form developed by the commissioner under
- 11 section 1 of this act shall be used by all health plans whether or not
- 12 the plans are subject to the provisions of Title 48 RCW. This includes
- 13 state paid health care services provided through the basic health plan,
- 14 the health care authority, the department of social and health
- 15 services, and the department of labor and industries. The commissioner
- 16 shall aggressively pursue such federal regulatory changes as may be
