1 AN ACT Relating to technical corrections to corporations statutes;
2 and amending RCW 18.100.120 and 50.04.165.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 18.100.120 and 1982 c 35 s 169 are each amended to
5 read as follows:

6 Corporations organized pursuant to this chapter shall render
7 professional service and exercise its authorized powers under a name
8 permitted by law and the professional ethics of the profession in which
9 the corporation is so engaged. (~~In the event that the words~~
10 ~~"company", "corporation" or "incorporated" or any other word,~~
11 ~~abbreviation, affix or prefix indicating that it is a corporation shall~~
12 ~~be used, it shall be accompanied with the abbreviation "P.S." or "P.C."~~
13 ~~or the words "professional service".~~)) The corporate name of a
14 professional service corporation must contain either the words

1 "professional service" or "professional corporation" or the
2 abbreviation "P.S." or "P.C." The corporate name may also contain
3 either the words "corporation," "incorporated," "company," or
4 "limited," or the abbreviation "corp.," "inc.," "co.," or "ltd." With
5 the filing of its first annual report and any filings thereafter,
6 professional service corporation shall list its then shareholders:
7 PROVIDED, That notwithstanding the foregoing provisions of this
8 section, the corporate name of a corporation organized to render dental
9 services shall contain the full names or surnames of all shareholders
10 and no other word than "chartered" or the words "professional services"
11 or the abbreviation "P.S." or "P.C."

12 **Sec. 2.** RCW 50.04.165 and 1991 c 72 s 57 are each amended to read
13 as follows:

14 ~~((1))~~ Services performed by ~~((corporate officers as defined in~~
15 ~~subsection (2) of this section))~~ a person appointed as an officer of a
16 corporation under RCW 23B.08.400, other than those covered by chapter
17 50.44 RCW, shall not be considered services in employment. However, a
18 corporation may elect to cover not less than all of its corporate
19 officers under RCW 50.24.160. If an employer does not elect to cover
20 its corporate officers under RCW 50.24.160, the employer must notify
21 its corporate officers in writing that they are ineligible for
22 unemployment benefits. If the employer fails to notify any corporate
23 officer, then that person shall not be considered to be a corporate
24 officer for the purposes of this section.

26 ~~one or more vice presidents as may be prescribed by the bylaws, a~~
