- AN ACT Relating to warrant officers; amending RCW 35.20.270;
- 2 providing an effective date; and declaring an emergency.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:
- 4 Sec. 1. RCW 35.20.270 and 1977 ex.s. c 108 s 1 are each amended to
- 5 read as follows:
- 6 (1) The position of warrant ((server)) officer is hereby created
- 7 ((within the courts created by chapter 35.20 RCW)) and maintained by
- 8 the city within the city police department. The number and
- 9 qualifications of ((said)) warrant ((servers)) officers shall be fixed
- 10 by ordinance, and their compensation shall be paid by the city.
- 11 (2) ((Said)) Warrant ((servers)) officers shall be vested only with
- 12 the special authority to make arrests authorized by ((the)) warrants
- 13 ((which they have been directed to serve by courts created by chapter

- 1 35.20 RCW)) and for such crimes as are determined appropriate by the
- 2 <u>city legislative authority</u>.
- 3 (3) All criminal and civil process issuing out of courts created
- 4 under this title shall be directed to the chief of police of the city
- 5 served by the court and/or to the sheriff of the county in which the
- 6 court is held and/or the warrant ((servers of the court)) officers and
- 7 be by them executed according to law in any county of this state.
- 8 (4) No process of courts created under this title shall be executed
- 9 outside the corporate limits of the city served by the court unless the
- 10 person authorized by ((said)) the process shall first contact the
- 11 applicable law enforcement agency in whose jurisdiction the process is
- 12 to be served.
- 13 (5) Upon a defendant being arrested in another city or county the
- 14 cost of arresting or serving process thereon shall be borne by the
- 15 court issuing ((said)) the process including the cost of returning the
- 16 defendant from any county of the state to the city.
- 17 (6) ((Said)) Warrant ((servers)) officers shall not be entitled to
- 18 death, disability, or retirement benefits pursuant to chapter 41.26 RCW
- 19 on the basis of service as a warrant ((server)) officer as described in
- 20 this section.
- 21 <u>NEW SECTION.</u> **Sec. 2.** This act is necessary for the immediate
- 22 preservation of the public peace, health, or safety, or support of the
- 23 state government and its existing public institutions, and shall take
- 24 effect June 1, 1992.
