1 AN ACT Relating to public disclosure reporting for members of
2 certain higher education boards; and amending RCW 42.17.2401.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF WASHINGTON:

4 **Sec. 1.** RCW 42.17.2401 and 1991 c 200 s 404 are each amended to
5 read as follows:

6 For the purposes of RCW 42.17.240, the term "executive state
7 officer" includes:

8 (1) The chief administrative law judge, the director of
9 agriculture, the administrator of the office of marine safety, the
10 administrator of the Washington basic health plan, the director of the
11 department of services for the blind, the director of the state system
12 of community and technical colleges, the director of community
13 development, the secretary of corrections, the director of ecology, the
14 commissioner of employment security, the chairman of the energy

1 facility site evaluation council, the director of the energy office,
2 the secretary of the state finance committee, the director of financial
3 management, the director of fisheries, the executive secretary of the
4 forest practices appeals board, the director of the gambling
5 commission, the director of general administration, the secretary of
6 health, the administrator of the Washington state health care
7 authority, the executive secretary of the health care facilities
8 authority, the executive secretary of the higher education facilities
9 authority, the director of the higher education personnel board, the
10 executive secretary of the horse racing commission, the executive
11 secretary of the human rights commission, the executive secretary of
12 the indeterminate sentence review board, the director of the department
13 of information services, the director of the interagency committee for
14 outdoor recreation, the executive director of the state investment
15 board, the director of labor and industries, the director of licensing,
16 the director of the lottery commission, the director of the office of
17 minority and women's business enterprises, the director of parks and
18 recreation, the director of personnel, the executive director of the
19 public disclosure commission, the director of retirement systems, the
20 director of revenue, the secretary of social and health services, the
21 chief of the Washington state patrol, the executive secretary of the
22 board of tax appeals, the director of trade and economic development,
23 the secretary of transportation, the secretary of the utilities and
24 transportation commission, the director of veterans affairs, the
25 director of wildlife, the president of each of the regional and state
26 universities and the president of The Evergreen State College, each
27 district and each campus president of each state community college;

28 (2) Each professional staff member of the office of the governor;

29 (3) Each professional staff member of the legislature; and

1 (4) Central Washington University board of trustees, board of
2 trustees of each community college, each member of the state board for
3 community and technical colleges ((education)), state convention and
4 trade center board of directors, committee for deferred compensation,
5 Eastern Washington University board of trustees, Washington economic
6 development finance authority, The Evergreen State College board of
7 trustees, forest practices appeals board, forest practices board,
8 gambling commission, Washington health care facilities authority,
9 higher education coordinating board, higher education facilities
10 authority, higher education personnel board, horse racing commission,
11 state housing finance commission, human rights commission,
12 indeterminate sentence review board, board of industrial insurance
13 appeals, information services board, interagency committee for outdoor
14 recreation, state investment board, joint center for higher education
15 governing board, liquor control board, lottery commission, marine
16 oversight board, oil and gas conservation committee, Pacific Northwest
17 electric power and conservation planning council, parks and recreation
18 commission, personnel appeals board, personnel board, board of pilotage
19 ((~~commissioners~~)) commissioners, pollution control hearings board,
